LUC-Monroe & Silica Intersection Improvements (PID 107489)

Dear Mr. Mayor and Council Members:

At the January 7, 2019 meeting City Council authorized the Service Department to request Letters of Interest (LOI's) from consultants to provide engineering services for improvements to the intersection of Monroe Street and Silica Drive.

During the solicitation we received LOI's from three engineering consultants. The Service Department reviewed, scored, and ranked all LOI's and selected Tetra Tech as the most highly qualified firm and project team. Subsequently the Service Department entered into scope of services and fee negotiations.

We have completed those negotiations and Tetra Tech has prepared a proposal in the amount of \$335,973 to complete the scope of services. The proposal includes \$323,629 in authorized tasks as well as an additional \$12,344 in "if-authorized" tasks. The "if-authorized" task includes traffic signal design should this option be the preferred alternative over the roundabout option at the conclusion of the public involvement process.

This is a Local Public Agency (LPA) project with the Ohio Department of Transportation (ODOT). As such the Service Department has coordinated the scope of services and fee proposal with ODOT District 2 and both entities are ready to move forward with the project. This is an appropriated item in the 2019 capital improvement budget. We would recommend approval of the proposal in the amount of \$335,973 with Tetra Tech.

Thank you for selecting our team for the LUC-Monroe Street/Silica Drive project! Our team is looking forward to working with you and Mr. Joe Shaw, P.E., P.S. on this exciting and important project for the City of Sylvania. Our team is comprised of the following subconsultants and their associated roles on the project:

- ➤ DGL Engineers surveying, R/W plans, traffic analysis, traffic control, and signal design (If Authorized)
- Lawhon and Associates environmental studies
- ➤ NE Roundabouts roundabout peer reviews and VISSIM simulations
- > TTL geotechnical investigations, engineering and recommendations

Additionally, on our team and whose services have been deferred until a preferred alternative is selected for detailed design are: West Erie Realty for R/W acquisition, and the EDGE Group for landscape architecture. Separate proposals for these services will be submitted to the City for consideration at the appropriate time in the project timeline.

Below is a breakdown of project understanding, project scope, project schedule, assumptions and compensation. Attached you will find a master cost spreadsheet printout that includes hourly breakdowns for each task, along with subconsultant costs for each task. Also attached are the individual sub consultant proposals with their cost spreadsheet printouts for reference.

PROJECT UNDERSTANDING

The City of Sylvania has selected the Tetra Tech Team to provide engineering services for the improvement of the Monroe Street and Silica Drive Intersection as well as approach work and the widening of Monroe Street from this intersection east to Main Street (adding an additional eastbound lane to the current three lane configuration). Our team will provide design services based on the engineering recommendations from the completed traffic study to increase capacity and Level of Service (LOS) at the intersection of Monroe Street and Silica Drive. We had a scoping meeting with the City on February 25, 2019 to kick off the proposal development and to clarify proposed work, tasks, schedules and assumptions for the price proposal. ODOT's standard Project Development Process (PDP) tasks will be used for this proposal. The following scope is based on our understanding:



PROJECT SCOPE

Our team will work with the City to develop the preliminary engineering and public involvement efforts to select the preferred intersection alternative (i.e. roundabout or traffic signal widening) and following selection, move forward with the detailed engineering design. This project involves the Preliminary Engineering (PE), Environmental Engineering (EE), and Final Engineering (FE) phases of the PDP phased approach and is anticipated to follow a Path 3, Complex Project.

The PE will include the development of Stage 1 plans, Stage 2 plans, Preliminary and Final R/W Plans and the environmental clearance document. The FE will include development of Stage 3 plans and Final Plans, Specifications and Estimates, and CO (Construction Phase) will include providing the City on-going support services during construction. This letter and the attached forms will serve as our scope and budget for this initial authorization. Project limits are defined as shown in the attached conceptual geometrics from the traffic study performed by Tetra Tech. These limits are roughly defined as: 900' west of the intersection to 1400' east of the intersection, and 600' south to 300' north of the intersection.

PROJECT SCHEDULE

Below is an overall project schedule that was developed based on input from the City and ODOT. Following the public meeting and selection of the preferred improvement, an updated and detailed design schedule will be submitted to the City of Sylvania and ODOT for concurrence.

We assume that all required permit fees will be paid directly by the City of Sylvania and are not included in this proposal. The assumed project limits are based on the conceptual plans developed in the completed Monroe Street and Silica Drive Intersection Traffic Study by Tt.

COMPENSATION

Compensation for our personnel directly engaged in the work of this proposal will be based on cost plus fixed fee. We have estimated a budget of \$323,629 for the Base Scope items, and an additional \$12,344 in "If Authorized" items. The "If Authorized" items will only be performed upon written authorization from the City of Sylvania. If Tt anticipates that additional effort is required beyond the Base Scope and/or the "If Authorized" scope during the project, Tt will submit a written request to the City for authorization prior to performing any additional work. ORDINANCE NO. 38 -2019

ACCEPTING THE PROPOSAL OF TETRA TECH TO PROVIDE PROFESSIONAL ENGINEERING SERVICES FOR IMPROVEMENTS TO THE INTERSECTION OF MONROE STREET AND SILICA DRIVE; APPROPRIATING FUNDS THEREFORE IN THE AMOUNT OF \$335,973; AND DECLARING AN EMERGENCY.

WHEREAS, at the January 7, 2019 meeting of Sylvania City Council, the Director of Public Service was authorized to request Letters of Interest from consultants to provide engineering services for improvements to the intersection of Monroe Street and Silica Drive; and,

WHEREAS, as a result of the request for Letters of Interest, the Department of Public Service reviewed, scored and ranked the three responding engineering firms and thereafter selected Tetra Tech as the most highly qualified firm; and,

WHEREAS, the proposal includes engineering services for the improvement of the Monroe Street and Silica Drive Intersection as well as approach work and the widening of Monroe Street from this intersection east to Main Street and will also provide design services based on the engineering recommendations from the completed traffic study to increase capacity and Level of Service at the Monroe Street and Silica Drive intersection; and,

WHEREAS, the Director of Public Service, in a report dated May 6, 2019, has recommended that the proposal of Tetra Tech to provide professional engineering services for the LUC-Monroe & Silica Intersection Improvements at a cost of Three Hundred Thirty-Five Thousand Nine Hundred Seventy-Three Dollars (\$335,973.00), be accepted.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, _____ members elected thereto concurring:

SECTION 1. That the proposal of Tetra Tech in the amount of Three Hundred Thirty-Five Thousand Nine Hundred Seventy-Three Dollars (\$335,973.00) for professional engineering services for the LUC-Monroe Street and Silica Intersection Improvements, is hereby accepted.

SECTION 2. That the Director of Public Service shall promptly give notice to said consultant to proceed under the proposal hereby approved and accepted.

<u>SECTION 3.</u> That to provide funds for said engineering services hereby authorized, there is hereby appropriated from the **CAPITAL IMPROVEMENT FUND** from funds therein not heretofore appropriated to **Account No. 401-7610-53503**, **Street Improvements**, the amount of Three Hundred Thirty-Five Thousand Nine Hundred Seventy-Three Dollars (\$335,973.00).

SECTION 4. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City.

SECTION 6. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that the City should provide for engineering of the intersection improvements at the earliest possible time. WHEREAS, Ordinance No. 47-2018, passed September 5, 2018, authorized the Mayor and Director of Finance to enter into an Intergovernmental Cooperative Agreement to determine the feasibility of constructing a water management facility and included the Henry County Regional Water and Sewer District, the Northwestern Water and Sewer District, the Villages of Liberty Center and Whitehouse, and the Cities of Maumee, Perrysburg and Sylvania for the production and distribution of potable water using the aquifer known as the Michindoh Aquifer and/or the sharing of services; and,

WHEREAS, the Director of Public Service, by report dated February 15, 2019, recommended that the City participate in Phase 2 of the study which will include drilling three additional observation wells across a broader area surrounding the proposed well site and conducting another pump test using the existing well; and,

WHEREAS, Ordinance No. 17-2019, passed February 19, 2019, accepted the proposal of Artesian of Pioneer to conduct further testing of the Michindoh Aquifer as an alternative water source for the City of Sylvania and appropriated funds in the amount of \$12,500; and,

WHEREAS, subsequent to the passage of the ordinance, it was determined that the appropriation amount should be increased to \$22,500 and that the payment should be made to Henry County Water District rather than Artesian of Pioneer; and,

WHEREAS, the Directors of Finance, Law and Public Service recommend that the appropriation amount and party should be changed to \$22,500 with the Henry County Water District.

ORDINANCE NO. 41 -2019

PROVIDING FOR THE CONTROLLING BLIGHT AND DISEASE OF SHADE TREES AND FOR PLANTING, MAINTAINING, TRIMMING AND REMOVING SHADE TREES IN AND ALONG THE STREETS AND WITHIN PUBLIC RIGHT-OF-WAY OF THE CITY OF SYLVANIA; AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE, BY AND THROUGH THE PROPER OFFICERS OF SAID CITY TO DO SAID WORK DURING THE YEAR 2019; ESTABLISHING ONE DISTRICT FOR SAID PURPOSE IN ACCORDANCE WITH THE PROVISIONS OF SECTION 727.011 OF THE REVISED CODE OF OHIO; PROVIDING FOR THE ASSESSMENT OF THE COST AND EXPENSE THEREOF UPON ABUTTING PROPERTY; AND DECLARING AN EMERGENCY.

WHEREAS, it is immediately urgent and necessary that work is authorized for the purpose of controlling blight and disease of shade trees and for planting, maintaining, trimming and removing shade trees in and along the streets and within public right-of-way of the City of Sylvania during the year 2019;

WHEREAS, the City Forester, through the Director of Public Service has recommended to Council the removal or special treatment of shade trees and for planting, maintaining, trimming and removing shade trees in and along the streets and within public right-of-way of the City of Sylvania during the year 2019 in accordance with plans, estimates and schedules therefore heretofore prepared and now on file in the Office of the Clerk of Council.

NOW, THEREFORE BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, _____ members elected thereto concurring:

SECTION 1. That it is hereby declared necessary and conducive to public health, convenience and welfare to remove and provide special treatment for shade trees for the purpose of controlling blight and disease of same, and for planting, maintaining, trimming and removing shade trees in and along the streets and within public right-of-way of the City of Sylvania during the year 2019. That for said purpose there is hereby established one (1) district which shall include all territory within and coextensive with the boundaries of the City of Sylvania, pursuant to the provisions of Section 727.011 of the Revised Code of Ohio.

SECTION 2. That the work of such removal or special treatment of shade trees for the purpose of controlling blight and disease of same and for planting, maintaining, trimming and removing shade trees in and along the streets and within public right-of-way of the City of Sylvania shall be done within said district, as herein set forth, and through the proper officers of the City of Sylvania; and such officers be, and they hereby are, authorized and directed to purchase required materials; to purchase or rent the necessary tools, machinery and appliances; to employ the necessary labor to do said work all in accordance with the plans, estimates and schedules therefore heretofore prepared and now on file in the Office of the Clerk of Council for inspection of all persons interested, which said plans, estimates and schedules, including approximate present estimates of the cost of said work, is in the aggregate sum of Two Hundred Forty-Six Thousand, Two Hundred Fifty-Three Dollars and 18/100 (\$246,253.18).

SECTION 3. That said cost and expense of removal or special treatment of shade trees for the purpose of controlling blight and disease of same and for planting, maintaining, trimming and removing shade trees in and along the streets and within public right-of-way of the City of Sylvania in the amount of Two Hundred Forty-Six Thousand, Two Hundred Fifty-Three Dollars and 18/100 (\$246,253.18) shall be specially assessed by the front foot upon all of the lots and lands abutting and bounding upon each of said streets and public right-of-way in said district in the amount of thirty-five cents (35ϕ) per front foot as provided in Section 727.011 of the Ohio Revised Code, which said lots and lands are hereby determined to be specially benefitted by said work in the amount equal to the amount specially assessed against each such lot and land. The cost of said work shall include acquisition of the necessary materials, tools, machinery and appliances, the wages for the necessary labor, the cost of said plans, estimates and schedules, cost of publication and mailing of notices, and cost of this Ordinance, costs of the preparation, levy and collection of special assessments and interest on notes issued in anticipation of the levy and collection of the special assessments together with all other necessary expenditures.

<u>SECTION 4.</u> That the special assessment so to be levied on said lots and lands shall be paid in one (1) installment in the manner provided in the case of special assessments pursuant to Section 727.01 of the Ohio Revised Code.

SECTION 5. That to provide a fund out of which shall be paid the assessed cost and expense of said work, bonds or notes or certificate of indebtedness of the City of Sylvania are hereby authorized to be issued and sold in anticipation of the levy and collection of said assessments.

SECTION 6. That the Director of Finance has prepared and filed in the Office of the Clerk of Council a list of the special assessments, pursuant to this Ordinance, and this Council finds and determines that such special assessments are in proportion to the special benefit derived by each property against which such assessments are to be levied and are not in excess of any statutory limitation.

SECTION 7. That, pursuant to Ohio Revised Code Section 727.14, the Clerk of Council is hereby directed to give notice of the passage of this Ordinance by publication of such notice once a week for two (2) consecutive weeks, and as to an owner of any lot or parcel of land the assessment upon which is estimated to exceed Two Hundred Fifty Dollars (\$250.00), the Clerk of Council is hereby directed to serve such notice in the same manner as service of summons in civil cases, or by certified mail addressed to such owner at his last known address or to the address to which tax bills are sent, or by a combination of the foregoing methods. Objections to estimated assessments must be filed, in writing with the Clerk of Council within two (2) weeks after completion of the notice hereby required. An owner who fails to file an objection shall be

deemed to have waived any objection. Any and all properly filed objections to estimated assessments shall be considered by Council at its first regular Council meeting held more than two (2) weeks after the completion of the notice hereby required and the estimated assessments so objected to shall at such meeting, be adjusted by Council by motion or other action reflected in the journal of the minutes of Council. Council, after adjusting such estimated assessments or, after the time for filing objections without any properly filed objections having been timely filed, may, by Ordinance, levy such estimated assessments and adjusted estimated assessments, as the case may be. No notice shall be required other than as herein required.

SECTION 8. That the method, manner, consideration and procedure for such shade tree work is hereby approved and this Council hereby determines the method, manner and procedure for levying assessments for such shade tree work to be as set forth in this Ordinance.

SECTION 9. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 10. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City.

SECTION 11. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that provision should be made immediately to provide for tree maintenance and therefore this Ordinance should be effective forthwith. DECLARING THE NECESSITY OF LIGHTING THE STREETS IN THE CITY OF SYLVANIA, OHIO; DETERMINING THE MANNER OF PROVIDING STREET LIGHTING AND THE BASIS FOR THE PROPERTY OWNER'S SHARE OF THE COST AND ANNUAL ASSESSMENT; AND DECLARING AN EMERGENCY.

BE IT RESOLVED by the Council of the City of Sylvania, Lucas County, Ohio, ______
members elected thereto concurring:

- <u>SECTION 1.</u> That is hereby determined to be necessary to continue to improve the streets in the City of Sylvania, Ohio, by lighting the same pursuant to a contract therefore which this City now has with the Toledo Edison Company and necessary to provide funds in 2019 for such street lighting.
- SECTION 2. That for the tax year 2019 the basis for determining and allocating annual assessments on lots and lands in said City for street lighting in the City of Sylvania, Ohio, shall be as follows, which basis is hereby determined to be according to the benefits which may result from the improvements to the several parcels and lots of land in said City:
 - A. Each taxable parcel, outside of the Whiteway Business District, having no building or buildings thereon, not served by lamps on steel poles with overhead circuits or by lamps on poles with underground circuits, shall be assessed a base charge of \$8.00 and, in addition thereto, a further charge of 90¢ for each \$1,000.00 tax valuation or part thereof;
 - B. Each taxable parcel, outside of the Whiteway Business District, having any building or buildings thereon, not served by lamps on steel poles with overhead circuits or by lamps on poles with underground circuits, shall be assessed a base charge of \$12.00 and, in addition thereto, a further charge of 90¢ for each \$1,000.00 tax valuation or part thereof;
 - C. Each taxable parcel, outside of the Whiteway Business District, having no building or buildings thereon, served by lamps on steel poles with overhead circuits, shall be assessed a base charge of \$11.00 and, in addition thereto, a further charge of 90¢ for each \$1,000.00 tax valuation or part thereof;
 - D. Each taxable parcel, outside of the Whiteway Business District, having any building or buildings thereon, served by lamps on steel poles with overhead circuits, shall be assessed a base charge of \$14.00 and, in addition thereto, a further charge of 90¢ for each \$1,000.00 tax valuation or part thereof;
 - E. Each taxable parcel, within the Whiteway Business District, fronting on Main Street, Maplewood Avenue, or Monroe Street, being served by lamps on either steel or

wood poles with overhead or underground circuits, shall be assessed at a rate of \$1.10 per front foot of the parcel;

- F. Each taxable parcel, outside of the Whiteway Business District, having no building or buildings thereon, served by lamps on poles with underground circuits, shall be assessed a base charge of \$20.00 and, in addition thereto, a further charge of 90¢ for each \$1,000.00 tax valuation or part thereof;
- G. Each taxable parcel, outside of the Whiteway Business District, having any building or buildings thereon, served by lamps on poles with underground circuits, shall be assessed a base charge of \$27.00 and, in addition thereto, a further charge of 90¢ for each \$1,000.00 tax valuation or part thereof;
- H. In cases under A, B, C, D, F and G above, the maximum amount of assessment for any parcel based on the charge of 90¢ for each \$1,000.00 tax valuation or part thereof shall not exceed the equivalent of \$2.00 per front foot of said parcel fronting on a cul-de-sac or \$1.00 per front foot on all other said parcels;
- SECTION 3. That the contract with the Toledo Edison company and the costs to this City required thereby, now on file with the Clerk of Council, are hereby deemed to be the plans and specifications and estimate of cost required to be on file with the Clerk of Council before the passage of the Resolution of necessity.
- SECTION 4. That the Clerk of Council has prepared and filed in the Office of the Clerk of Council a list of the estimated special assessments for the cost and expense of street lighting in the City of Sylvania, which list shows the amounts of the estimated assessment against each taxable parcel in the City of Sylvania, pursuant to Section 2 of this Resolution, and the amount of such assessments in the aggregate, and this Council finds and determines that such estimated assessments are in proportion to the special benefit derived by each property against which such assessments are to be levied and are not in excess of any statutory limitation.
- SECTION 5. That, pursuant to Ohio Revised Code Section 727.14, the Clerk of Council is hereby directed to give notice of the passage of this Resolution by publication of such notice once a week for two (2) consecutive weeks, and as to an owner of any lot or parcel of land the assessment upon which is estimated to exceed Two Hundred Fifty Dollars (\$250.00), the clerk of Council is hereby directed to serve such notice in the same manner as service of summons in civil cases, or by certified mail addressed to such owner at his last known address or to the address to which tax bills are sent, or by a combination of the foregoing methods. Objections to estimated assessments must be filed, in writing, with the Clerk of Council, within two (2) weeks after completion of the notice hereby required. An owner who fails to file an objection shall be deemed to have waived any objection. Any and all properly filed objections to estimated assessments shall be considered by Council at its first regular meeting held more than two (2) weeks after the completion of the notice hereby required and the estimated assessments so objected to shall, at such meeting, be adjusted by Council by motion or other action, reflected in the journal of the minutes of Council. Council, after adjusting such estimated assessments or after the time for filing objections without any properly filed objections having been timely filed, may, by Ordinance, levy such estimated assessments and adjusted estimated assessments, as the case may be. No notice shall be required other than as herein required.

SECTION 6. That the Clerk of Council is hereby directed to give notice to the Auditor of Lucas County, Ohio, on the levying of such assessments and to do so within twenty (20) days after the levying of same and prior to October 1, 2019.

SECTION 7. That the method, manner and procedure for providing street lighting by contract with the Toledo Edison Company is hereby approved and this Council hereby determines the method, manner and procedure for levying assessments for such street lighting to be as set forth in this Resolution.

SECTION 8. That this Resolution shall be published by posting a copy thereof in a conspicuous place in the Sylvania Municipal Building for a period of not less than fifteen (15) days as provided in ARTICLE III, Section 12.0 of the Charter of said City.

SECTION 9. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

125.02 DIVISION OF POLICE.

The Chief of the Division of Police, to be called the Chief of Police, shall, under the Director of Public Safety, have exclusive control of the stationing and transfer of all patrolmen and other officers and employees constituting the police force, under such rules and regulations as the Director may promulgate from time to time. The Chief of Police shall have a police secretary whose duties he shall assign within the Division. The police force shall be composed of a Chief of the Division of Police; two captains, who shall be directed by and answerable to the Chief; six sergeants, who shall be answerable to and assigned by the Chief; twenty-six patrolmen, who shall be answerable to and assigned duties by the Chief of Police; a chief telecommunicator and five regular full-time telecommunicators in the Communications Section, all of whom shall be answerable to and assigned duties by the Chief of Police; and such additional personnel, both full-time and part-time as Council shall hereafter authorize. The Chief of Police may set up, combine and/or abolish and assign or reassign any member of the police force to, or withdraw therefrom, any of the following sections: Office of Community Affairs; Detective Bureau; Court Officer; Property and Evidence Room; Road Patrol. In the event of an emergency, the Mayor may appoint additional patrolmen and other officers for temporary service during the emergency.

Permissive License Tax

Dear Mr. Mayor and Council Members:

House Bill 62 recently passed by our state legislature created the ability for municipalities to levy an annual Five Dollar license tax on vehicles registered within its municipal limits. This authority is granted via Ohio Revised Code 4504.173.

We have estimated that the City would receive approximately \$87,140 should Council authorize this fee. The funds can only be used for the planning, constructing, improving, maintaining, and repairing of public roads, highways, streets, bridges and viaducts.

We request that Council authorize legislation to be prepared and move forward with levying an additional Five Dollar license tax. Please note that this legislation can not be enacted as an emergency measure.










Man-Hours by Work Type

PROJECTS

Patch Management

With the continued increase of cyber-attacks, it is absolutely necessary that we maintain a patch management strategy. We continue to patch our servers, workstations, websites and infrastructure devices regularly to help protect us from known vulnerabilities. Servers and workstations are patched monthly with the exception of our servers which reside in the DMZ, which are patched weekly as they are more prone to attack. We continue to work with our vendors to make sure that any security vulnerabilities are resolved in a timely manner.

o Telecommunications

We have successfully completed implementation and training of the new Mitel telephone system. A new City general telephone number 419-885-TREE (8733) was implemented as well. A great deal of time was spent reconfiguring the call flow in order to gently guide our residents to the proper destination. We have received a great deal of positive feedback regarding this change. We also completed implementation of similar call routing with the Police Division and the results have been positive as well. We have installed several mobile apps on cell phones of our users that provide them with the ability to receive and make office calls from their cellphones without compromising their cell phone telephone number. Any calls made using the app will display the office number of the individual instead of the cell phone number they are calling from. It also allows for internal calls to be received or transferred by merely transferring the call to recipient's extension number. The app is a true extension on our system. This allows for employees to utilize their personal cell phone instead of a city phone, no longer requiring them to carry two phones and further reducing costs.

EMC Avamar Upgrade

We have completed migration to the new Avamar backup grid, moving our current backups to the new equipment. We continue to work with Dell EMC in order to relocate one of the Dell Data Domains to our DR site. We expect this to be completed in the coming weeks. Due to some challenges, including firmware issues, the deployment was delayed.

Court server upgrades

Court server upgrades are still in progress. We are currently working with Henschen & Associates to complete the installation. This is taking a bit longer

than anticipated however, should be completed by the end of the second quarter of 2019.

Switch refresh & RPS installation

We continue to update the few remaining 10/100 switches to gigabit (10/100/1000) and connect those in the PD, which are considered mission critical, to a Cisco RPS. (Redundant Power System)

Wireless implementation

We have successfully completed a refresh of our wireless infrastructure at City Hall as well as the Sylvania Municipal Court using Ubiquiti Wi-Fi Access Points. We are scheduled to complete this in the second quarter of 2019. We will be outsourcing some of the wiring in order to speed up this implementation as wiring is a very time consuming process.

Server migration

We continue to upgrade our existing Windows Server 2008 R2 environment to Windows Server 2012 R2. Windows 2008 R2 will be end of life beginning in January of 2020. We currently have 22 Servers that are on Windows 2008 R2.

o Camera migration and implementation. (Main Campus)

We continue to refresh our existing security cameras with Avigilon cameras. These cameras will replace older CCTV style cameras that are already in place. We also are going to be adding additional cameras at the Sylvania Municipal Court. We will be outsourcing some of the wiring in order to speed up this implementation.

GOALS

PC Refresh

We will be replacing all existing PC's this year, (95) in all. We will be purchasing Lenovo PC's on state contract. These PC's are extremely stable and reliable. They will be running Windows 10 and Microsoft Office 2019 as both our current applications, Windows 7 and Office 2010, are no longer going to be supported beginning January of 2020. Unfortunately, there is currently an Intel microchip shortage, therefore the PC's are not currently available. We will also be purchasing additional Windows 10 upgrade licensing for the MDT's in the patrol vehicles of the police division.

o Exchange Server (Email Server) upgrade.

Our current version of exchange is also in need of replacement due to the end of support date in January 2020. We will be purchasing licensing, under state contract, in the second quarter of 2019 with the implementation to follow.

SIRE Upgrade

Our current version of SIRE, which we currently use for document management, including providing police accident reports online, will no longer be supported come January 2020. We are going to migrate to another solution later this year. We are in the process of reviewing other solutions and costs.

Digital Sign Replacement (Main/Monroe)

The digital sign located at Main/Monroe continues to experience hardware and software failures. The current radio is malfunctioning, and the software is no longer supported by the company. This is due to several Windows security updates that are no longer compatible with the WatchFire software. We have made the decision to upgrade the existing sign in the coming weels. The new sign will have new technology that provides a much higher resolution than the existing sign. We felt this was important due to the pending DORA proposal and the SOMO project which will increase pedestrian traffic. The higher resolution sign will provide an easier to read sign for those walking near it. The new technology will also use cell phone technology for connectivity vs. the obsolete radio technology we currently use. This will be an upgrade and the existing physical sign will remain the same. The components such as the panels and controller are all that will be changed.

o Installation of cell phone signal booster in Maintenance Garage.

We will be installing and testing a cell phone booster at the Maintenance Garage on Harroun Rd. This will allow for the users at that location to receive phone calls in the building, using the Mitel App, which is severely restricted due to the current signal strength. Poor signal strength results in missed and dropped phone calls.

Training

We will continue to pursue relevant training and certifications.

Cost Reduction through consolidation

We continue to decommission switches and other network related equipment in order to reduce costs and simplify administration.

Police Dispatch Console

The wiring project has been temporarily placed on hold pending further discussion of telecommunications consolidation.

The project is proposed to include the replacement of the driving surface and bridge deck, as well as improvements to the outside walls (parapets), outside fencing (vandal fence), light fixtures, and sidewalks. Through coordination with the City of Sylvania, local schools, and emergency services, in order to expedite construction, the bridge is proposed to be closed for 120 days with vehicular and pedestrian detours posted. Construction is expected to begin in the summer of 2021.
