Re: 2020 ODOT Highway Safety Improvement Program Application

Dear Mr. Mayor and Council Members:

The Service Department has one project to submit for funding consideration in the April 2020 solicitation round of projects eligible in the Ohio Department of Transportation's Highway Safety Improvement Program (HSIP).

The City's No. 1 project is US-23 & Monroe Street Interchange Improvements Project. The Service Department started interchange improvement discussions with the ODOT in 2015 and on November 6, 2017 City Council authorized a Feasibility Study to be conducted to review alternatives (ORD 78-2017). The study was completed in May 2019 and recommended Alternative B, including Glasgow Option 1 and eastbound Monroe Street widening as the preferred alternatives to best alleviate congestion and improve safety within this corridor. The total cost of the project is estimated to be \$28,051,064 and we are requesting up to \$9,790,783 in HSIP funding assistance.

The Service Department began pursuing grant funds last August and to date has secured over \$17 million towards the project. Enclosed is a funding matrix of the various eligible programs, the anticipated request amounts, and awarded amounts to date. The City will be keeping City Council up to date on our progress and will request additional authorizations as needed for these programs when the funding solicitation windows become available. If successful with all applications construction would begin in 2025.

We recommend moving forward with this grant application. Please call if you have any questions.

RESOLUTION NO. 6 -2020

A RESOLUTION AUTHORIZING THE MAYOR AND DIRECTOR OF FINANCE TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO DEPARTMENT OF TRANSPORTATION HIGHWAY SAFETY IMPROVEMENT PROGRAM AND TO EXECUTE CONTRACTS AS REQUIRED; AND DECLARING AN EMERGENCY.

WHEREAS, the Ohio Department of Transportation Highway Safety Improvement Program provides financial assistance to political subdivisions for capital improvements to public infrastructure; and,

WHEREAS, pending successful grant applications, the City of Sylvania and ODOT are planning to improve the US-23 and Monroe Street Interchange in 2025; and,

WHEREAS, the Director of Public Service, in a report dated February 18, 2020, indicated that the total estimated cost of the project is \$28,051,064 and the City is requesting up to \$9,790,783 in Highway Safety Improvement Program funding, with the City previously being awarded over \$17,000,000 in grant funding toward the project.

NOW, THEREFORE BE IT RESOLVED by the Council of the City of Sylvania, Lucas County, Ohio, ____ members elected thereto concurring:

- SECTION 1. That the Mayor and Director of Finance be, and they hereby are, authorized to apply to the Ohio Department of Transportation Highway Safety Improvement Program for funds as described above.
- <u>SECTION 2.</u> The Mayor and Director of Finance are further authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance.
- SECTION 3. If the US-23 and Monroe Street Interchange Project are approved for financial assistance, the City of Sylvania will commit the necessary funds to meet the local share as indicated in the corresponding project application and will enter into an agreement with the Ohio Department of Transportation for the grant.
- SECTION 4. It is hereby found and determined that for all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- SECTION 5. That the Clerk of Council is hereby directed to post a copy of this Resolution in the office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12 of the Charter of this City.

SECTION 6. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that the City should file its application for the grant immediately and indicate its willingness to enter into an Agreement and appropriate the funds for said project as necessary and therefore this Resolution should be made effective immediately. Re: Engineering Services Contract Modification – Cushman Road Improvements

Dear Mr. Mayor and Council Members:

On November 18, 2019 City Council accepted the proposal from ESA, LLC to provide engineering services for improvements on Cushman Road and Randall Drive (Ord. 96-2019).

One of the project goals was to re-establish a new drainage swale centerline on the east side of the road and provide side slopes that are much easier to maintain than the existing conditions. During engineering design, it was determined there was insufficient right-of-way to accomplish this goal. As a result, the Service Department requested an engineering proposal from ESA to provide legal descriptions and drawings that will be used to acquire temporary construction easements from the required property owners. ESA has provided an estimated fee of \$11,900 to accomplish this task.

In addition, the Service Department asked for an engineering design change to shift the new waterline from the east side of the road to the west side of the road to provide more room for the required drainage improvements. The drainage swales needed to be redesigned to accommodate the larger footprint. As a result of the design changes, ESA has requested an additional \$9,800 to complete the construction plans.

The original engineering design fee was \$12,500 which would bring the total cost of engineering design work to be \$34,200. We believe the fees are reasonable and would recommend approval of the engineering service contract modification with ESA in the amount of \$21,700. Please call with any questions.

AUTHORIZING THE MAYOR AND DIRECTOR OF FINANCE TO APPROVE THE AMENDMENT TO THE CITY'S AGREEMENT WITH ESA, LLC FOR THE ENGINEERING SERVICES RELATIVE TO THE CUSHMAN ROAD IMPROVEMENTS; INCREASING THE PROPOSAL AMOUNT BY \$21,700; APPROPRIATING FUNDS THEREFORE; AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance No. 96-2019, passed November 18, 2019, accepted the proposal of ESA, LLC to provide engineering services for the Cushman Road Improvement Project at a cost of \$12,500; and,

WHEREAS, part of the improvement project includes establishing a new drainage swale centerline on the east side of the road and provide side slopes that are easier to maintain; and,

WHEREAS, during engineering design, it was discovered that there is insufficient right-of-way to establish a new drainage swale and, therefore, additional right-of-way will need to be acquired; and,

WHEREAS, ESA, LLC has proposed to provide legal descriptions and drawings that will be used to acquire temporary construction easements from the necessary property owners at a cost of \$11,900; and,

WHEREAS, an engineering design change was also requested to shift the new waterline from the east side of the road to the west side of the road to provide more room for the required drainage improvements; and,

WHEREAS, all of this additional work has resulted in a net addition to the original proposal amount of \$21,700, bringing the total contract amount to \$34,200; and,

WHEREAS, the Director of Public Service, in a report dated February 18, 2020, has recommended approval of the additional cost of the engineering design fees.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, _____ members elected thereto concurring:

SECTION 1. ORDINANCE NO. _ 9 _-2020

AUTHORIZING THE MAYOR AND DIRECTOR OF FINANCE TO ENTER INTO AN AMENDED AGREEMENT WITH THE CHAIRMAN OF THE LUCAS COUNTY GENERAL HEALTH DISTRICT ADVISORY COUNCIL FOR A CONTRACT PROVIDING FOR THE ADMINISTRATION OF HEALTH AND ENVIRONMENTAL AFFAIRS IN THE REGIONAL COMBINED HEALTH DISTRICT; AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance No. 116-99, passed by Sylvania City Council on October 18, 1999, authorized the Mayor and Director of Finance to enter into an Agreement with the Chairman of the Lucas County General Health District Advisory Council establishing a regional combined health district; and,

WHEREAS, Ordinance No. 2-2005, passed by Sylvania City Council on January 3, 2005, authorized the Mayor and Director of Finance to enter into a Second Amended Agreement with the Chairman of the Lucas County General Health District Advisory Council, which contained no substantive changes to the Agreement only an extension of the term of the Agreement; and,

WHEREAS, Ordinance No. 102-2009, passed October 5, 2009, authorized the Mayor and Director of Finance to enter into a Third Amended Agreement with the Chairman of the Lucas County General Health District Advisory Council for a contract providing for the administration of health and environmental affairs in the regional combined health district; and,

WHEREAS, the City has received a proposed Amended Agreement in which there are no substantive changes made to the proposed Amended Agreement, the only change being to extend the term of the Agreement to January 1, 2025; and,

WHEREAS, the Agreement provides that the governing body of said health district shall be the Regional Combined Health District Board which will be comprised of thirteen members with one member from the City of Sylvania being appointed to represent the City; that the agreement may be terminated by either party on one year written notice; the regional combined health district board shall establish and approve a regional health district budget for which the City of Sylvania will provide 3.35% (increased from 3% to 3.35% in 2009) of the total intergovernmental revenue no later than March 31 of each year; and the regional health district board shall provide a written detailed account of all actions, efforts and progress of the regional

combined health district every forty-five days commencing from the effective date of the
Agreement and continuing thereafter throughout the term of the Agreement; and.
NOW, THEREFORE BE IT ORDAINED by the Council of the City of Sylvania, Lucas
County, Ohio, members elected thereto concurring:
SECTION 1. That the Mayor and Director of Finance be, and they hereby are, authorized, on behalf of the City of Sylvania, Ohio, to enter into an Amended Agreement with the Chairman of the Lucas County General Health District Advisory Council, which Agreement is attached hereto as "Exhibit A."
SECTION 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
SECTION 3. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City.
SECTION 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that the Amended Agreement should be entered into as soon as possible in order to maintain the administration of health and environmental services in the City of Sylvania. ORDINANCE NO. <u>10</u> -2020

AUTHORIZING THE MAYOR AND DIRECTOR OF FINANCE TO ENTER INTO A CUSTOMER SUPPLY AGREEMENT FOR THE PROVISION OF ELECTRIC ENERGY TO RESIDENTIAL AND SMALL COMMERCIAL CUSTOMERS WITHIN THE CITY OF SYLVANIA; AND DECLARING AN EMERGENCY.

WHEREAS, Sylvania has been a Public Utilities Commission of Ohio ("PUCO") certified governmental aggregator since 2000 and has offered various programs to residential and small commercial users over the years; and,

WHEREAS, the Sylvania is also a member of the Northwest Ohio Aggregation Coalition ("NOAC") as are several other neighboring communities; and,

WHEREAS, NOAC's current Agreement with FirstEnergy Solutions expires in April, 2020 and NOAC's energy consultant, Palmer Energy, recently issued an RFP for residential and small commercial customers to 14 suppliers; and,

WHEREAS, NOAC received five proposals for the provision of lower-cost electricity to residential and small commercial customers within the City of Sylvania; and,

WHEREAS, the NOAC member communities have met and reviewed the proposals with Palmer Energy and Palmer Energy has recommended moving forward in the contract review and evaluation process with AEP Energy, Dynegy, and FirstEnergy Solutions for 24-month terms to further evaluate and determine which supplier will represents the best savings for the residential and small commercial consumers in the City of Sylvania; and,

WHEREAS, the responses to the RFP provide for the term of the Agreement to be twenty-four months with anticipated approximate annual savings of \$53 for residential customers

and \$152 annually for commercial customers over the term of the Agreement. NOW, THEREFORE BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, _____ members elected thereto concurring: SECTION 1. That the Mayor and Director of Finance be, and they hereby are authorized to enter into a Customer Supply Agreement with First Energy Solutions, AEP Energy or Dynegy, subject to final review and approval of the Director of Law and the City's consultant. Palmer Energy on behalf of the City of Sylvania. SECTION 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code. SECTION 3. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City. SECTION 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that the Customer Supply Agreement should be executed immediately so as to provide uninterrupted service to the municipal customers in the City of Sylvania. WHEREAS, Ohio Revised Code Section 167.01 provides that the governing bodies of any two or more political subdivisions may enter into an Agreement establishing a regional council of governments; and,

WHEREAS, Ohio Revised Code Sections 167.03(A)(5) and 128.03(D)(1) provide that a regional council of governments has the power to operate a public safety answering point; and,

WHEREAS, the Safety Committee met on November 6, 2019 to consider and gather information from the Director of Public Safety and Chief of Police regarding the 911 consolidation; and,

WHEREAS, a Special Council Meeting was held following the Safety Committee meeting on November 6, 2019 to appoint the City of Sylvania's representative to the Lucas County 9-1-1 Planning Committee; and,

WHEREAS, Resolution No. 17-2019, passed by Sylvania City Council on November 6, 2019, appointed Donald L. Atkinson, Mayor of Whitehouse, as the City of Sylvania's representative to the Lucas County 9-1-1 Planning Committee; and,

WHEREAS, the Lucas County 911 Planning Committee amended Lucas County's Final Plan through an Addendum passed on December 10, 2019 merging and consolidating 911 operations under a regional council of governments; and,

WHEREAS, the City of Sylvania desires to participate with all of the other political subdivisions in Lucas County in the formation of a regional council of governments for the purpose of operating a public safety answering point in accordance with Chapter 128 of the Ohio Revised Code; and,

WHEREAS, the proposed Agreement is attached hereto as "Exhibit A."

AGREEMENT

ESTABLISHING THE LUCAS COUNTY 911 REGIONAL COUNCIL OF GOVERNMENTS

WHEREAS, Ohio Revised Code Section 167.01 provides, in general, that the governing bodies of any two or more political subdivisions may enter into an agreement establishing a regional council of governments for the purposes of performing functions and duties that its Members can perform individually and addressing problems of mutual concern; and

WHEREAS, Ohio Revised Code Sections 167.03(A)(5) and 128.03(D)(1) provide that a regional council of governments shall have the power to operate a public safety answering point; and

WHEREAS, the Lucas County 911 Planning Committee amended Lucas County's Final Plan through an Addendum passed on December 10, 2019 merging and consolidating 911 operations under a regional council of governments; and

WHEREAS, the Board of Lucas County Commissioners and all other political subdivisions located within Lucas County wish to form a regional council of governments for the purpose of operating a public safety answering point in accordance with Chapter 128 of the Revised Code;

NOW, THEREFORE, it is agreed by and among the Members identified herein, on behalf of which this Agreement has been executed in accordance with the authorizing resolutions or ordinances adopted by their respective governing bodies, as follows:

Section 1. Purposes. The Lucas County 911 Regional Council of Government is created, in accordance with Section 167.03(A)(5) of the Ohio Revised Code, to organize and operate a Public Safety Answering Point in accordance with Chapter 128 of the Ohio Revised Code.

Section 2. <u>Definitions</u>. As used in this Agreement and in the By-laws adopted pursuant to Section 5 hereof, the following words shall have the following meanings:

"Agreement" means this agreement, as the same may be amended, modified or supplemented in accordance with Section 11 hereof.

"By-laws" means the regulations adopted by the Council pursuant to Revised Code. § 167.04, as those regulations may be amended, modified or supplemented in accordance with this Agreement.

"Regional Council" or "Council" means the regional council of governments established pursuant to this Agreement that shall be known as the Lucas County 911 Regional Council.

"Council Costs" means operating costs and any other costs incurred in connection with the activities and operations of the Regional Council. "Council Funds" means the funds that shall be established and maintained by the Treasurer and/or Fiscal Agent as separate funds in accordance with the By-laws, into which shall be deposited all assessment, membership dues, grants, or other revenue generated from any and all sources.

"Board of Directors" means the governing board of the Council consisting of the following: (A) County Sheriff, (B) the police chief of the most populous municipality in the County, (C) the fire chief from the most populous municipality in the County, (D) the police chief from the second most populous jurisdiction in the County, (E) a Lucas County municipal police chief selected by a majority of the suburban municipal police chiefs, (F) a municipal fire chief selected by a majority of the suburban municipal fire chiefs, and (G) a township fire chief selected by the Lucas County Township Association. The Board of Directors shall have primary responsibility for the conduct of the Council's business in accordance with Ohio Revised Code Section 167.04(A) and as specified in the By-laws.

"Technical Advisory Committees" shall include the following: (A) Law Enforcement Technical Advisory Committee, (B) Fire and Emergency Medical Service Technical Advisory Committee, and (C) the Administrators Technical Advisory Committee and shall have the duties specified in this Agreement and the By-laws.

"Fiscal Agent" means the entity as may be designated by the Governing Board pursuant to the By-laws.

"Chief Financial Officer" means the fiscal officer appointed by the Board of Trustees pursuant to the By-laws, in the event that the Board of Directors should at any point in time determine to operate the Council's financial services through direct action, without the services of a Fiscal Agent, pursuant to Chapter 167 of the Ohio Revised Code. If a Chief Financial Officer is so appointed, all references in this Agreement pertaining to the Fiscal Agent shall be deemed to relate to the Chief Financial Officer, who shall have all of the rights, powers, and responsibilities ascribed to the Fiscal Agent by such documents, unless clearly inappropriate.

"Fiscal Year" means the twelve-month period established by the Board of Directors.

"Member" means the Board of Lucas County Commissioners and any of the political subdivisions of Lucas County that has caused this Agreement to be executed in its name in accordance with Section 8 hereof and has not withdrawn from the Council pursuant to By-laws Section 9 of this Agreement.

"9-1-1 Planning Committee" means the same as in R.C. 128.06.

Section 3. Name. The name of this regional council of governments shall be the "Lucas County 911 Regional Council of Government." The Board of Directors shall have the authority to change the council name.

Section 4. Representation of Members. Each Member of the Council shall be represented by the member jurisdiction's representative on the Board of Directors as specified in Section 2 of this Agreement.

Section 5. Adoption of By-laws. Within ninety days following execution of this Agreement by at least two members, the Board of Directors shall meet for the purpose of adopting By-laws. The affirmative vote of a majority of the Board of Directors shall be required for the adoption of the By-laws.

Section 6. <u>Technical Advisory Committees</u>. The Regional Council shall maintain three Technical Advisory Committees: (A) Law Enforcement Technical Advisory Committee, (B) Fire and Emergency Medical Services Technical Advisory Committee, and (C) Administrators Technical Advisory Committee.

The Law Enforcement Technical Advisory Committee shall be tasked with reviewing, presenting and establishing recommendations to the Board of Directors regarding law enforcement policies and procedures that impact the Lucas County 911 Regional Council of Governments. Every chief of a law enforcement agency in Lucas County shall have a seat on the Law Enforcement Technical Advisory Committee.

The Fire and Emergency Medical Services Technical Advisory Committee shall be tasked with reviewing, presenting and establishing recommendations to the Board of Directors regarding fire and emergency medical policies and procedures that impact the Lucas County 911 Regional Council of Governments. Every fire chief in Lucas County as well as the administrator of Lucas County EMS shall have a seat on the Fire and Emergency Medical Service Technical Advisory Committee.

The Administrators Technical Advisory Committee shall be responsible for reviewing administrative and budgetary matters as well as recommending the annual budget and all collective bargaining agreements of the Lucas County 911 Regional Council of Governments. All budgets and collective bargaining agreements must be approved and recommended by a majority of the Administrators Technical Advisory Committee before formal consideration and approval by the Board of Directors. The annual budget for the Lucas County 911 Regional Council of Governments shall be presented to the Administrators Technical Advisory Committee no less than 90 days prior to the start of each fiscal year. The Administrators Technical Advisory Committee shall be comprised of the chief elected official or their designee of each political subdivision of Lucas County.

Section 7. <u>Assessment of Fees and Costs</u>. Annually the Board of Directors will determine the costs of the Regional Council for the next fiscal year based upon the annual budget recommended and approved by a majority of the Administrators Technical Advisory Committee. These costs shall be assessed to the county, municipalities, and townships in Lucas County based on the method and formula determined by the 9-1-1 Planning Committee, regardless of membership status of the county, municipality, village or township.

Failure to pay the assessment pursuant to this Agreement may result in the assessment of interest charges and legal action as provided in Ohio law and the By-laws.

Section 8. Membership. Membership in the Regional Council is open to Lucas County and all municipalities, villages and townships in Lucas County. The Board of Directors may expand membership to include political subdivisions outside of Lucas County.

Section 9. New Member Admissions. Upon request and approval of a majority of the Board of Directors, a non-member county, municipality, village or township may be admitted as a member of the Regional Council.

Section 10. <u>Withdrawal of a Member.</u> Any Member wishing to withdraw from the Regional Council may do so with 60 days written notice. Withdrawal as a member shall not relieve Lucas County member jurisdictions of continuing to pay the assessment authorized by Section 6.

Section 11. <u>Title to Property and Assets</u>. Title to all property and assets of the Council, regardless of whether such property and/or assets are real or personal, tangible or intangible, and regardless of whether such property and/or assets originated from contributions by Members, external sources, or were developed by the activities of the Council, shall be vested solely in the Council and not in its respective Members.

Upon the withdrawal of any Member pursuant to Section 9 herein or otherwise, the withdrawing Member shall have no right or claim upon any such property or assets of the Council, except as may be due and owing to such Member under a specific contractual arrangement, or as a result of overpayment of dues by such Member.

Upon termination of this Agreement and dissolution of the Council, all property and assets remaining in the hands of the Council shall be distributed in accordance with the provisions of Section 13 herein.

Section 12. <u>Amendments</u>. All proposed amendments to this Agreement must be approved by a super majority (seventy percent) of the Board of Directors.

Section 13. <u>Term of Agreement</u>. It is the express intention of the Members that this Agreement shall continue for an indefinite term, but may be terminated as herein provided.

Section 14. <u>Termination of Agreement; Dissolution</u>. This Agreement may be terminated only with the approval of a super majority (seventy percent) of the Board of Directors or through an amendment to Lucas County's Final Plan pursuant to Ohio Revised Code Section 128.12. Upon termination, the Board of Directors will determine the disposition of the Council's property and assets.

Section 15. <u>Effectiveness and Counterparts of the Agreement</u>. This Agreement shall not be effective with respect to any Member until signed by the representative of that Member, as authorized by a duly adopted resolution or ordinance of the governing body of that Member. This Agreement shall be effective with respect to the establishment and operation of the Council upon

its execution by the Board of Lucas County Commissioners and at least one municipal and one township member. The Agreement may be signed in separate counterparts on behalf of any one or more than one of the Members, without the necessity for any one counterpart to be signed on behalf of all Members. All separately signed counterparts shall be filed with the Council Fiscal Agent and shall constitute one Agreement.

Section 16. No Third-Party Beneficiaries. The parties hereby expressly declare that, unless specifically so provided herein, it is not their intention, through any provision of this Agreement, to create the rights of a third-party beneficiary in any other person or entity, either private or governmental.

Item 4 – Regulated Sign – app. no. 3-2020 requested by Myra Gueli of Toledo Sign for Spoke Life Cycles, 6363 Monroe Street, Sylvania, Ohio 43560. Ms. Gueli present. Application is for a new monument sign, which will replacement the existing temporary sign, and new channel letters on the raceway sign on the front of the building. Both signs will be internally lit.

Mayor Stough asked Mr. Burns if the monument sign was allowed as there is another at that location.

Mr. Burns said that the sign is allowed because this is a separate building. He added that the building is also under separate ownership.
