TO ASSESS A SPECIAL TAX UPON THE LOTS AND LANDS DESCRIBED IN THE SCHEDULE REFERRED TO HEREIN TO PAY A PART OF THE COST AND EXPENSE OF PROVIDING FOR THE REMOVAL AND SPECIAL TREATMENT OF SHADE TREES FOR THE PURPOSE OF CONTROLLING BLIGHT AND DISEASE OF SAME; AND FOR PLANTING, MAINTAINING, TRIMMING AND REMOVING SHADE TREES IN AND ALONG THE STREETS AND WITHIN PUBLIC RIGHT-OF-WAY OF THE CITY FOR THE YEAR ENDING DECEMBER 31, 2020; AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the City of Sylvania has heretofore, by Ordinance, established one (1) district for the purpose of removing or specially treating therein shade trees for the purpose of controlling the blight and disease of same for the planting, maintaining, trimming and removing shade trees in and along the streets and within public right-of-way of the City of Sylvania during the year 2020, and provided that part of the cost and expense connected with said work in said district in the total amount of Two Hundred Forty-Four Thousand, Four Hundred Twenty-Two and 78/100 (\$244,422.78) shall be levied and assessed in the sum of thirty-five cents (35¢) per front foot upon all lots and lands bounding and abutting upon the streets and public right-of-way in said district as set forth in said Ordinance; and,

WHEREAS, the Clerk of Council has given notice of the passage of the Ordinance creating the Tree District for 2020, and of the estimated assessments on file in the Office of the Clerk of Council; and,

WHEREAS, Council has considered and adjusted all objections to estimated assessments that were properly and timely filed.

NOW, THEREFORE BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, _____ members elected thereto concurring:

SECTION 1. That, to pay the cost and expense of the removal or special treatment of certain shade trees for the purpose of controlling the blight and disease and for planting, maintaining, trimming and removing of other shade trees in and along the streets and within public right-of-way of the City of Sylvania described in the schedule as reported by the Clerk of Council for the year ending December 31, 2020, there be, and hereby is assessed, in one (1) installment for 2020, upon the lots and lands bounding and abutting upon the streets and public right-of-way in said district, the several sums shown in the list of assessments, as adjusted if adjusted, and set opposite the description of the respective lots and lands and do hereby determine and declare that said lots and lands are specially benefitted in the amounts so assessed against the same, which amounts and assessments are hereby confirmed and approved.

SECTION 2. That the owners of said several lots and parcels of land shall pay the said sum so assessed as above against their said lots and lands, respectively, in one (1) installment, to the Treasurer of Lucas County, Ohio, at the same time and in the same manner as other taxes are paid, or be subject to the penalty and interest to be paid thereon as provided by law.

SECTION 3. That the Clerk of Council be, and she hereby is, directed to certify said assessments in one (1) installment within twenty (20) days of the passage hereof, to the Auditor of Lucas County, Ohio, to be, by him, placed upon the grand tax duplicate of said County for the year 2019 against said lots and lands, respectively, to be collected at the same time and in the same manner as other taxes are collected.

SECTION 4. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City.

SECTION 6. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that the assessments need to be certified immediately so as to meet the deadline for certifying the same to the Auditor and therefore this Ordinance should be effective immediately. Provided this Ordinance receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force thirty (30) days after it is approved by the Mayor or as otherwise provided by the Charter.

TO ASSESS A SPECIAL TAX UPON THE LOTS AND LANDS DESCRIBED IN THE SCHEDULE REFERRED TO HEREIN TO PAY A PART OF THE COST AND EXPENSE OF PROVIDING FOR THE CONSTRUCTION, MAINTENANCE, REPAIR, CLEANING AND ENCLOSING OPEN DRAINAGE DITCHES WITHIN THE CORPORATE LIMITS OF THE CITY OF SYLVANIA FOR THE YEAR ENDING DECEMBER 31, 2020; AND DECLARING AN EMERGENCY.

That the assessments for the street lighting authorized by said Resolution in the aggregate amount of Four Hundred Twenty-One Thousand, Four Hundred Eighty and 24/100 (\$421,480.24) and the assessments, as adjusted if adjusted, are hereby approved an such assessments in the amount so approved are hereby levied on the several parcels and lots of land in said City on the basis as set forth in said Resolution and the Clerk of Council is hereby directed to certify said assessments to the Auditor of Lucas County, Ohio, within the time provided therefore by the Revised Code of Ohio Section 5705.34.

SECTION 2. Re: Acres Road Sanitary Sewer Extension (6024 & 6030 Acres Road)

Dear Mr. Mayor and Council Members:

Construction of the sanitary sewer extension to 6024 and 6030 Acres Road is complete. The total cost of the project including design, permitting, and construction is \$15,959.66.

It is our recommendation that the cost of the project be assessed to the benefitting properties on a per unit basis. This results in a final assessment for each parcel to be \$7,979.83. We would recommend a payment term of 20 years at an interest rate of 2.12%, the current rate for Ohio Water Development Authority loans.

We would recommend approval of this final assessment. Please call if you have any questions.

ORDINANCE NO. <u>44</u> -2020

AN ORDINANCE LEVYING SPECIAL ASSESSMENTS FOR THE IMPROVEMENT OF ACRES ROAD BETWEEN SUGAR HILL COURT AND GREENHAVEN ROAD, BY INSTALLING EIGHT INCH SANITARY SEWER LINES TOGETHER WITH THE NECESSARY APPURTENANCES THERETO; AND DECLARING AN EMERGENCY.

WHEREAS, the improvement described in Section 1 hereof has been completed and the final costs of that improvement have been determined.

NOW, THE	REFORE, BE IT ORDAINED by the Council of the City of Sylvania, Lucas
County, Ohio,	members elected thereto concurring:

SECTION 1. That the special assessments for the cost and expense of improving Acres Road between Sugar Hill Court and Greenhaven Road by installing eight inch sanitary sewer lines together with the necessary appurtenances thereto, pursuant to Resolution No. 5-2020, adopted February 3, 2020, amounting in the aggregate to Fifteen Thousand Nine Hundred Fifty-Nine and 66/100 Dollars (\$15,959.66), which were filed and are on file with the Clerk of Council, are adopted and confirmed. Those special assessments are levied and assessed upon the lots and lands provided for in Resolution No. 5-2020 in the respective amounts set forth in the Schedule of Special Assessments now on file with the Clerk of this Council which special assessments are in proportion to the special benefits and are not in excess of any statutory limitation.

SECTION 2. That this Council finds and determines that the special assessments are in the same proportion to the estimated special assessments as the actual cost of the improvement is to the estimated cost of the improvement as originally filed.

SECTION 3. That the special assessment against each lot or parcel of land shall be payable in cash within thirty (30) days after the passage of this Ordinance, if bonds are not issued, there shall be charged an interest rate of two and twelve hundredths percent (2.12%) per annum or at the option of the rate as borne by the bonds to be issued in anticipation of the collection of the special assessments. All cash payments shall be made to the Director of Finance of this City. All special assessments remaining unpaid at the expiration of those thirty (30) days shall be certified by the Clerk of Council to the County Auditor as provided by law, to be placed on the tax duplicate and collected as taxes are collected.

<u>SECTION 4.</u> That the Clerk of Council shall deliver a certified copy of this Ordinance to the County Auditor within twenty (20) days after its passage.

SECTION 5. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 6. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Administration Building pursuant to ARTICLE III, Section 12, of the Charter of this City.

SECTION 7. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that the immediate effectiveness of this Ordinance is required in order that the levy of the special assessments and the commencement of the cash payment period may be immediately effective so that bonds may be issued to reimburse the City for funds it expended to finance the construction of the improvements described in Section 1. Provided this Ordinance receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force thirty (30) days after it is approved by the Mayor or as otherwise provided by the Charter.

Dear Mr. Mayor and Council Members:

On February 18, 2020 City Council authorized the Service Department to submit a Highway Safety Improvement Program (HSIP) funding application to the Ohio Department of Transportation (ODOT) for the proposed improvement planned at the US-23 & Monroe Street Interchange (Res. 6-2020). The application requested \$9,790,783 in safety funding assistance for the \$28,051,064 project.

The Service Department was notified this month that the funding application was successful receiving the full amount requested.

Since August 2019, the Service Department has secured \$24.3 million in outside funding assistance. The remaining piece of outside funding assistance will be pursued in November 2023 with OPWC. We have enclosed an updated funding matrix for your review.

With the necessary funds in place project management will transition from the Service Department to ODOT for design and construction. Design is scheduled to commence in fiscal year 2022 with construction scheduled for fiscal year 2025 through 2026.

ORDINANCE NO. <u>46</u> -2020

PROPOSING AND PROVIDING FOR THE SUBMISSION OF CERTAIN AMENDMENTS OF THE CHARTER OF THE CITY OF SYLVANIA, OHIO, TO THE ELECTORS OF THE CITY OF SYLVANIA, OHIO, AT THE NEXT GENERAL ELECTION ON NOVEMBER 3, 2020, IN ACCORDANCE WITH THE CHARTER OF THE CITY OF SYLVANIA, OHIO, AND THE CONSTITUTION OF THE STATE OF OHIO; REPEALING THE PROVISIONS, AS CURRENTLY WRITTEN, OF THE CHARTER OF THE CITY OF SYLVANIA, OHIO, HEREBY PROPOSED TO BE SO AMENDED; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Sylvania, Ohio, adopted a Charter on September 6, 1961; and, WHEREAS, said Charter was amended in certain respects on November 5, 1968 and November 6, 1984, November 5, 1985 and November 7, 2000; and,

WHEREAS, the Committee-of-the-Whole met on June 24, 2020 to consider the proposed Charter Amendments and thereafter recommended that the Charter be amended; and,

WHEREAS, proposed amendments to this City's Charter are required by Article XIV of said Charter to be submitted to the electors of said City in accordance with the Constitution of the State of Ohio which, pursuant to Sections 8 and 9 of Article XVIII thereof, requires the question to be submitted to the electors of this City at the next regular municipal election within sixty (60) to one hundred twenty (120) days after the passage hereof or at a special election within such times; and,

WHEREAS, a special election may be held at the same date and time as the general election.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sylvania, Ohio,

members thereto concurring:

SECTION 1. That it be, and hereby is, proposed to the electors of the City of Sylvania,

Ohio, at the next general election to be held in this City on November 3, 2020, the question of the adoption and approval of a certain amendments to the Charter of the Municipality of Sylvania, Ohio, as follows:

A. Section 4.0 of Article III of said Charter shall be amended so that the same, as amended, shall read as follows:

"SECTION 4.0 ORGANIZATION.

On or before the 8th of January next following each regular municipal election, the members of Council shall meet at the Council Chambers for the purpose of organization. At such meeting, the Council shall elect one of the members thereof as President of the Council to serve until his successor shall have been elected. In the event the President of the Council ceases to be a member thereof, the Council shall elect another member to serve as President until his successor shall have been elected."

B. Section 11.0(b) of Article III of said Charter shall be amended so that the same, as amended, shall read as follows:

"SECTION 11.0 PROVISIONS AS TO LEGISLATIVE ACTION.

- (b) Ordinances and resolutions shall be read once prior to passage by reading aloud a descriptive title or summary thereof and stating the number assigned to such ordinance, except that, if any four Council members so request, the reading shall be of the full text of the ordinance or resolution. If any three members of Council so request, the reading of any ordinance or resolution, whether by title or full text, shall be required to occur on three different days. Each request for reading by full text, and for reading on three different days, shall be entered upon the journal of Council with the names of the members making the request."
- C. Section 5, subsections (b)(d) and (e) of Article IV of said Charter shall be amended so that the same, as amended, shall read as follows:

"SECTION 5.0 EXECUTIVE POWERS.

- (b) He and the Director of Finance shall be responsible for the preparation and submission of the annual estimate of receipts and expenditures and of appropriation measures and for furnishing to the Council full information of the financial condition and needs of the City. He shall be responsible for the faithful observance and performance of the conditions imposed in favor of the City or its inhabitants by any franchise or contract to which the City is a party.
- (d) "...If following such hearing the Mayor shall remove such individual, he shall file with the Director of Finance a signed order of removal accompanied by

- a written statement of his findings at such hearing and the reasons for such removal. Upon approval of such order by a majority of the members of Council such removal shall become final and the Director of Finance shall notify the individual so removed accordingly.
- (e) The Mayor and Director of Finance shall execute on behalf of the City all contracts, conveyances, evidences of indebtedness and all other instruments to which it is a party. He shall have custody of the Seal of the City and may affix it to any of said instruments, but the absence of the Seal shall not affect the validity of such instrument. The Mayor shall be recognized as the official and ceremonial head of the City by the Governor for military purposes and by the Courts for the purpose of serving civil processes."
- D. Section 4.0 of Article VI of said Charter shall be amended so that the same, as amended, shall read as follows:
 - "SECTION 4.0 ELIGIBILITY OF DIRECTOR OF FINANCE.

 The Director of Finance shall be eligible to hold the office of City Treasurer."
- E. Article X of said Charter shall be amended so that the same, as amended, shall read as follows:

"ARTICLE X NOMINATIONS AND ELECTIONS.

SECTION 1.0 MUNICIPAL ELECTIONS.

All elections provided for by this Charter, whether for the choice of officials or the submission of questions to the voters, shall be conducted by the election authorities prescribed by the laws of the State of Ohio, which laws shall apply to all such elections except as provision is otherwise made by this Charter. A regular municipal election for the choice of all elective offices of the City shall be held on the first Tuesday after the first Monday in November in the year 1961 and on such day in the odd-numbered years thereafter. The nominating petitions and ballots to be used in all municipal elections shall bear no party marks or designations.

- SECTION 2.0 NOMINATING PROCEDURE.
- (a) Nominations for elective office of the Municipality shall be made only by petition filed with the election authorities ninety (90) days prior to the first Tuesday after the first Monday in November.
- (b) The name of any qualified elector of the City shall be placed upon the election ballot for nomination as a candidate for Mayor when there shall have been filed with the election authorities signed by not less than one hundred (100) nor more than two hundred (200) electors of the City, and for City Council when there shall have been filed with the election authorities a petition signed by not less than fifty (50) nor more than one hundred (100) electors of the City.
- (c) The nominating petition shall contain a statement of candidacy, which shall designate a committee to represent the candidate. Both the nominating petition

and statement of candidacy shall be substantially in the form prescribed by the State of Ohio for nominating petitions generally, and shall be signed, circulated and filed in accordance with the provisions of the Ohio Revised Code. SECTION 4.0 WHO TO BE DECLARED ELECTED.

The candidates for any elective office, equal in number to the places to be filled, who shall receive the largest number of votes at such regular municipal election shall be declared elected."

- <u>SECTION 2.</u> That the aforesaid proposed amendments to Sylvania's Charter shall include the proposal and submission of Sylvania's Charter as it is written immediately before the proposed amendments are approved by the electors.
- SECTION 3. That the Board of Elections of Lucas County is hereby requested to submit the proposed Charter amendments as two ballot issues; one issue for the proposed amendments to Article X and one issue for the remaining proposed amendments.
- SECTION 4. That the Clerk of Council is hereby directed to forward a certified copy of this Ordinance to the Board of Elections of Lucas County, Ohio, to certify to said Board the enactment of this Ordinance submitting said Charter amendments to the general election to be held on November 3, 2020, and to request said Board of Elections to provide for submitting of the questions of adopting said amendments at such election, and to do all of the same prior to 4 o'clock p.m. on August 5, 2020.
- SECTION 5. That the Clerk of Council is further authorized and directed to give notice of the proposed Charter amendment by causing the publication of the full text of the proposed Charter amendments once a week for not less than two (2) consecutive weeks in The Blade, a newspaper published and/or of general circulation within the City of Sylvania, Ohio, with the first publication being at least fifteen (15) days prior to November 3, 2020, the election at which the proposed amendments are to be submitted to the electors of the City of Sylvania. The publication of this entire Ordinance enacted by the Council of the City of Sylvania as provided hereinabove for the giving of such notice shall constitute the giving of the notice herein required.
- SECTION 6. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
- SECTION 7. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City.
- <u>SECTION 8.</u> That this Ordinance is hereby declared to be an emergency measure and shall take effect and be in force from and after its passage by five (5) or more

members of Council and approval by the Mayor. The reason for the emergency lies in the fact that this Ordinance is necessary for the immediate preservation of the public peace, health and safety in that said Board of Election should be notified as soon as possible in order to prepare properly for said election and in any event must be notified prior to 4 p.m. on August 5, 2020.

That the City of Sylvania hereby requests CARES Act funding to be distributed by the County Auditor and by adopting this resolution affirms that the revenue will only be used for the purposes prescribed in the CARES Act, Section 5001 of the 'Coronavirus Aid, Relief and Economic Security Act,' as described in 42 USC 801(d) (formerly 42 USC 601(d)), and any applicable regulations, for necessary expenditures incurred due to the public health emergency connected with COVID-19 pandemic, provided those expenses are incurred between March 1 and December 20, 2020, and are not accounted for in the current budget and certifies such to the State Director of Office of Budget and Management and the County Auditor.

SECTION 2. That the City of Sylvania will comply with the procedure created by Am. Sub. H.B. 481 of the 133rd G.A. to receive funds under the CARES Act.

SECTION 3. SECTION 5. That the Clerk of Council is hereby directed to post a copy of this Resolution in the office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12 of the Charter of this City.

SECTION 6. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that the City must request CARES Act funding in order for it to receive the distribution from the County Auditor and therefore this Resolution should be made effective immediately. Provided this Resolution receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force thirty (30) days after it is approved by the Mayor or as otherwise provided by the Charter.
