The Council of the City of Sylvania, Ohio met in regular session via Zoom on January 4, 2021 at 7:40 p.m. with Mayor Stough in the chair. Roll was called with the following members present: Katie Cappellini, Mark Frye, Doug Haynam, Brian McCann, Patrick Richardson, Lyndsey Stough, Mary Westphal; (7) present; (0) absent.

Re: LUC-Monroe-0127 Bridge Rehabilitation

Dear Mr. Mayor and Council Members:

The bidding documents for the above referenced project are complete.

This project will rehabilitate the Monroe Street bridge deck over the North Branch of Tenmile Creek using hydrodemolition with a concrete overlay. This process consists of removing the top 3" of concrete with high pressured water and overlaying the remaining sound surface with rigid concrete. Other rehabilitation work includes full/partial depth slab repairs, curbing and sidewalk reconstruction, and bridge railing and guardrail replacement.

Construction is scheduled for June and July of 2021 and will require a full bridge closure for two weeks. Once the bridge deck work is completed the contractor will open one lane of traffic in each direction for an additional five weeks to complete replacements of parapet walls, railing, sidewalks, guardrail, decorative lighting, and install a new bridge deck drip irrigation system for planters.

The estimated construction cost of the project is \$188,311. This was a planned expense in the 2021 capital improvement budget and will be funded from account number 401-7610-53503.

We would request that the Clerk of Council be authorized to advertise for bids.

Dear Mr. Mayor and Council Members:

City Council approved construction of this project via Ordinance 89-2020 and construction of the waterline was recently completed. The project extended along Brint Road westerly from Harroun Road approximately 400 feet.

The properties along Brint Road receive a benefit from the waterline's location. Accordingly, we have created a cost recovery roster and map showing those properties receiving such benefit and the corresponding value of that benefit. Please note that the property will only pay these costs should they choose to connect to the waterline. The cost will rise annually 1.78% as shown utilizing the current Ohio Water Development Authority bond rate.

ORDINANCE NO. <u>8</u> -2021

ESTABLISHING THE 6302-6342 BRINT ROAD WATERLINE AND THE COST RECOVERY FEE FOR THE AREA; AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO ADJUST THE COST RECOVERY FEE TO REFLECT ACTUAL CONSTRUCTION COSTS; AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance No. 89-2020, passed by Sylvania City Council on October 19, 2020, accepted the proposal of Provo Construction for the installation of an 8" waterline to provide water service to 6302-6342 Brint Road, Sylvania, Ohio; and,

WHEREAS, Ordinance No. 110-2020, passed by Sylvania City Council on December 21, 2020, authorized the Mayor and Director of Finance to approve Change Order No. 1 (Final) to this City's Agreement with Provo Construction for the 6302-6342 Brint Road Waterline Project which increased the contract amount by \$2,632, for a total contract amount of \$35,790;

WHEREAS, the City of Sylvania has constructed a waterline along Brint Road to serve the area described on the attached; and,

WHEREAS, there are five parcels, identified on the attached Cost Recovery Fee Schedule that are benefitted equally by said waterline, and all of said benefitted area is located within the City of Sylvania, Ohio, and within the City of Sylvania Water Service Area, as that term is defined in the Water Agreement; and,

WHEREAS, the Director of Public Service has determined the unpaid portion of the project costs of said waterline allocable to said benefitted area to be Thirty-Nine Thousand Two Hundred Ninety-Six and 25/100 Dollars (\$39,296.25) as shown on the attached exhibit and has calculated the benefit to properties not connected to the Sylvania Water System within said service area to be \$7,859.25 per parcel; and,

WHEREAS, a service area should be established and the basis for the connection fee should be determined, by this Council, for those properties in the service area, that may, in the future, request to tap into the Sylvania Water System.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, _____ members elected thereto concurring:

<u>SECTION 1.</u> That the area as shown on said map for 6302-6342 Brint Road attached hereto is hereby established as the 6302-6342 Brint Road Water Service Area.

SECTION 2. That the connection fee cost recovery schedule, as set forth on "Exhibit A," is hereby adopted as the cost recovery fee schedule applicable to all area within the cost recovery service area established by Section 1 hereof, for all connections therein to Sylvania's water system.

SECTION 3. No connections within said area shall be made to the Sylvania Water System unless the applicable connection fee is first paid to the City of Sylvania.

<u>SECTION 4.</u> That the Director of Public Service is hereby authorized to increase or decrease the cost recovery fee amount proportionately to the extent the actual construction costs are less than or more than the estimated construction costs and the Director of Public Service is hereby further authorized to propound rules to implement this Ordinance.

SECTION 5. That this Ordinance shall be recorded in the Office of the Recorder of Lucas County, Ohio.

SECTION 6. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 7. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City.

SECTION 8. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that this Ordinance should be effective forthwith so that the public will promptly know the costs for connecting to the Sylvania Water System within the Service Area hereby established. Provided this Ordinance receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force thirty (30) days after it is approved by the Mayor or as otherwise provided by the Charter.

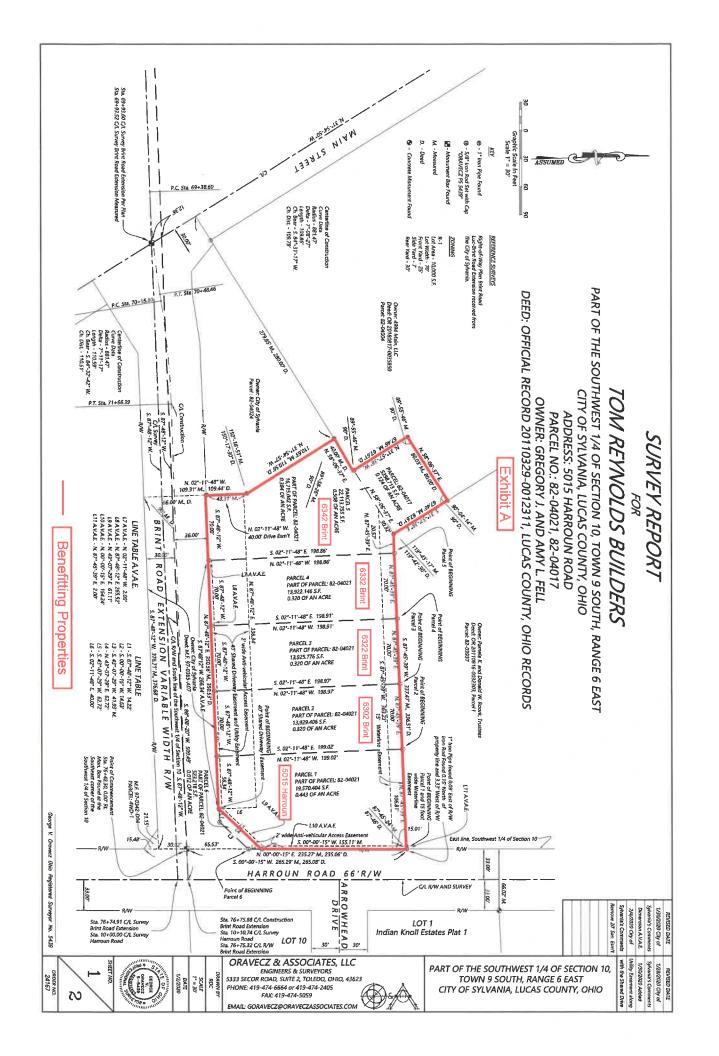

Contract for Professional Surveying and Engineering Services

Dear Mr. Mayor and Council Members:

The Utilities & Environment Committee discussed the Elden Ditch watershed at their meeting held September 8, 2020. At this meeting, the Service Department shared a brief historical timeline of events in this area dating back to 1965. In addition, the Service Department introduced an engineering proposal prepared by Fishbeck to provide a detailed hydraulic study of the watershed. At the conclusion of the meeting, the Committee recommended including the engineering proposal in the 2021 budget with the goal that any proposed infrastructure improvements resulting from the study could be considered for future Ohio Public Works Commission (OPWC) grant opportunities.

The scope of work in the Fishbeck proposal includes five (5) specific Task Orders. These Task Orders include data collection and drainage map generation (#1), existing system analysis (#2), storm sewer routing and recommendations (#3), proposed system analysis, with and without upstream detention (#4), and final deliverables including an executive summary (#5).

Fishbeck's proposal amount is \$28,970 to complete this scope of services. The team of Fishbeck engineers to be assigned to this project are very familiar with the City and have performed previous hydraulic studies for the Highland Meadows/Griffith Park Subdivision in 2009-10 and most recently for the Alexis Road corridor in 2018. Funding of the study would be from the 503-7510-51686 account.

We would recommend approval of the proposal from Fishbeck in the amount of \$28,970. Please call if you should have any questions.

ORDINANCE NO. <u>9</u> -2021

ACCEPTING THE PROPOSAL OF FISHBECK TO CONDUCT PROFESSIONAL ENGINEERING AND SURVEY SERVICES FOR THE ELDEN DITCH HYDRAULIC STUDY; APPROPRIATING FUNDS THEREFORE IN THE AMOUNT OF \$28,970; AND DECLARING AN EMERGENCY.

WHEREAS, at the September 8, 2020 Utilities and Environment Committee, the Elden Ditch watershed was discussed and thereafter, a recommendation was made to include a hydraulic study of the watershed in the 2021 budget; and,

- 1. **METHOD OF AUTHORIZATION**. Client may authorize Fishbeck to proceed with work either by signing a Professional Services Agreement or by issuance of an acknowledgment, confirmation, purchase order, or other communication. 1157.16 BICYCLE PARKING.

- (a) <u>Purpose</u>. The requirements for bicycle parking are established for the purpose of ensuring adequate and safe facilities to accommodate bicycle parking and to encourage use of bicycles for travel as an alternative to use of motorized vehicles.
- (b) <u>Time of Compliance</u>. For applicable parking lots that were approved prior to the initial effective date of this section, required bicycle parking spaces shall be provided no later than two (2) years after the initial effective date of this section. For other applicable parking lots and garages, required bicycle parking spaces shall be provided prior to site plan approval.
- (c) <u>Number of Bicycle Parking Spaces</u>. Bicycle parking spaces shall be provided at a rate of one (1) bicycle parking space for each twenty (20) automobile spaces provided. However, no automobile parking lot or garage shall be required to provide more than **twenty-four (24)** bicycle parking spaces.
- (e) <u>Bicycle Parking Space Size.</u> Required bicycle parking spaces for nonresidential uses must have minimum dimensions of two (2) feet in width by six (6) feet in length.
- (f) <u>Bicycle Parking Space Location</u>. Required bicycle parking spaces shall be located at least as close to the entrance of the building as the nearest non-handicapped automobile parking space.
- (g) <u>Bicycle Racks and Lockers</u>. Each required bicycle parking space shall be equipped with a bicycle rack or "bicycle locker", as defined in this section.
 - (1) <u>Design.</u> Bicycle racks and lockers must be securely anchored to the ground or a building. Bicycle racks must provide a stable frame to which the bicycle

may be conveniently secured, such as the inverted-U, post and loop, or another type of rack that meets these standards. Bicycle racks that support the wheel but not the frame of the bike may not be used to fulfill a bicycle parking requirement. In parking lots and parking garages, physical barriers, such as posts or bollards, shall be provided so as to prevent a motor vehicle from striking a parked bicycle.

- (2) <u>Residential Uses</u>. Neither bicycle racks nor bicycle lockers are required for bicycle parking associated with residential uses. Required bicycle parking for residential uses may be provided in garages, storage rooms, or any other resident-accessible, secure areas.
- (h) <u>Bike Locker</u>. As used in this section, "bike locker" means a locker or storage space large enough to house a single bicycle and which may be secured and accessed by a single user.

WHEREAS, at the November 16, 2020 meeting of Sylvania City Council, legislation was ordered to provide for three full-time Police Division Clerks to staff the Police Department from 8:00 a.m. – 8:00 p.m.

125.02 DIVISION OF POLICE.

The Chief of the Division of Police, to be called the Chief of Police, shall, under the Director of Public Safety, have exclusive control of the stationing and transfer of all police officers and other officers and employees constituting the police force, under such rules and regulations as the Director may promulgate from time to time. The Chief of Police shall have a police secretary whose duties he shall assign within the Division. The police force shall be composed of a Chief of the Division of Police; two captains, who shall be directed by and answerable to the Chief; six sergeants, who shall be answerable to and assigned by the Chief: twenty-six police officers and/or cadets, who shall be answerable to and assigned duties by the Chief of Police; five telecommunicators until the effective date of the Lucas County 911 Dispatch Consolidation which is expected to occur on or around September 1, 2021; two fulltime Police Division Clerks and one full-time Police Division Clerk II, from September 1, 2021 or the effective date of the Lucas County 911 Dispatch Consolidation, all of whom shall be answerable to and assigned duties by the Chief of Police; and such additional personnel, both full-time and part-time as Council shall hereafter authorize. The Chief of Police may set up, combine and/or abolish and assign or reassign any member of the police force to, or withdraw therefrom, any of the following sections: Office of Community Affairs; Detective Bureau; Court Officer; Property and Evidence Room; Road Patrol. In the event of an emergency, the Mayor may appoint additional police officers and other officers for temporary service during the emergency.

139.02 CONTENT AND COVERAGE OF THE COMPENSATION PLAN.

(a) Classes in the Plan. The Classification Plan shall consist of the classes listed in this section, with such changes from time to time as may be recommended by the Treasurer and approved by Council. All positions in each class shall be compensated in accordance with the class grade for each class as shown in this section and at the rates of pay for each class grade as set forth in Section 139.03. The salary rates as established for each class grade shall be the compensation for work of salaried employees on a normal full-time
