The Council of the City of Sylvania, Ohio met in regular session via Zoom on March 15, 2021 at 7:30 p.m. with Mayor Stough in the chair. Roll was called with the following members present: Katie Cappellini, Mark Frye, Doug Haynam, Brian McCann, Patrick Richardson, Lyndsey Stough, Mary Westphal; (7) present; (0) absent.

## **ORDINANCE NO.** <u>29</u> -2021

AMENDING THE CODIFIED ORDINANCES, 1979, AS AMENDED, BY ADDING CHAPTER 769 – MOBILE FOOD VEHICLES; AND DECLARING AN EMERGENCY.

AN EMERGENCY.
WHEREAS, the Director of Public Service has recommended that Chapter 769 be
added to the Sylvania Codified Ordinances, 1979, as amended, as set forth on the attached "Exhibit
A."
NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sylvania, Lucas
County, Ohio, members elected thereto concurring:
SECTION 1. That Chapter 769 – Mobile Food Vehicles of the Codified Ordinances of Sylvania, 1979, as amended, be and it is, hereby further amended to read as set forth on the attached "Exhibit A."
SECTION 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
SECTION 3. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City.
SECTION 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that the regulation of Mobile Food Vehicles should be enacted immediately. Provided this Ordinance receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force thirty (30) days after it is approved by the Mayor or as otherwise provided by this Charter.

# CHAPTER 769 Mobile Food Vehicles

769.01	Definitions.	769.04	Furnishing of Information.

#### 769.01 DEFINITIONS.

The following terms shall have the following meanings when used in this chapter:

- (a) The Zoning Administrator shall mean the Zoning Administrator of the City of Sylvania.(b) The Tax Administrator shall mean the Income Tax Commissioner of the City of Sylvania.
- (c) Food Establishment shall mean a business operation or any part thereof that stores, prepares, packages, serves, vends or otherwise provides food and/or beverages for human consumption.
- (d) Mobile Food Vehicle shall mean a Food Establishment that is located upon a vehicle including motorcycles and bicycles, or which is pulled by a vehicle. This definition includes mobile food kitchens, pushcart vendors, bicycle cart vendors, mobile food trucks, canteen trucks and coffee trucks.
- (e) Mobile Food Vehicle Operator shall mean any and all persons associated with the operation of a Mobile Food Vehicle for which registration has been made to operate the Mobile Food Vehicle within the City.

#### 769.02 REGISTRATION REQUIRED.

Except as provided in 769.03(c), no Mobile Food Vehicle shall be operated in the City without first registering with the Zoning Administrator. A separate registration must be made for each and every Mobile Food Vehicle to be operated within the City.

(Ord. \_\_\_\_\_\_-2021. Passed \_\_\_\_\_-2021.)

#### 769.03 APPLICATION FOR REGISTRATION.

- (a) Each Mobile Food Vehicle operator shall, prior to commencing operations within the City, furnish the Zoning Administrator, on a form provided by the City, a fully executed application for registration to operate a Mobile Food Vehicle within the City.
- (b) Applications for registrations to operate Mobile Food Vehicles will be accepted by the City Administrator each year beginning March 1.
- (c) Mobile Food Vehicles operating within the boundaries of the City, stopping, standing or otherwise parking in the public right of way for only 15 consecutive minutes or less, shall not be required to apply for registration to operate a Mobile Food Vehicle within the boundaries of the City in the public right of way.

#### 769.04 FURNISHING OF INFORMATION.

A Mobile Food Vehicle Operator, prior to commencing Mobile Food Vehicle operations within the City, shall furnish the Zoning Administrator with the following documents and information:

- (a) A current, written certification that the Mobile Food Vehicle has passed all necessary inspections required by the Sylvania Township Fire Department;
- (b) A current written certification that the Mobile Food Vehicle Operator and the Mobile Food Vehicle have passed all necessary inspections and are in full compliance with the Lucas County Health Department;
- (c) A letter of good standing from the City Income Tax Division with respect to the Mobile Food Vehicle operations; and
- (d) A current certificate of insurance evidencing general liability coverage in the minimum amount of one million dollars (\$1,000,000.00) in the aggregate in a form acceptable to the City. (Ord. -2021. Passed -2021.)

#### 769.05 PERMIT.

- (a) Each Mobile Food Vehicle Operator shall, prior to commencing operations within the City, pay an annual, nonrefundable permit fee to the Zoning Administrator in the amount of \$100.00.
- (b) The City shall, no later than 14 days after receiving (i) a fully executed application for registration to operate a Mobile Food Vehicle within the City, (ii) all other required documents and information, and (iii) an annual permit fee, issue a permit to the Mobile Food Vehicle Operator to operate the Mobile Food Vehicle within the City.
- (c) Mobile Food Vehicle permits must be on display, on the vehicle, in full sight for all to see at all times while the Mobile Food Vehicle is operating within the City.
- (d) Mobile Food Vehicle permits are specific to the Mobile Food Vehicle Operator and the Mobile Food Vehicle.
  - (e) Mobile Food Vehicle permits will automatically expire each year on December 31.
- (f) No annual permit fee shall be required of Mobile Food Vehicles or Mobile Food Vehicle Operators owned or compensated by a food establishment currently operating within the boundaries of the City, from a fixed location (i.e., from owned or leased real property), and in compliance with all other applicable, local regulations.

#### 769.06 REGULATIONS.

- (a) A mobile food vehicle shall not operate on City-owned property or within the public right-of-way unless authorized as part of a temporary special event, except that ice cream sales trucks may operate within the public right-of-way without being part of a temporary special event.
- (b) A mobile food vehicle shall not operate within 500 feet of a temporary special event, unless approved as part of a temporary special event, or any brick and mortar restaurant.
- (c) No mobile food vehicle shall operate prior to 7:00 a.m. or after 10:00 p.m. unless specifically authorized as part of a temporary special event.
- (d) All mobile food vehicles shall offer a waste container for public use that the operator shall empty at his or her own expense and not into any City-owned waste container.
- (e) The City reserves the right to relocate a mobile food vehicle to an alternate location as determined by the Director of Public Safety and/or the Chief of Police or their designee if the approved location needs to be used for emergency purposes or other public benefit.
- (f) The operation of the mobile food vehicles shall at all times be in compliance with all applicable governmental rules and regulations including, but not limited to those of the Lucas County Health Department and the State of Ohio.

(g) The Sylvania Township Fire Department may inspect mobile food vehicles at any time to ensure compliance with all applicable Federal, State and local fire safety statutes, regulations, ordinances and codes.  (Ord2021. Passed2021.)
769.07 ENFORCEMENT AND PENALTY.  In the case of a failure by any Mobile Food Vehicle Operator to comply with any of the provisions of this chapter, such Mobile Food Vehicle Operator shall be in violation and shall be subject to a penalty.
(a) The provisions of this section shall be enforceable by the Sylvania Police Division.  (b) A penalty in the amount of one hundred dollars (\$100.00) shall be assessed and immediately payable for failure to comply with any of the provisions of this chapter. A separate offense shall be deemed committed each day, or part thereof, for which a Mobile Food Vehicle Operator fails to comply with any of the provisions of this chapter. Any and all penalties are in addition to the annual permit fee.
<ul> <li>(c) No penalty shall be imposed under this chapter with respect to any failure if it is shown that such failure is due to reasonable cause and not to willful neglect.</li> <li>(d) Upon discovery of the violation, the Mobile Food Vehicle operator shall be served with notice of violation and demand for penalty in the same manner as a fine. Upon service with the notice of violation, the Mobile Food Vehicle operator shall immediately cease operations within the City of Sylvania until such time as the Mobile Food Vehicle operator is issued a valid permit for operations.</li> <li>(e) No Mobile Food Vehicle Operator shall be permitted to operate a Mobile Food Vehicle within the City for any year in which it has been assessed penalties under this chapter on more than two occasions.</li> </ul>

#### **ORDINANCE NO. 30 -2021**

APPROVING THE THIRD AMENDMENT TO REAL ESTATE PURCHASE AGREEMENT OF FIRST BROOKSIDE, LLC TO PURCHASE THE CITY'S REAL ESTATE LOCATED AT 5705-5711 NORTH MAIN STREET, SYLVANIA, OHIO; AUTHORIZING THE MAYOR AND THE DIRECTOR OF FINANCE TO ACCEPT SAID THIRD AMENDMENT TO REAL ESTATE PURCHASE AGREEMENT ON BEHALF OF THE CITY OF SYLVANIA; DETERMINING SAID REAL ESTATE TO BE NO LONGER NEEDED FOR MUNICIPAL PURPOSES; AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance No. 48-2020, passed by Sylvania City Council on August 17, 2020, approved the Offer to Purchase of First Brookside, LLC for its property commonly known as 5705-5711 North Main Street, Sylvania, Ohio at a sales price of \$200,000; and,

WHEREAS, during the diligence period, a survey issue was identified relative to a gap parcel at the easterly boundary line of the property, and in lieu of waiting until that issue can be resolved by either a quiet title action or obtaining deeds from the prior owners' heirs, the Buyer has proposed that they will accept the title to the property "as is" and assume the responsibility for the quiet title action in exchange for a \$20,000 credit on the purchase price; and,

WHEREAS, First Brookside, LLC has submitted a Third Amendment to Real Estate

Purchase Agreement to purchase said real estate located at 5705-5711 N. Main St., from the City

of Sylvania for a total purchase price of One Hundred Eighty Thousand Dollars (\$180,000.00),

which Third Amendment to Real Estate Purchase Agreement is now on file with the Clerk of this

Council.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, \_\_\_\_\_ members elected thereto concurring:

SECTION 1. That this Council hereby finds and determines that the real estate known as 5705-5711 N. Main St. is no longer needed for any municipal purpose.

SECTION 2. That the Third Amendment to Real Estate Purchase Agreement, submitted by First Brookside, LLC in the amount of One Hundred Eighty Thousand Dollars

(\$180,00.00) for the purchase of 5705-5711 N. Main St. is hereby approved and the Mayor and Director of Finance be, and they hereby are, authorized to accept said Offer to Purchase on behalf of this City.

- SECTION 3. #### **RESOLUTION NO.** 5 -2021

A RESOLUTION OF THE COUNCIL OF THE CITY OF SYLVANIA JOINING THE TOLEDO REGIONAL CHAMBER OF COMMERCE IN STRONGLY URGING THE UNITED STATES POSTAL SERVICE ("USPS") TO CONSIDER RETURNING MAIL PROCESSING OPERATIONS TO ITS SORTING FACILITY IN TOLEDO, OHIO; AND DECLARING AN EMERGENCY.

WHEREAS, our residents and businesses rely on prompt mail for important everyday transactions like sending invoices, paying bills, receiving medications, and shipping of critical supplies; and,

WHEREAS, complaints of untimely mail delivery have persisted in Northwest Ohio since USPS transferred sorting operations from the Toledo processing facility to the Michigan Metroplex Facility in 2012; and,

WHEREAS, in a survey of its member businesses conducted in 2020 by the Toledo Regional Chamber of Commerce, more than 70 percent of respondents indicated that delays in USPS mail delivery were negatively impacting them and their customers; and,

WHEREAS, in a follow-up survey of its members conducted in March of 2021, that number increased to 100 percent, with respondents indicating the specific consequences of USPS mail delivery delays to their businesses; and,

WHEREAS, in that most recent survey 94 percent of respondents cited late payment of bills or invoices, 12 percent experienced disruptions to supply chains, and 36 percent received unfavorable customer reviews; and,

WHEREAS, businesses being negatively impacted are among our region's smallest employers, with nearly two-thirds of the survey respondents employing fewer than 50 employees, and 34 percent employing fewer than 10 employees; and,

WHEREAS, our residents and businesses deserve confidence that their mail will be delivered reliably and consistently as our region continues on its path to economic recovery. NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Sylvania, Lucas County, Ohio, members elected thereto concurring: SECTION 1. That the City of Sylvania strongly urges the USPS to consider restoring mail sorting services to the Toledo processing facility as USPS evaluates operational changes to improve mail services for our residents and businesses. SECTION 2. That the Clerk of Council is hereby directed to forward a certified copy of this Resolution to the Postmaster General, USPS Board of Governors, Senator Rob Portman, Senator Sherrod Brown, and Representative Bob Latta. SECTION 3. It is hereby found and determined that for all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code. SECTION 4. That the Clerk of Council is hereby directed to post a copy of this Resolution in the office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12 of the Charter of this City. SECTION 5. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that the Council of the City of Sylvania wishes to make its support of returning mail processing operations to its sorting facility in Toledo and therefore this Resolution should be made effective immediately. Provided this Resolution receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force thirty (30) days after it is approved by the Mayor or as otherwise provided by the Charter.
