Minutes of the Meeting of Council June 21, 2021

The Council of the City of Sylvania, Ohio met in regular session on June 7, 2021 at 7:30 p.m. with Mayor Stough in the chair. Roll was called with the following members present: Katie Cappellini, Mark Frye, Doug Haynam, Brian McCann, Patrick Richardson, Mary Westphal, Lyndsey Stough; (7) present; (0) absent.

Roll call: All present.

Pledge of Allegiance to the United States of America led by Mr. Frye.

Pledge of Allegiance.

Mayor Stough stated that Council will now consider agenda item 3.

Mr. Frye moved, Mr. Haynam seconded to approve the agenda; roll call vote being: Cappellini, Frye, Haynam, McCann, Stough, Richardson, Westphal; (7) yeas; (0) nays. The motion carried.

Agenda approval.

Mayor Stough stated that Council will now consider agenda item 4.

Mr. Frye presented the June 7, 2021 meeting minutes. Mr. Frye moved, Ms. Stough seconded, that since the Mayor, members of Council, and others had been furnished copies of these minutes prior to this meeting, Council dispense with the reading of these minutes at this time, and the journal of the minutes of the regular meeting of June 7, 2021 be approved; roll call vote being: Frye, Haynam, McCann, Richardson, Westphal, Stough, Cappellini, (7) yeas; (0) nays. The motion carried.

Mayor Stough stated that Council will now consider agenda item 5.

Mr. Sanford spoke on behalf of the Sylvania CIC and introduced Senator Theresa Gavarone, Jeff Clegg-CIC President, Oliver Turner-Township Administrator and other CIC members. Mr. Sanford provided recognition for her support to Sylvania. Senator Gavarone spoke and thanked the CIC for the award.

Mayor Stough stated that Council will now consider agenda item 6.

Service Director's report on the Harroun Park River Trail Bioretention & Stream Restoration Project was placed on file. Mrs. Cappellini presented and read aloud by title only, proposed Ordinance No. 49-2021, a written copy of same having been previously furnished to each member of Council, "Authorizing the Mayor and Director of Finance to approve and accept the amendment to the proposal of Civil & Environmental Consultants, Inc. for the Design-Build Services for the Harroun Park River Trail Bioretention and Stream Restoration Project; appropriating funds therefore in the amount of \$11,000; and declaring an emergency."; Mrs. Cappellini moved, Mr. Haynam seconded for passage of Ordinance No. 49-2021 as an emergency measure.; roll call vote being: Haynam, McCann, Richardson, Stough, Westphal, Cappellini, Frye, (7) yeas; (0) nays. The motion carried.

Ordinance No. 49-2021, "Authorizing amendment to Design-Build Svcs for Harroun Park River Trail Bioretention & Stream Restoration Project..."

Mayor Stough stated that Council will now consider agenda item 7.

Service Director Aller provided various options for the Cushman Road Swale/Drainage issues. Mayor Stough discussed options and recommended Option #2, which installs an 8-inch solid wall corrugated plastic pipe in the bottom of existing swale and through existing drive tiles, backfills as necessary and connect existing drainage pipes and sump pump discharges. Install 6-inch perforated corrugated plastic pipe to provide drainage for the road pavement and connections. Fill the swale with sand and topsoil to ground grade and reseed. Project cost proposal of \$172,835.81.

Cushman Rd. Swale/Drainage issue resolution.

Mr. Frye moved, Mr. Haynam seconded to authorize payment to proceed with Option #2 at the City's expense. Roll call vote being: McCann, Richardson, Stough, Westphal, Cappellini, Frye, Haynam, (7) yeas; (0) nays. The motion carried.

Council has received a petition for speed humps for Cushman Road. Law Director Brinning presented the process and next steps. Mr. Aller stated the traffic count process is now in place. Post cards will be sent to begin the process. Mrs. Westphal moved, Mr. Frye seconded to refer this matter to the Streets Committee for review. Roll call vote being: Richardson, Stough, Westphal, Cappellini, Frye, Haynam, McCann, (7) yeas; (0) nays. The motion carried. Mayor Stough asked the police department for speed checks.

Mrs. Westphal moved, Mr. McCann seconded for passage of Resolution No. 7-2021 as an emergency measure; roll call vote being: Stough, Westphal, Cappellini, Frye, Haynam, McCann, Richardson, (7) yeas; (0) nays. ORDINANCE NO. 46-2021

APPROVING THE INCLUSION OF LUCAS COUNTY AS A MEMBER OF THE TOLEDO AREA REGIONAL TRANSIT AUTHORITY; AND DECLARING AN EMERGENCY.

WHEREAS, the Toledo Area Regional Transit Authority ("TARTA") exists as a political subdivision under the laws of the State of Ohio and is operated in the following jurisdictions (Member Communities): the City of Toledo, the City of Maumee, the City of Sylvania, the City of Rossford, the Village of Ottawa Hills, the City of Waterville and the Township of Sylvania; and,

WHEREAS, TARTA provides transit services within the areas of the Member

Communities which are within portions of Lucas County, Ohio and Wood County, Ohio; and,

WHEREAS, TARTA currently derives funding from two ad valorem property taxes (one 1.0 mill levy and one 1.5 mill levy) for a total of 2.5 mills paid by the property owners within the area of TARTA; and,

WHEREAS, several other Regional Transit Authorities in Ohio utilize a sales and use tax to fund operations, which funding system is viewed as a preferable method of funding because it is paid by nonresidents as well as residents; and,

WHEREAS, the Board of Lucas County Commissioners established a community task force comprised of a broad cross section of leaders throughout the region to assess the state of public transportation in and around Lucas County; and,

WHEREAS, in August of 2019, the final report of the task force, entitled Community

Task Force: Public Transportation in Northwest Ohio, was issued and it recommended that

Lucas County should be invited to become a member of TARTA and that a 0.5% sales tax levy

be proposed to replace the inefficient property taxes; and,

WHEREAS, a sales and use tax funding system requires the addition of Lucas County as one of TARTA's Member Communities; and,

WHEREAS, the Board of Trustees of TARTA has approved a resolution directing its

Chief Executive Officer to develop a plan for a new organizational and funding structure that
would: (1) expand mass transit service throughout Lucas County by adding Lucas County as a
member of TARTA; (2) eliminate the current 2.5 mill property tax levies and substitute a 0.5%
sales and use tax; and (3) allocate monies from the sales and use tax collected to TARTA to
directly fund its operations and allocate monies from the sales and use tax collected to other local
governmental entities for the installation, maintenance and improvement of mass transit related
infrastructure; and,

WHEREAS, the Board of Trustees of TARTA's resolution directing its Chief Executive Officer to develop a plan for a new organizational and funding provided that if Lucas County is added as a member of TARTA, the Board of Trustees will amend its composition to reflect its expanded geographical boundaries, as follows: four members, who shall have terms of three years, shall be appointed by the Mayor of the City of Toledo, with the advice and consent of the Council of the City of Toledo; three members, who shall have terms of three years, shall be appointed by the Board of County Commissioners for Lucas County; one member, who shall have a term of three years, shall be appointed by the City of Maumee, with the advice and consent of the Council of the City of Maumee; one member, who shall have a term of three years, shall be appointed by the Mayor of the Village of Ottawa Hills, with the advice and consent of the Council of the Village; one member, who shall have a term of three years, shall be appointed by the Mayor the City of

Rossford, with the advice and consent of the Council of the City of Rossford; one member, who shall have a term of three years, shall be appointed by the Mayor of the City of Sylvania, with the advice and consent of the Council of the City of Sylvania; one member, who shall have a term of three years, shall be appointed by the Board of Trustees of Sylvania Township; and one member, who shall have a term of three years, shall be appointed by the Mayor of the City of Waterville, with the advice and consent of the Council of the City of Waterville; and,

WHEREAS, the Board of Trustees of TARTA's resolution directing its Chief Executive Officer to develop a plan for a new organizational and funding provided that if the current 2.5 mill property tax levies are replaced with a 0.5% sales and use tax, the monies derived therefrom will be utilized in accordance with Ohio Revised Code Section 306.35, and after application of Section 306.322, certain of these sums collected are to be expended for public infrastructure projects to assist other local governmental entities in the TARTA service area in funding installation, maintenance and improvement of transit related infrastructure so that the roads, sidewalks, bridges, bus stops, bus shelters, signage and associated improvements are adequate to allow TARTA to operate its vehicles and serve its passengers in the Member Communities, with annual payments as follows: City of Toledo \$300,000; City of Maumee \$90,000; Village of Ottawa Hills \$90,000; City of Rossford \$90,000; City of Sylvania \$90,000; Sylvania Township \$90,000 and City of Waterville \$90,000; and,

WHEREAS, the proposed changes first require the Lucas County Board of County

Commissioners to adopt a resolution or ordinance proposing that Lucas County join TARTA

without a time limit on the County's membership, and to then submit a copy of its resolution or

ordinance to the governing body of each political subdivision comprising TARTA; and,

WHEREAS, if a majority of the governing bodies of the political subdivisions comprising TARTA, within 30 days of receiving the copy of the Lucas County Board of County Commissioners' resolution or ordinance proposing to join TARTA, adopt a resolution or ordinance approving the inclusion of Lucas County as a member of TARTA without a time limit on the County's membership, TARTA's Board of Trustees may adopt a resolution to submit to the electors of TARTA, as it would be enlarged by the inclusion of Lucas County, the question of including Lucas County in TARTA, of levying a sales and use tax under R.C. 5739.23 and 5741.022 throughout TARTA's territorial boundaries as so enlarged, and of repealing the two property taxes currently levied by TARTA under R.C. 306.49; and,

WHEREAS, if a majority of the governing bodies of the political subdivisions comprising TARTA adopt a resolution or ordinance approving the inclusion of Lucas County as a member of TARTA without a time limit on the County's membership, the Board of Trustees of TARTA intends to proceed to submit to the electors of TARTA, as it would be enlarged by the inclusion of Lucas County, the question of including Lucas County in TARTA, of levying a 0.5% sales and use tax under R.C. 5739.23 and 5741.022 throughout TARTA's territorial boundaries as so enlarged for a period of ten years, and of repealing the two property taxes currently levied by TARTA under R.C. 306.49 at the November 2, 2021 General Election; and,

WHEREAS, at the June 7, 2021 meeting of Sylvania City Council, this ordinance was referred to the Committee-of-the-Whole for its review and recommendation; and,

WHEREAS, the Committee-of-the-Whole met on June 21, 2021 and recommended approval of the proposed legislation thereafter, at the Council meeting on June 21, 2021, the Director of Law was directed and authorized to prepare legislation approving the inclusion of

Lucas County as a member of TARTA; and,

WHEREAS, the Board of Lucas County Commissioners approved a resolution on June 30, 2021 proposing that Lucas County join TARTA without a time limit as to the County's membership and submitted to this Council a copy of the County Commissioners' resolution on July 1, 2021.

NOW, THEREFORE BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, _____ members elected thereto concurring:

- SECTION 1. That the Council of the City of Sylvania approves the Board of Lucas County Commissioners' proposal that Lucas County join TARTA as a member without a time limit.
- SECTION 2. This Council gives approval to TARTA to repeal the two property taxes currently levied and to levy a sales and use tax at a rate of up to 0.5%.
- SECTION 3. This Council hereby authorizes the Clerk of Council to promptly take all actions necessary to promptly present this Ordinance to the Board of Trustees of TARTA in time for it to adopt a resolution to submit to the electors of TARTA, as it would be enlarged by the inclusion of Lucas County, the question of including Lucas County in TARTA, of levying a sales and use tax at a rate of up to 0.5% under R.C. 5739.23 and 5741.022 throughout TARTA's territorial boundaries as so enlarged for a period of ten years, and of repealing the two property taxes currently levied by TARTA under R.C. 306.49 at the November 2, 2021 General Election.
- SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- SECTION 4. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City.
- SECTION 5. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that it is necessary to inform the Board of Trustees of TARTA of this Council's approval of the Board of Lucas County Commissioners' proposal in time for the TARTA Board of Trustees to submit the above-described question to the electors within TARTA's territorial boundaries, as would be enlarged by the inclusion of Lucas County, at the November 2, 2021 General Election at the earliest possible time, and therefore, this Ordinance should be effective immediately. Provided this Ordinance receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force thirty (30) days

after it is approved by the Mayor or as of	therwise provided by the Charter.

SECOND AMENDMENT TO WATER TOWER ATTACHMENT LEASE AGREEMENT

THIS SECOND AMENDMENT TO WATER TOWER ATTACHMENT LEASE AGREEMENT ("Second Amendment") is made and entered into on _______, 2021 ("Effective Date"), by and between City of Sylvania, Ohio, an Ohio municipal corporation ("Landlord"), and T-Mobile Central LLC, a Delaware limited liability company ("Tenant").

Recitals

The parties hereto recite, declare and agree as follows:

- A. Landlord and Tenant entered into a Water Tower Attachment Lease Agreement (the "Lease"), dated October 5, 2001, which was subsequently amended with the First Amendment to Water Tower Attachment Lease Agreement on May 2, 2008(collectively, the "Lease") for antenna facilities located at 6850 Maplewood Ave., Sylvania, OH 43560(the "Premises").
- B. Landlord and Tenant desire to enter into this Second Amendment in order to modify and amend certain provisions of the Lease.

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Landlord and Tenant covenant and agree as follows:

- 1. <u>Landlord Consent</u>. Landlord hereby grants Tenant the right and consents to Tenant's expansion of the Premises and the installation of Hardening Construction Drawings as described and depicted on Exhibit "B-2", which is attached hereto and by this reference incorporated herein, which equipment shall be considered part of the "Antenna Facilities" under the Lease. The installation, as depicted in the Construction Drawings on Exhibit "B-2" constitutes the entire Premises under the Lease. B-2 shall be incorporated to modify the original Exhibit A.
- 2. Rent and Costs. The Rent that Tenant pays Landlord will be increased by Fifty Dollars (\$50) per month as of January 1, 2022. Thereafter, Rent, shall be payable in accordance with the terms of the Lease per the following schedule.

January 1, 2022	\$3,566.66/month
January 1, 2023	\$3,744.99/month
January 1, 2024	\$3,932.24/month
January 1, 2025	\$4,128.85/month
January 1, 2026	\$4,335.30/month
January 1, 2027	\$4,552.06/month

The parties hereby agree that, as of the date of this Second Amendment, there are no payment obligations of Tenant under the Lease, including but not limited to the payment of Rent, or other costs or fees, that are overdue.

To the extent there is any conflict between the terms and conditions of the Lease and this Second Amendment, the terms and conditions of this Second Amendment will govern and control.

Landlord represents and warrants to Tenant that the consent or approval of no third party, including, without limitation, a lender, is required with respect to the execution of this Second Amendment, or if any such third party consent or approval is required, Landlord has obtained any and all such consents or approvals.

Dear Mr. Mayor and City Council Members:

As discussed during recent Utilities and Environment Committee meetings we have been in discussions with Republic Services regarding the extension of our existing collection services contract in lieu of advertising for outside proposals.

Those discussions have resulted in the following agreed upon items.

- 1. Republic will provide approximately 6,000 carts(95-gallon) for refuse collection.
- The recycling collection schedule will change so that one half of the City is collected each week. (52week collection schedule vs. current 26-week collection schedule)
- 3. The cost for refuse and recycling collection will be \$11.68 per unit per month through September 1, 2022.
 - a. The existing fee of \$0.81 per unit per month for unlimited collection remains and will be billed separately at the time of the two events(typically May and October).
- 4. The above fee structure will increase three percent (3%) annually on September 1.
- 5. The contract will be extended through September 1, 2026.

We are working with Republic Services representatives to coordinate recycling collection to our existing Green Yard Waste collection schedules. We are also planning public information pieces for direct mailing, utility bill inserts, media notices, etc. to inform our residents of the upcoming changes.

Due to cart delivery and distribution schedules we are aiming for an October 1 transition to the new service. Republic Services has provided good services to the City for several years and we would recommend that the amendments to the existing agreement be approved.

WHEREAS, Ordinance No. 53-2006, passed June 5, 2006, determined that the lowest and best bid for collection and disposal of residential refuse was that of Allied Waste Services and awarded the contract for the same to them; and,

WHEREAS, Ordinance No. 54-2006, passed June 5, 2006, accepted the bid of Allied Waste Services and authorized the Mayor and Director of Finance to enter into a contract pursuant to the lowest and best bid for the curbside recycling collection and disposal contract, and Chapter 943 of the Codified Ordinances of Sylvania, 1979, as amended; and,

WHEREAS, Ordinance No. 33-2009, passed May 4, 2009, accepted the proposal of Allied Waste Services to provide residential curbside refuse collection for a one-year term; and,

WHEREAS, Ordinance No. 38-2009, passed May 4, 2009, accepted the proposal of Allied Waste Services to provide residential curbside recycling collection for a one-year term; and,

WHEREAS, Ordinance No. 69-2010, passed July 19, 2010, accepted the bid of Allied Waste Services to provide residential curbside refuse collection for a three-year term; and,

WHEREAS, Ordinance No. 70-2010, passed July 19, 2010, accepted the bid of Allied Waste Services to provide residential curbside recycling collection for a three-year term; and,

WHEREAS, Ordinance No. 67-2012, passed December 3, 2012, accepted the proposal of Allied Waste Services to provide residential curbside recycling collection for a three-year term; and,

WHEREAS, Ordinance No. 68-2012, passed December 3, 2012, accepted the proposal of.

Allied Waste Services to provide residential refuse collection for a three-year term; and,

WHEREAS, Ordinance No. 38-2016, passed August 15, 2016, accepted the bid of Allied Waste Services of North America to provide residential refuse and recycling collection for a five-year term with one five-year renewal; and,

WHEREAS, the City's contract with Allied Waste, now known as Republic Services, expires on August 31, 2021, however, the contract entered into in 2016 provides for one five-year renewal; and,

WHEREAS, the Utilities and Environment Committee met on March 22, 2021 and June 7, 2021 to discuss amendments to the Sylvania Codified Ordinances and also various options for handling residential refuse and recycling in the City and thereafter recommended that the City's contract with Republic Services be extended for an additional five years; and,

WHEREAS, the Director of Public Service, by report dated July 19, 2021 has recommended acceptance of the proposal of Republic Services which will include the following:

1. Republic will provide approximately 6,000 95-gallon carts for refuse collection; 2. The recycling collection schedule will be modified to collect half of the City each week; 3. The cost for residential refuse and recycling collection will be \$11.68 per unit, per month through September 1, 2022, and will increase 3% annually on September 1 each year thereafter through August 31, 2026.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sylvania, Lucas

County, Ohio, ______ members elected thereto concurring:

SECTION 1. That the proposal of Republic Services, for a five-year extension of the existing contract commencing September 1, 2021 and ending August 31, 2026, for the collection and disposal of City of Sylvania, Ohio residential refuse and recycling, under the same terms and conditions as set forth in the contract approved in 2016, subject to the following additional terms: 1. Republic will provide approximately 6,000 95-gallon carts for refuse collection; 2. The

recycling collection schedule will change so that one-half of the City is collected each week (52-week collection schedule vs. 26-week collection schedule); 3. The cost for refuse and recycling collection will be Eleven and 68/100 Dollars (\$11.68) per unit, per month, for the September 1, 2021 through August 31, 2022 term and thereafter, the rate shall be increased by three percent (3%) annually on September 1, 2022, September 1, 2023, September 1, 2024, and September 1, 2025, all as set forth in the proposal hereby accepted; 3. The existing fee of \$0.81 per unit, per month for unlimited collection remains and will be billed separately at the time of the two events (typically May and October); and the Mayor and Director of Finance are hereby authorized to enter into a contract with Republic Services whose proposal is hereby accepted for the combined refuse and recycling collection and disposal, pursuant to said proposal, the collection and disposal contract specifications, the provisions of Chapter 941 of the Codified Ordinances of Sylvania, 1979, as amended, and containing such the provisions as the Mayor, Director of Finance and Director of Law shall require, which contract shall be substantially in the form and substance of the refuse and recycling collection and disposal contract currently on file with the Clerk of Council.

SECTION 2. That the monthly payment under such residential refuse collection and disposal contract authorized by this Ordinance shall be charged to **Account No. 110-7515-51265** - **Refuse Collection and Disposal**.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

This change order request contains costs to perform work not included in the original contract documents for the project per Council's approval of Option 2 in the Service Department memo dated June 21, 2021. As a reminder, this work consists of 8-inch solid wall corrugated plastic pipe in the bottom of the existing swale and through existing drive tiles, backfill as necessary to support the pipe, and connect the existing drainage pipes and sump pump discharges to this pipe. Install 4-inch perforated corrugated plastic pipe to provide drainage for the road pavement and connect this pipe to the solid wall pipe at various locations for conveyance to existing outlets. Fill the swale with sand and topsoil to ground grade and reseed.

The project contractor, Salenbien Excavating, has provided a total cost of \$172,835.81 to perform this work per the attached schedule. We are requesting approval of Change Order No. 1 to allow this work to move forward. It is anticipated that the work will begin three to four weeks from approval based on material delivery.

WHEREAS, after reviewing the options presented by the Director of Public Service, Sylvania City Council authorized moving forward with Option 2 in the Service Director's Memo of June 21, 2021, which provides for installing an 8-inch diameter closed drainage pipe coupled with a 4-inch perforated drainage pipe with a filter sock laid in the bottom of the swale, stone backfill as required and dirt backfill to grade; and,

WHEREAS, the Director of Public Service, by report dated July 19, 2021, has requested approval of Change Order No. 1 of Salenbien Trucking and Excavating, Inc. for said Cushman

Road Project to perform the additional work requested on the project; and,

- (1) Tea house facilities shall be located only on the thoroughfares of Main Street, Summit Street, Brint Road, McCord Road, Erie Street, Harroun Road and Monroe Street west of US23;
- (2) The hours of operation shall be as specified in the Special Use Permit as approved by Sylvania City Council;
- (3) Required food licensing shall be as set forth in the Ohio Revised Code;
- (4) Each facility shall have the following safety items:
 - (a) Smoke alarms in each unit;
 - (b) Two fire extinguishers which shall be "abc" rating and one shall be located in the kitchen and one shall be located at the main entrance/exit:
 - (c) First-aid kit;
 - (d) Emergency lighting and/or other safety devices as recommended by the Fire Chief.
- (5) Failure to comply with these conditions, the Ohio Revised Code, the State Health Department or other such agencies shall be cause for repeal of the Special Use Permit.
