

The construction plans and specifications for the above referenced project are complete and the Service Department is anticipating receiving Federal authorization to proceed ahead with the advertising and bidding phase of the project this month.

Dear Mr. Mayor and Council Members:

On May 6, 2019 City Council authorized the Service Department to enter into an agreement with Tetra Tech to provide engineering services for LUC-Monroe St & Silica Dr Upgrd (Part I – PID 107489) project (Ord. 38-2019). This project is improving the intersection of Monroe Street & Silica Drive and widening Monroe Street to two eastbound through lanes between Silica Drive and Main Street. Construction plans were completed in November 2022. The cost of the contract was \$335,973. This contract was modified on October 4, 2021 (Ord. 67-2021) with an increase of \$63,765 because of additional retaining wall design.

With design engineering complete the Service Department requested a proposal from Tetra Tech to provide engineering support during construction. The anticipated services to be rendered by Tetra Tech during construction consist of bidding assistance, responses to contractor's request for information, shop drawing review, and the preparation of record drawings once the project is complete. The engineering support proposal received from Tetra Tech is in the amount of \$17,101.

This was an anticipated cost and funds are available in the 2022 capital improvement budget for this project from account number 401-7610-53503. We would recommend approval of the proposal from Tetra Tech in the amount of \$17,101. Please call if you should have any questions.

ACCEPTING THE PROPOSAL OF TETRA TECH TO PROVIDE ENGINEERING SERVICES FOR THE MONROE & SILICA INTERSECTION IMPROVEMENT PROJECT; APPROPRIATING FUNDS THEREFORE IN THE AMOUNT OF \$17,101; AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance No. 38-2019, passed May 6, 2019, authorized the Mayor and Director of Finance to enter into an Agreement with Tetra Tech to provide engineering services for the Monroe & Silica Intersection Improvement Project; and,

WHEREAS, the project is improving the intersection of Monroe Street & Silica Drive and widening Monroe Street to two eastbound through lanes between Silica Drive and Main Street; and,

WHEREAS, the design engineering is now complete and the Director of Public Service, by report dated December 5, 2022, has requested a proposal from Tetra Tech to provide engineering support during construction; and,

WHEREAS, the proposal includes bidding assistance, response to contractors' requests for information, shop drawing review and preparation of record drawings upon project completion; and,

WHEREAS, the Director of Public Service, in a report dated December 5, 2022, has recommended that the proposal of Tetra Tech to provide engineering services during construction at a cost of Seventeen Thousand One Hundred One Dollars (\$17,101.00), be accepted.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, _____ members elected thereto concurring:

SECTION 1. That the proposal of Tetra Tech in the amount of Seventeen Thousand One Hundred One Dollars (\$17,101.00) for providing engineering support services during construction for the Monroe Street & Silica Drive Intersection Improvement Project, is hereby accepted.

SECTION 2. That the Director of Public Service shall promptly give notice to said engineers to proceed under the proposal hereby approved and accepted.



SECTION 4. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City.

SECTION 6. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that the City should provide for engineering support services during the Monroe & Silica Intersection Improvement Project at the earliest possible time. LUC-Monroe & Silica (PID 107489) & LUC-Silica Drive Bridge Replacement (PID 111563)

Dear Mr. Mayor and Council Members:

On October 17th the Service Department requested Council authorization (Ord. 93-2022) for permission to file a Petition for Appropriation for Parcel 32 (Emro Marketing Company). This parcel is located at 6605 Monroe Street and is the Speedway Gas Station at the southwest corner of Monroe Street and Main Street. The Service Department needed a temporary construction easement to replace the Monroe Street driveway approach, install new sidewalk, and for grading purposes. Discussions with the property owner had been limited and the Service Department needed to certify control of the right-of-way by November 15th.

Since the Council meeting the Service Department was able to obtain a Right of Entry Agreement on November 10th which allowed the certification of right-of-way to move forward ahead of the deadline. In addition, the Service Department and owner agreed on the temporary construction easement request in the amount of \$4,200 on November 28th. As a result, the need to file a Petition to Appropriate is no longer required. Further discussions are ongoing to remove the monument sign encroachment from the existing right-of-way and will be brought to the appropriate Board of Architectural Review meeting for their consideration.

We would request approval of the temporary construction easement in the amount of \$4,200 with Emro Marketing Company, a Delaware Corporation, now known as Speedway LLC. Procurement of this easement was a known project expense and was included in the 2022 capital improvement budget. Funds are available from account number 401-7610-53503. To have and to hold the temporary easement(s), for the aforesaid purposes and for the anticipated period of time described below, unto the Grantee, its successors and assigns.

The duration of the temporary easement(s) granted to the Grantee is 24 months immediately following the date on which the work described above is first commenced by the Grantee, or its duly authorized employees, agents, and contractors.

The temporary easement(s) interest granted is being acquired by Grantee for a public purpose, namely the establishment, construction, reconstruction, widening, repair or maintenance of a public road.

It is further understood and agreed that Grantee and/or its contractor shall provide Grantor with no less than 48 hours' prior notice when the access point on Monroe Street is to be completely closed off. The closing of such access point will prevent Grantor's fuel transport from entering the site, and in being provided with such advance notice, Grantor can coordinate its fuel delivery accordingly. Grantee shall completely close such access point for a period not to exceed 24 hours. In constructing such access points, Grantee and/or its contractors shall use QC-MS concrete, which will allow such access points to be reopened in 24 hours. 

West Erie's proposal made assumptions based on a review of the Preliminary R/W plans including the estimated number of parcels to acquire with respect to project management, title reports, appraisals, negotiations, closings, document recordings, and mortgage releases. Their approved contact amount was \$95,250.

Now that the right-of-way acquisition phase is nearing completion, the actual number of parcels acquired has been determined and an adjustment to their contract amount is necessary. 

The construction plans for both the roadway widening and intersection improvements project (PID 107489) and bridge replacement project (PID 111563) have reached the Plans, Specifications, and Estimate (PS&E) level of plan development. The final right-of-way plans have been submitted and the City was authorized to begin the right-of-way acquisition phase of the project on February 18, 2022. As a reminder, construction is scheduled to begin in March 2023.

In order to accommodate the roadway improvements, the Service Department needs to obtain a temporary construction easement from the Pennsylvania Lines LLC, now known as the Norfolk Southern Railway Company (Ownership 23 in the Right-of-Way Plan on file with the Service Department). The easement allows the City the right to enter and complete the necessary scope of work over a 24-month period including utility installations, pavement, curbing, and sidewalk work.

The City has reached an agreement with the owner in consideration of \$6,530. Procurement of this easement was a known project expense and was included in the 2022 capital improvement budget. Funds are available and allocated from account number 401-7610-53503.

ORDINANCE NO. <u>107</u>-2022

ACCEPTING A TEMPORARY CONSTRUCTION EASEMENT FROM PENNSYLVANIA LINES, LLC, n/k/a NORFOLK SOUTHERN RAILWAY COMPANY FOR THE MONROE & SILICA IMPROVEMENT PROJECT AND SILICA DRIVE BRIDGE REPLACEMENT PROJECT; DEDICATING THE TEMPORARY EASEMENT FOR PUBLIC PURPOSES; APPROPRIATING FUNDS THEREFORE IN THE AMOUNT OF \$6,530; AND DECLARING AN EMERGENCY.

WHEREAS, plans for the Monroe & Silica Improvement Project and Silica Drive Replacement Project in the City of Sylvania, Ohio have been completed; and,

WHEREAS, the projects include roadway widening and intersection improvements and the bridge replacement and in order to accomplish these improvements, the City needs to acquire a temporary easement from Pennsylvania Lines, LLC, n/k/a Norfolk Southern Railway Company; and,

WHEREAS, Pennsylvania Lines, LLC, n/k/a Norfolk Southern Railway Company is entitled to receive payment of just compensation representing the fair market value of the temporary easement after an appraisal of those rights and they have executed and delivered a grant of temporary easement to this City for which they will be paid the sum of Six Thousand Five Hundred Thirty Dollars (\$6,530.00), a copy of which grant of temporary easement is attached hereto as "Exhibit A"; and,

WHEREAS, said grant of temporary easement is presented to this Council for acceptance and for appropriation of funds and authorization of payment thereof to the Grantor.

NOW, THEREFOR	E BE IT ORDAINED by the Council of the City of Sylvania, Lucas
County, Ohio,	members elected thereto concurring:

SECTION 1. That the temporary easement as to executed and tendered as described on "Exhibit A" be, and the same hereby is, accepted from Pennsylvania Lines, LLC, n/k/a Norfolk

Southern Railway Company, the grantor therein.

- SECTION 2. That the temporary easement area identified and described in said temporary easement as set forth on "Exhibit A" be, and the same hereby is, dedicated for the respective public purposes expresses in said temporary easement.
- SECTION 3. That the Director of Law is hereby directed to deliver the recorded temporary easement document to the Director of Finance for retention by him as custodian of the records of this City.
- SECTION 4. That, to provide funds for payment to the Grantor of said temporary easement hereby accepted, there is hereby appropriated from the CAPITAL IMPROVEMENT FUND, from funds therein not heretofore appropriated, to Account No. 401-7610-53503, Street Improvements the sum of Six Thousand Five Hundred Thirty Dollars (\$6,530.00).
- SECTION 5. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- SECTION 6. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City.
- SECTION 7. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that the improvement of should proceed as soon as possible and accordingly the acquisition of the necessary temporary easements should proceed forthwith and therefore this Ordinance should be effective immediately. Provided this Ordinance receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force thirty (30) days after it is approved by the Mayor or as otherwise provided by the Charter.
