## AMENDED - Minutes of the Meeting of Council December 19, 2022

The Council of the City of Sylvania, Ohio met in regular session on December 19, 2022 at 7:30 p.m. with Mayor Stough in the chair. Roll was called with the following members present: Mark Frye, Marcus Hansen, Doug Haynam, Brian McCann, Patrick Richardson, Lyndsey Stough, Mary Westphal; (7) present; (0) absent.

Roll call: 7 present.

Pledge of Allegiance to the United States of America led by Mr. Hansen.

Rick from DGL discussed the summary of comments from the stakeholders meeting including traffic pattern, parking, sidewalks, and mid-block crossing.
