Dear Mr. Mayor and Council Members:

On April 18, 2022 City Council was presented a proposal by DGL Consulting Engineers, LLC to provide preliminary engineering design work on the Downtown Transportation Improvements Project. Council referred this proposal to a Streets Committee meeting held on April 28, 2022 for further discussion. Council formally accepted the proposal on May 2, 2022 (Ord. 46-2022).

The DGL team has prepared several iterations of concept plans and renderings that were publicly shared at the Initial Stakeholder Meeting (August 24, 2022), at City Council (December 19, 2022), and at the public Open House (February 1, 2023). Feedback was obtained and incorporated into a final preliminary design concept that includes improved pedestrian accommodations, increased on-street parking using a curbless street concept, gathering spaces, and landscaping planters.

DGL's original proposal was in the amount of \$61,680 and they are requesting consideration of a contract modification. DGL has exceeded their original proposal by \$8,478 citing a greater complexity for field surveying work and additional traffic analysis at both intersections including alternate layouts. Their subconsultant, EDGE, exceeded their budget allocation by \$15,000, but is requesting a \$10,000 consideration mainly due to additional time spent preparing the concept video.

The total requested contract modification is \$18,478. The Service Department supports this request and believes the effort and deliverables received to complete the preliminary engineering process from this design team were very well done. We would recommend approval of the DGL contract modification in the amount of \$18,478. Please call with any questions.

AUTHORIZING THE MAYOR AND DIRECTOR OF FINANCE TO APPROVE THE AMENDMENT TO THE CITY'S AGREEMENT WITH DGL CONSULTING ENGINEERS, LLC TO REFLECT THE ACTUAL WORK PERFORMED FOR PRELIMINARY ENGINEERING SERVICES FOR THE DOWNTOWN TRANSPORTATION IMPROVEMENT PROJECT; INCREASING THE PROPOSAL AMOUNT BY \$18,478.00; APPROPRIATING FUNDS THEREFORE; AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance No. 46-2022, passed May 2, 2022, accepted the proposal of DGL Consulting Engineers, LLC (hereafter "DGL") to provide preliminary engineering design services for the Downtown Transportation Improvement Project in the amount of Sixty-One Thousand Six Hundred Eighty Dollars (\$61,680.00); and,

WHEREAS, DGL has prepared several iterations of concept plans and renderings that were publicly shared at the stakeholder meeting, City Council meeting and a public open house; and,

WHEREAS, following these meetings and based on comments received, a final preliminary design plan has been developed that includes improved pedestrian accommodations, increased on-street parking using a curbless street concept, gathering spaces and landscaping planters; and,

WHEREAS, in order to develop their plans and conduct their preliminary engineering design, DGL needed to perform additional traffic analysis at both intersections including alternate layouts in addition to more complex field surveying work resulting in an increase to the proposal of \$8,478; and,

WHEREAS, in addition, one of their subcontractors exceeded their budget allocation by \$15,000, although they have reduced their fee by \$5,000, for a total overage of \$10,000; and,

WHEREAS, the Director of Public Service, by report dated March 6, 2023, has recommended approval of the additional engineering services in the amount of \$18,478 to reflect the actual work performed in preparing the preliminary design concept for the Downtown Transportation Improvements. NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, members elected thereto concurring: SECTION 1. That said increase in the proposal in the amount of Eighteen Thousand Four Hundred Seventy-Eight Dollars (\$18,478.00), authorized to be appropriated be, and the same hereby is, approved, and the Mayor and the Director of Finance be, and they hereby are, authorized to sign said proposal amendment on behalf of this City, thereby indicating such approval and changing the total contract amount. SECTION 2. That to provide funds for said services hereby authorized, there is hereby appropriated from the CAPITAL IMPROVEMENT FUND from funds therein not heretofore appropriated to Account No. 401-7610-53503 – Street Improvements the total sum of Eighteen Thousand Four Hundred Seventy-Eight Dollars (\$18,478.00). SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code. SECTION 4. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City. SECTION 5. Dear Mr. Aller:

Please accept this fee modification to the Sylvania Downtown Improvements project. Both DGL and the EDGE Group have exceeded our original contract amounts and would appreciate your consideration for the following modification.

DGL has currently exceeded our contract amount by \$4,978. This overage is a result of greater complexity than anticipated field survey and base mapping, additional traffic analysis of the intersections and layout of alternate intersection options, the inclusion of Maplewood Avenue, and additional time for meetings. We believe the finalizing of the Study will result in an additional \$3,500. Therefore, DGL would appreciate the consideration of a \$8,478 modification to our contract.

The EDGE Group has indicated that they have exceeded their budget by \$15,000 and would be in favor of a \$10,000 modification to cover some of their overage. They realize some of their overage was due to refining the video and presentation material beyond what may normally be required for such presentations.

The total requested modification is \$18,478 (\$8,487 DGL and \$10,000 EDGE). We appreciate your consideration and hope you feel this request is appropriate.

Contract for Professional Surveying and Engineering Services

Dear Mr. Mayor and Council Members:

Balfour Road is currently served by an existing 4" and 6" cast iron waterline from Alexis Road to approximately 700 feet north of Marshall Road. The 4" main is believed to have been installed sometime between 1925 and 1952 and extends from Alexis Road to approximately 900 feet north. The 6" was extended northerly in 1952 to 700 feet north of Marshall Road.

These water mains need replaced with the southern portion along Alexis Road scheduled to be abandoned with the US-23/Monroe Street Interchange Project in 2025. The Service Department is recommending full replacement of approximately 2,600 feet of waterline with a new 8" waterline. Construction is scheduled for 2024 in advance of the Interchange Project.

The Service Department received a proposal from Tetra Tech in the amount of \$65,000 to complete the survey and design the waterline replacement. Tetra Tech is currently designing other water system improvements associated with the Interchange Project and has already obtained a portion of the necessary field work needed for the Balfour Project.

Engineering design was included in the 2023 capital improvement budget and would be funded from the 701-7525-53501 account. We would recommend approval of the proposal from Tetra Tech in the amount of \$65,000. Please call if you should have any questions.

ACCEPTING THE PROPOSAL OF TETRA TECH TO PROVIDE PROFESSIONAL ENGINEERING AND SURVEYING SERVICES FOR THE BALFOUR ROAD WATERLINE IMPROVEMENTS PROJECT; APPROPRIATING FUNDS THEREFORE IN THE AMOUNT OF \$65,000; AND DECLARING AN EMERGENCY.

WHEREAS, Balfour Road is currently served by an existing 4" and 6" cast iron waterline from Alexis Road to approximately 700 feet north of Marshall Road; and,

WHEREAS, these waterlines were installed between 1925 and 1952 and should be replaced with the southern portion along Alexis Road scheduled to be abandoned with the US23/Monroe Street Interchange Project in 2025; and,

WHEREAS, the plans for the waterline improvement project replace approximately 2,600 feet of waterline with a new 8" waterline to be installed in 2024, prior to the start of the interchange project; and,

WHEREAS, the Director of Public Service, by report dated March 6, 2023, has received a proposal from Tetra Tech to complete the survey and design the waterline replacement in the amount of Sixty-Five Thousand Dollars (\$65,000.00); and,

WHEREAS, the Director of Public Service, by report dated March 6, 2023, has recommended that the proposal in the amount of \$65,000 for the professional engineering and surveying services relative to the Balfour Road Waterline Improvement Project be accepted.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, _____ members elected thereto concurring:





The Service Department is proposing storm sewer and drainage improvements within a portion of Veteran's Memorial Field (VMF) as a part of Phase 1 improvements scheduled for the Elden Ditch Watershed.

Specifically, an underground storm water detention facility and upstream and downstream piping changes will be installed to alleviate flooding issues at the westerly end of VMF and in the rear yards of homes along Elden Drive. The construction plans and specifications for the improvement are complete and construction is scheduled for August 2023.

The estimated construction cost of the project is \$306,443. The Service Department has secured \$91,000 in Ohio Public Works Commission (OPWC) grant assistance and the Sylvania Area Joint Recreation District (SAJRD) will be contributing \$48,650 towards construction. The remaining \$166,793 will be locally funded and was included in the 2023 budget as a capital improvement expense via fund 401-7510-53501.

We would request that the Clerk of Council be authorized to advertise for bids.

On January 17, 2017 City Council authorized a proposal from Tetra Tech to inventory all twenty-seven (27) City-owned and operated traffic signal systems within our municipal limits (Ord. 6-2017). The inventory included a field review, inspection, and recommendations to improve each signal.

Since 2017 several locations have already had capital improvements completed using Federal Highway Safety Improvement Program (HSIP) grant funds including Alexis/Acres & Alexis/Elliott. Several more intersections are currently programed for signal replacements or removals using Federal HSIP, CMAQ, or STBG grant funds including Monroe/Silica, Monroe/Summit, Monroe/Harroun, Monroe/Kroger, Monroe/Glasgow, Monroe/Alexis, & Monroe/Acres.

The Service Department is ready to commence engineering work to upgrade another four (4) intersections (Erie/Sun Valley, Monroe/Major Magics, Monroe/Corey, and Monroe/ProMedica). The City requested an engineering proposal from DGL Consulting Engineers, LLC from Maumee, Ohio to design these improvements. DGL has provided signalization engineering for the City on four (4) of the locations noted above and is very familiar with the standards and operation of the City's signal system. Their proposal to complete the requested scope of services is in the amount of \$88,738.

Engineering design was included in the 2023 capital improvement budget and would be funded from the 401-7635-53543 account. We would recommend approval of the proposal from DGL in the amount of \$88,738. Please call if you should have any questions.

The Monroe Street corridor (Sun Valley Boulevard to ProMedica Health & Wellness Center) currently operates on a spread spectrum radio network for traffic signal communication and coordination. The network is master controlled at the Monroe Street & Main Street location and a two-way radio system feeds information in each direction to provide the necessary progression and offsets to optimize the flow of traffic.

This type of communication network is obsolete and once new traffic signal equipment is implemented later this year at the Monroe/Silica, Monroe/Harroun, and Monroe/Kroger intersections corridor coordination abilities via radio will no longer be possible. As a result, a new network will need to be installed ahead of these construction projects to keep the flow of traffic intact.

The Service Department has received a proposal from our traffic signal equipment vendor, Path Master, in the amount of \$86,411 to provide and install a new network at thirteen (13) intersections. The new devices are called Field Monitoring Units (FMU's) made by Applied Information and communicate with cellular technology. The FMU's will work with our old and new equipment and can be harvested and reinstalled when each traffic signal system is upgraded and replaced. This equipment is readily available with the goal to have the network installed and operational by May.

This was an anticipated expense and included in the 2023 capital improvement budget. Funds for this project would be from account number 401-7635-53543. We would recommend approval of the Path Master proposal in the amount of \$86,411. Please call with any questions.

125.02 DIVISION OF POLICE.

The Chief of the Division of Police, to be called the Chief of Police, shall, under the Director of Public Safety, have exclusive control of the stationing and transfer of all police officers and other officers and employees constituting the police force, under such rules and regulations as the Director may promulgate from time to time. The Chief of Police shall have a police secretary whose duties he shall assign within the Division. The police force shall be composed of a Chief of the Division of Police; two captains, who shall be directed by and answerable to the Chief; seven sergeants, who shall be answerable to and assigned by the Chief; twenty-five police officers and/or cadets, who shall be answerable to and assigned duties by the Chief of Police; two full-time Police Division Clerks and one full-time Police Division Clerk II. all of whom shall be answerable to and assigned duties by the Chief of Police; and such additional personnel, both full-time and part-time as Council shall hereafter authorize. The Chief of Police may set up, combine and/or abolish and assign or reassign any member of the police force to, or withdraw therefrom, any of the following sections: Office of Community Affairs; Detective Bureau; Court Officer; Property and Evidence Room; Road Patrol. In the event of an emergency, the Mayor may appoint additional police officers and other officers for temporary service during the emergency.

1105.07 VARIANCES.

- (a) Nature of variance. On a particular property extraordinary circumstances may exist, making a strict enforcement of the applicable development requirements of this Code unreasonable, and therefore, the variance procedure is provided to allow the flexibility necessary to adapt to changed or unusual conditions that meet the standards of review for variances. In granting any variance, the Board of Zoning Appeals shall prescribe appropriate conditions and safeguards to maintain the intent and spirit of the zoning district in conformity with the Zoning Code.
- (b) <u>Non-use (area) variances.</u> Upon application, the Board of Zoning Appeals shall only approve a request for a non-use variance only in cases where there is evidence of practical difficulty present on the property in the official record of the hearing and that the following findings are made by the Board:
 - (1) Whether the property in question will yield a reasonable return or whether there can be a beneficial use of the property without the variance;
 - (2) Whether the variance is substantial;
 - (3) Whether the essential character of the neighborhood would be substantially altered or whether adjoining properties would suffer a substantial detriment as a result of the variance;
 - (4) Whether the variance would adversely affect the delivery of governmental services (e.g., water, sewer);
 - (5) Whether the property owner purchased the property with knowledge of the zoning restriction;
 - (6) Whether the property owner's predicament can be obviated through some method other than a variance; and
 - (7) Whether the spirit and intent behind the zoning requirement would be observed and substantial justice done by granting the variance.

After considering the above, the Board thereafter finds that:

- (8) The granting of the variance will be in harmony with the general purpose and intent of this Zoning Ordinance, will not be injurious to the neighborhood, will not impair the adequate supply of light and air to the adjacent property, will not unreasonably increase the congestion in public streets, will not unreasonably diminish property values within the surrounding area or otherwise be detrimental to the public interest. In authorizing a variance, the Board may attach conditions and require such guarantee or bond as it may deem necessary to assure compliance with the objective of this Zoning Ordinance.
- (c) <u>Use variances</u>. Establishment or expansion of a use otherwise prohibited shall not be allowed by variance, nor shall a variance be granted because of the presence of nonconformities in the zoning district, or adjoining zoning districts.
