# NORTHWEST OHIO AGGREGATION COALITION (NOAC) ELECTRIC PROGRAM UPDATE

FirstEnergy (Toledo Edison's parent company) recently announced the final supply auction results for the June 2023- May 2024 electric delivery year, and starting in June 2023, the utility default supply rate (also known as the price to compare) for Toledo Edison residential and small commercial customers will be over \$0.12 per kWh. This is double the current utility supply rate and will remain the price to compare through August 2023. The good news is you have other options for your home or small business's electric supply rate.

Your community operates its own aggregation program but participates with 14 other local communities in the Northwest Ohio Aggregation Coalition or NOAC. Early in 2022, the communities of NOAC had anticipated higher supply pricing, so they selected Energy Harbor to supply their residents/small businesses at a low fixed rate. With Energy Harbor as the electric aggregation provider, the fixed supply rate is \$0.063 per kWh from June 2022 through May 2025. Under this program, NOAC residents and small businesses not with a third-party supplier were automatically enrolled in June 2022 unless they said "no thanks" by opting out. If you were not automatically enrolled or if you are not currently participating, you still have the option to enroll in the current electric program supplied by Energy Harbor.

Many residents and small businesses are already participating in the program. To confirm your participation, check page 1 of your Toledo Edison bill for the following detail of charges.

If you have not chosen a third-party supplier and are served under the Toledo Edison default supply rate, you may still be able to participate in the electric aggregation program. To know if you're eligible to participate and opt-in to the NOAC program, you can visit Energy Harbor's Find Your Program webpage and search for your community or you can call Energy Harbor directly at 1-800-254-6359. Be sure to mention your community's name when speaking with Energy Harbor. Please Note: Energy Harbor reviews each opt-in request to participate in the NOAC program to confirm your eligibility. Energy Harbor will notify you either via email to the email address provided or mail to your service address if you are ineligible.

If Energy Harbor is not listed on your bill and you are being served by another supplier, but you would like to participate, be sure to check the terms of your current agreement with your supplier noted on your bill before making any changes. Some suppliers charge early termination fees for switching mid-contract, but if there isn't a conflict, then you can visit Energy Harbor's Find Your Program webpage and search for your community or you can call Energy Harbor directly at 1-800-254-6359to inquire about your eligibility for the NOAC Program. Be sure to mention your community aggregation program when choosing a supply rate. **Please Note:** Energy Harbor reviews each opt-in request to participate in the NOAC program and will confirm your eligibility. Energy Harbor will notify you either via email to the email address provided or mail to your service address if you are ineligible.

# Who is eligible for the NOAC Program?

Residential and non-mercantile business accounts served on the RS / GS rate classification located within
the program boundaries in the Cities of Maumee, Northwood, Oregon, Perrysburg, Rossford, Sylvania,
Toledo and Waterville; the Villages of Delta, Holland, Ottawa Hills and Walbridge; as well as Lake and
Perrysburg Townships in Wood County and the unincorporated areas of Lucas County.

# Who is not eligible for the NOAC Program?

- Non-residential accounts that:
  - Are not at secondary voltage;
  - Consume more than 700,000 kWh annually;
  - Have monthly demand that has exceeded 200 kWh
- PIPP (percentage of income payment plan) customers
- Lighting Accounts
- Customers with a special contract with their utility
- Customers outside the program boundaries

#### What if I am currently in contract with another supplier?

Call your current supplier and inquire about the terms of your agreement. Early termination fees may apply if you leave an agreement early. If there isn't a conflict with your existing supply agreement, you can visit Energy Harbor's Find Your Program webpage and search for your community or you can call Energy Harbor directly at 1-800-254-6359 to inquire about your eligibility for the NOAC Program. Be sure to mention your community aggregation program when choosing a supply rate.

**Please Note: Asking to join** the program does not guarantee participation. Energy Harbor reviews each opt-in request to participate in the NOAC program and will confirm your eligibility. If your home or small business falls outside the geographic boundaries of the participating communities or if you have a special arrangement with your utility, then you may not be able to join.

If unable to participate, Energy Harbor will provide a notice of your ineligibility via email and - where possible - inform you if you're eligible to participate in another community program that Energy Harbor serves.

#### What if a lower rate becomes available before the May 2025 term?

You are not obligated stay with Energy Harbor for the length of the term and may choose to opt your home or small business out of the NOAC program by submitting the opt-out reply form mailed to your address within 30-days of receipt, filling out Energy Harbor's online opt-out form, or by calling Energy Harbor at 1-800-254-6359. There is no fee to leave the NOAC Program prior to May 2025.
