Highland Elementary, Sylvan Elementary, and McCord Road Junior High

Dear Mr. Mayor and Council Members:

In March 2010 the City commenced a Safe Routes to Schools (SRTS) project in conjunction with Sylvania Schools and ODOT. ODOT infrastructure grant dollars were used to implement pedestrian improvements at Highland Elementary, Maplewood Elementary, Sylvan Elementary, and McCord Junior High School. The improvements included the installation of Rectangular Rapid Flashing Beacon (RRFB) systems at Highland (Erie Street crossing) and Sylvan and McCord (both McCord Road crossings). These units allowed pedestrians to illuminate flashing crosswalk lights to warn motorists that the crosswalk was about to be in use.

The Service Department would like to study the possibility of replacing these RRFB systems with pedestrian hybrid beacons (PHB's). The beacons are a newer tool to assist with pedestrian movements across busier roadways that were not available for use in Ohio at the time of the SRTS project. The beacons would be a significant upgrade and carry full traffic control authority.

The City requested a proposal from DGL Consulting Engineers, LLC to study these locations and prepare a safety report. If the PHB's are warranted, DGL would assist the City and prepare an ODOT Systemic Safety Application. This program was launched in 2022 within the Highway Safety Improvement Program (HSIP) and focuses specifically on pedestrian countermeasures. The DGL proposal to complete the safety report and potential application is in the amount of \$24,000.

The safety study would be funded from the 401-7635-53543 account. We would recommend approval of the proposal from DGL in the amount of \$24,000. Please call with any questions.

# **ORDINANCE NO. 48-2023**

ACCEPTING THE PROPOSAL OF DGL CONSULTING ENGINEERS, LLC TO PREPARE A PEDESTRIAN HYBRID BEACON SAFETY STUDY FOR HIGHLAND ELEMENTARY, SYLVAN ELEMENTARY AND McCORD ROAD JUNIOR HIGH SCHOOLS; APPROPRIATING FUNDS THEREFORE IN THE AMOUNT OF \$24,000; AND DECLARING AN EMERGENCY.

WHEREAS, in 2010, the City of Sylvania, Sylvania City School District and the Ohio Department of Transportation collaborated on a comprehensive Safe Routes to School study; and,

WHEREAS, as a result of that study, Ohio Department of Transportation grant dollars were used to implement pedestrian improvements at Highland Elementary, Maplewood Elementary, Sylvan Elementary and McCord Road Junior High School, including the installation of Rectangular Rapid Flashing Beacon Systems at Highland Elementary (Erie Street crossing), Sylvan Elementary (McCord Road crossing) and McCord Road Junior High School (McCord Road crossing); and,

WHEREAS, the Director of Public Service has requested a proposal from DGL

Consulting Engineers, LLC to study the possibility of replacing the rectangular rapid flashing

beacon systems with pedestrian hybrid beacons, a newer tool to assist with pedestrian movements

across busier roadways; and,

WHEREAS, the Director of Public Service, by report dated June 5, 2023, reported that he received a proposal from DGL in the amount of \$24,000 to study the Highland Elementary, Sylvan Elementary and McCord Road Junior High School rectangular rapid flashing beacon system locations to determine if they should be upgraded to pedestrian hybrid beacons and prepare a safety report and has recommended that the proposal be approved and accepted.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, members elected thereto concurring: SECTION 1. That the proposal of DGL Consulting Engineers, LLC in the amount of Twenty-Four Thousand Dollars (\$24,000.00) to prepare a Pedestrian Hybrid Beacon Safety Study and report for Highland Elementary, Sylvan Elementary and McCord Road Junior High Schools, is hereby approved and accepted. SECTION 2. That the Director of Public Service shall promptly give notice to said engineers to proceed under the proposal hereby approved and accepted. SECTION 3. That to provide funds for said services hereby authorized, there is hereby appropriated from the CAPITAL IMPROVEMENT FUND from funds therein not heretofore appropriated to Account No. 401-7635-53543 - Traffic Signal Upgrades the amount of Twenty-Four Thousand Dollars (\$24,000.00). SECTION 4. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code. SECTION 5. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City. SECTION 6. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that the City should provide for the preparation of the pedestrian hybrid beacon safety study for Highland Elementary, Sylvan Elementary and McCord Road Junior High Schools at the earliest possible time. Provided this Ordinance receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force thirty (30) days after it is approved by the Mayor or as otherwise provided by the Charter. Dear Mr. Mayor and Council Members:

On April 18, 2022 City Council authorized a contract with DGL Consulting Engineers, LLC in the amount of \$38,259 to provide engineering design services for the Monroe Street/Main Street/Summit Street Traffic Signal Improvement Project (Ord. 47-2022). As a reminder, this project will update signal operations and equipment at both intersections, add pedestrian signal accommodations at Summit Street, and improve the truck turning radius at the northeast quadrant of Summit Street.

The project construction plans are 90% complete and in order to accommodate the improvements additional right-of-way will need to be acquired from two (2) parcels.

The Service Department received a proposal from DGL in the amount of \$2,875 to prepare a Right-of-Way Plat and two (2) legal descriptions for the proposed take areas. In addition, the Service Department requested a Right-of-Way Acquisition services proposal from West Erie Realty Solutions, LTD to provide project management, title reports, appraisals, negotiations, closings, and recording services. The West Erie Realty Solutions proposal amount is \$14,300.

We would recommend approval of the DGL proposal in the amount of \$2,875 and the West Erie Realty Solutions proposal in the amount of \$14,300. These were anticipated project expenses and funds would be encumbered from the 401-7635-53543 account. Please call with any questions.

# BACKGROUND

The City of Sylvania desires to complete a Systemic Safety Study to review the replacement and upgrade of three Rapid Rectangular Flashing Beacons to Pedestrian Hybrid Beacons for McCord Junior High School, Sylvan Hills Elementary and Highland Elementary School.

# SCOPE OF WORK

# **Existing Conditions Review and Analysis**

- Perform field review of corridor, including coordination with the City. Document relevant corridor details or evidence of safety issues via photo, GoPro and/or drone. The field visit will be attended by up to two (2) DGL representatives.
- Develop and analyze existing/future year traffic volumes. Anticipating Opening Year 2026. The growth factors will be developed using ODOT SHIFT Tool and TMACOG models.
- Collect and review crash history at three (3) locations. Crash diagrams will be created for each location.
- Collect counts via video cameras. DGL will conduct three ATR's that include pedestrian volumes.
- Collect speed data on both McCord Road and Erie Street to determine 85th percentile speed.
   DGL can collect data via speed gun and would request the assistance of the City Police with a speed trailer that collects data can also be implemented.
- Develop physical conditions write-up including existing and future traffic conditions to be included in final study report.

### **Develop Potential Alternatives**

- Review and analyze appropriate FHWA countermeasures.
- Alternatives meeting (via web conference or in person) with the City, District 2, and key Stakeholders (as directed by City/ODOT) to discuss preferred countermeasures
- Final recommendation(s) to be shown on a Conceptual Plan and prepared with sufficient detail to develop planning level cost estimates for use in cost benefit analysis.

On June 20, 2022 City Council accepted the proposal from DGL Consulting Engineers, LLC to provide engineering services for a new traffic signal installation at the intersection of Harroun Road and Ravine Drive as a part of the LUC- TR 77-0.54 (PID 116375) improvements project (Ord. 59-2022).

During Stage 3 development ProMedica requested further design review from ODOT and the City to reanalyze their new driveway alignment. ProMedica's request was to shorten the length of the driveway and move the tie-in further north to straighten the alignment. ProMedica was provided preliminary information including potential schedule impacts this change would have on the project. ProMedica has decided they would like to move forward with the change.

The Service Department requested a contract modification proposal from DGL to redesign the driveway per the ProMedica request and also evaluated potential construction cost savings by shortening the driveway. The contract modification proposal from DGL was in the amount of \$66,758. The Service Department is estimating the potential construction cost savings to be \$264,000.

WHEREAS, Ordinance No. 59-2022, passed June 20, 2022, accepted the proposal of DGL Consulting Engineers, LLC (hereafter "DGL") to provide engineering services for a new traffic signal installation at the intersection of Harroun Road and Ravine Drive in the amount of Eighty-Nine Thousand Nine Hundred Ninety-Four Dollars (\$89,994.00); and,

WHEREAS, during Stage 3 development, ProMedica requested further design review from the Ohio Department of Transportation ("ODOT") and the City related to the proposed new Flower Hospital driveway alignment; and,

WHEREAS, based on this request, representatives from ProMedica, ODOT and the City met to review the proposed new alignment and ProMedica requested that the driveway length be shortened and the tie-in be moved further north to straighten the alignment; and,

WHEREAS, the Director of Public Service, by report dated June 5, 2023, has received a proposal from DGL for the additional engineering services required to redesign the driveway and has recommended approval of the additional engineering services in the amount of \$66,758; and,

WHEREAS, although the cost of engineering is increasing, the cost of construction is estimated to decrease in the amount of \$264,000 due to the shortened driveway length, for a net decrease to the estimated project cost of \$197,242.

# **Scope of Services**

# Project Background and Original Scope

DGL understands that the City of Sylvania is planning improvements at the Harroun Rd. and Ravine Drive intersection including the relocation of the Flower Hospital main entrance. Harroun Rd. provides access to ProMedica Flower Hospital. Traffic is especially heavy during shift changes which has led to crash issues at the Harroun Rd. & Ravine Drive intersection and the existing Harroun Rd. & Hospital Drive intersection. These two intersections are approximately 350' apart. Realignment of Hospital Dr. to Ravine Dr. provides one common intersection. A signal at this upgraded intersection will be provided. Ravine Drive will also be widened for the addition of a left turn lane and aligning this lane with the left turn out of the new Flower Hospital main entrance. Harroun Rd. will be resurfaced throughout the project limits to allow for restriping.

# Fee Modification Scope of Work

# Detailed Design and Right of Way Plans

Upon authorization, DGL will confirm the geometric layout of the Flower Hospital Drive. Once this geometric layout is approved, Stage 2 design will begin to revise the original plans for the revised drive alignment. All roadway, drainage, lighting, and traffic control design will adhere to ODOT standards and guidelines. Construction limits will be finalized and right of way plan adjustments will begin.

# Final Design

Upon approval of the Stage 2 design, DGL will finalize design and prepare construction documents following all ODOT specifications for advertisement and bidding purposes. This final design stage will include the original scope of work for Harroun Road resurfacing, Ravine Drive widening, the signal installation at Ravine Drive and Harroun Road and the revised alignment for the Hospital Drive. The plan set will include subsummaries and a general summary of all the biddable items. DGL will assist with bid book and advertising of the project. A review of all bids and a recommendation letter will be provided by DGL.

Dear Mr. Mayor and City Council Members,

The Sylvania Senior Center has obtained quotes to replace their aged heating, ventilating, and air conditioning (HVAC) system. The lowest quote for the work was submitted by Rawlings Heating & Cooling of Temperance, Michigan in the amount of \$165,000.

The current Operating Agreement for the Senior Center indicates that the Township and the City are responsible for the "replacement of any HVAC item, the cost of which exceeds \$25,000." Therefore, the City's portion of this replacement cost is \$82,500.

We were only notified of this project on or about March 7, 2023. Hence, we were not able to include the project in our Capital Improvement Plan for the year. It is our recommendation that we meet our responsibility with the Senior Center but utilize our existing Capital Improvement budget. We will continue to monitor the existing budget and modify projects accordingly or come back to City Council for an additional appropriation, if needed, as the year progresses.

We request approval to provide \$82,500 to the Sylvania Senior Center for the replacement of their HVAC system, to be paid from the Capital Improvement Fund 401-7750-52268. Please call if you have any questions.

PROVIDING FOR THE CONSTRUCTION, MAINTENANCE, REPAIR, CLEANING AND ENCLOSING OPEN DRAINAGE DITCHES LOCATED WITHIN THE CORPORATE LIMITS OF THE CITY OF SYLVANIA; AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE, BY AND THROUGH THE PROPER OFFICERS OF SAID CITY TO DO SAID WORK DURING THE YEAR 2023; ESTABLISHING ONE DISTRICT FOR SAID PURPOSE IN ACCORDANCE WITH THE PROVISIONS OF SECTION 727.012 OF THE REVISED CODE OF OHIO; PROVIDING FOR THE ASSESSMENT OF THE COST AND EXPENSE THEREOF UPON ABUTTING PROPERTY; AND DECLARING AN EMERGENCY.

WHEREAS, it is immediately urgent and necessary that work is authorized for the purpose of constructing, maintaining, repairing, cleaning and enclosing open drainage ditches located within the corporate limits of the City of Sylvania during the year 2023;

WHEREAS, the Director of Public Service has recommended to Council the construction, maintaining, repairing, cleaning and enclosing open drainage ditches located within the corporate limits of the City of Sylvania during the year 2023 in accordance with plans, estimates and schedules therefore heretofore prepared and now on file in the Office of Finance.

NOW, THEREFORE BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, \_\_\_\_\_ members elected thereto concurring:

SECTION 1. That it is hereby declared necessary and conducive to public health, convenience and welfare to construct, maintain, repair, clean and enclose open drainage ditches located within the corporate limits of the City of Sylvania during the year 2023. That for said purpose there is hereby established one (1) district which shall include all territory within and coextensive with the boundaries of the City of Sylvania, pursuant to the provisions of Section 727.012 of the Revised Code of Ohio.

SECTION 2. That the work of such construction, maintaining, repairing, cleaning and enclosing open drainage ditches located within the district of the City shall be done within said district, as herein set forth, and through the proper officers of the City of Sylvania; and such officers be, and they hereby are, authorized and directed to purchase required materials; to purchase or rent the necessary tools, machinery and appliances; to employ the necessary labor to do said work all in accordance with the plans, estimates and schedules therefore heretofore prepared and now on file in the Office of Finance for inspection of all persons interested, which said plans, estimates and schedules, including approximate present estimates of the cost of said work, is in the aggregate sum of Three Hundred Sixteen Thousand, Four Hundred Nine Dollars

and 00/100 (\$316,409.00).

SECTION 3. That said cost and expense of construction, maintaining, repairing, cleaning and enclosing open drainage ditches located within the corporate limits of the City in the amount of Three Hundred Sixteen Thousand, Four Hundred Nine Dollars and 00/100 (\$316,409.00) shall be specially assessed by impervious area upon all of the lots and lands abutting and bounding upon each of said streets and public right-of-way in said district as follows:

- a. Small Lot Residential (lot size less than 9,900 square feet) = \$15.00 per year;
- b. Large Lot Residential (lot size greater than 9,900 square feet) = \$30.00 per year;
- c. Non-Single Family Residential = \$30.00 per year per 5,000 square feet of impervious area:

as provided in Section 727.012 of the Ohio Revised Code, which said lots and lands are hereby determined to be specially benefitted by said work in the amount equal to the amount specially assessed against each such lot and land. The cost of said work shall include acquisition of the necessary materials, tools, machinery and appliances, the wages for the necessary labor, the cost of said plans, estimates and schedules, cost of publication and mailing of notices, and cost of this Ordinance, costs of the preparation, levy and collection of special assessments and interest on notes issued in anticipation of the levy and collection of the special assessments together with all necessary expenditures.

SECTION 4. That the special assessment so to be levied on said lots and lands shall be paid in one (1) installment in the manner provided in the case of special assessments pursuant to Section 727.01 of the Ohio Revised Code.

SECTION 5. That to provide a fund out of which shall be paid the assessed cost and expense of said work, bonds or notes or certificate of indebtedness of the City of Sylvania are hereby authorized to be issued and sold in anticipation of the levy and collection of said assessments.

SECTION 6. That the Director of Finance has prepared and filed in the Office of Finance a list of the special assessments, pursuant to this Ordinance, and this Council finds and determines that such special assessments are in proportion to the special benefit derived by each property against which such assessments are to be levied and are not in excess of any statutory limitation.

SECTION 7. That, pursuant to Ohio Revised Code Section 727.14, the Finance Department is hereby directed to give notice of the passage of this Ordinance by publication of such notice once a week for two (2) consecutive weeks, and as to an owner of any lot or parcel of land the assessment upon which is estimated to exceed Two Hundred Fifty Dollars (\$250.00), the Finance Department is hereby directed to serve such notice in the same manner as service of summons in civil cases, or by certified mail addressed to such owner at his last known address or to the address to which tax bills are sent, or by a combination of the foregoing methods. Objections to estimated assessments must be filed, in writing with the Finance Department within two (2) weeks after completion of the notice hereby required. An owner who fails to file an objection shall be deemed to have waived any objection. Any and all properly filed objections to estimated assessments shall be considered by Council at its first regular Council meeting held more than two (2) weeks after the completion of the notice hereby required and the estimated assessments so objected to shall at such meeting, be adjusted by Council by motion or other action reflected in the journal of the minutes of Council. Council, after adjusting such estimated assessments or, after the time for filing objections without any properly filed objections having been timely filed, may, by Ordinance, levy such estimated assessments and adjusted estimated assessments, as the case may be. No notice shall be required other than as herein required.

SECTION 8. That the method, manner, consideration and procedure for such drainage ditch work is hereby approved and this Council hereby determines the method, manner and procedure for levying assessments for such drainage ditch work to be as set forth in this Ordinance.

SECTION 9. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 10. That the Finance Department is hereby directed to post a copy of this Ordinance in the Office of Finance in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City.

SECTION 11. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that the repair, cleaning, construction and maintenance of drainage ditches should be provided for immediately and therefore this Ordinance should be effective forthwith. Provided this Ordinance receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force thirty (30) days after it is approved by the Mayor or as otherwise provided by the Charter.

PROVIDING FOR THE CONTROLLING BLIGHT AND DISEASE OF SHADE TREES AND FOR PLANTING, MAINTAINING, TRIMMING AND REMOVING SHADE TREES IN AND ALONG THE STREETS AND WITHIN PUBLIC RIGHT-OF-WAY OF THE CITY OF SYLVANIA; AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE, BY AND THROUGH THE PROPER OFFICERS OF SAID CITY TO DO SAID WORK DURING THE YEAR 2023; ESTABLISHING ONE DISTRICT FOR SAID PURPOSE IN ACCORDANCE WITH THE PROVISIONS OF SECTION 727.011 OF THE REVISED CODE OF OHIO; PROVIDING FOR THE ASSESSMENT OF THE COST AND EXPENSE THEREOF UPON ABUTTING PROPERTY; AND DECLARING AN EMERGENCY.

WHEREAS, it is immediately urgent and necessary that work is authorized for the purpose of controlling blight and disease of shade trees and for planting, maintaining, trimming and removing shade trees in and along the streets and within public right-of-way of the City of Sylvania during the year 2023;

WHEREAS, the Director of Public Service has recommended to Council the removal or special treatment of shade trees and for planting, maintaining, trimming and removing shade trees in and along the streets and within public right-of-way of the City of Sylvania during the year 2023 in accordance with plans, estimates and schedules therefore heretofore prepared and now on file in the Office of Finance.

NOW, THEREFORE BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, \_\_\_\_\_ members elected thereto concurring:

SECTION 1. That it is hereby declared necessary and conducive to public health, convenience and welfare to remove and provide special treatment for shade trees for the purpose of controlling blight and disease of same, and for planting, maintaining, trimming and removing shade trees in and along the streets and within public right-of-way of the City of Sylvania during the year 2023. That for said purpose there is hereby established one (1) district which shall include all territory within and coextensive with the boundaries of the City of Sylvania, pursuant to the provisions of Section 727.011 of the Revised Code of Ohio.

SECTION 2. That the work of such removal or special treatment of shade trees for the purpose of controlling blight and disease of same and for planting, maintaining, trimming and removing shade trees in and along the streets and within public right-of-way of the City of Sylvania shall be done within said district, as herein set forth, and through the proper officers of the City of Sylvania; and such officers be, and they hereby are, authorized and directed to purchase required materials; to purchase or rent the necessary tools, machinery and appliances; to employ the necessary labor to do said work all in accordance with the plans, estimates and schedules therefore heretofore prepared and now on file in the Office of Finance for inspection of all persons interested, which said plans, estimates and schedules, including approximate present estimates of the cost of said work, is in the aggregate sum of Two Hundred Forty-Nine Thousand, Nine Hundred Ninety-Three Dollars and 00/100 (\$249,993.00).

SECTION 3. That said cost and expense of removal or special treatment of shade trees for the purpose of controlling blight and disease of same and for planting, maintaining, trimming and removing shade trees in and along the streets and within public right-of-way of the City of Sylvania in the amount of Two Hundred Forty-Nine Thousand, Nine Hundred Ninety-Three Dollars and 00/100 (\$249,993.00) shall be specially assessed by the front foot upon all of the lots and lands abutting and bounding upon each of said streets and public right-of-way in said district in the amount of thirty-five cents ( $35\phi$ ) per front foot as provided in Section 727.011 of the Ohio Revised Code, which said lots and lands are hereby determined to be specially benefitted by said work in the amount equal to the amount specially assessed against each such lot and land. The cost of said work shall include acquisition of the necessary materials, tools, machinery and appliances, the wages for the necessary labor, the cost of said plans, estimates and schedules, cost of publication and mailing of notices, and cost of this Ordinance, costs of the preparation, levy and collection of special assessments and interest on notes issued in anticipation of the levy and collection of the special assessments together with all other necessary expenditures.

SECTION 4. That the special assessment so to be levied on said lots and lands shall be paid in one (1) installment in the manner provided in the case of special assessments pursuant to Section 727.01 of the Ohio Revised Code.

SECTION 5. That to provide a fund out of which shall be paid the assessed cost and expense of said work, bonds or notes or certificate of indebtedness of the City of Sylvania are hereby authorized to be issued and sold in anticipation of the levy and collection of said assessments.

Provided this Ordinance receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force thirty (30) days after it is approved by the Mayor or as otherwise provided by the Charter.

# **RESOLUTION NO. 5-2023**

DECLARING THE NECESSITY OF LIGHTING THE STREETS IN THE CITY OF SYLVANIA, OHIO; DETERMINING THE MANNER OF PROVIDING STREET LIGHTING AND THE BASIS FOR THE PROPERTY OWNER'S SHARE OF THE COST AND ANNUAL ASSESSMENT; AND DECLARING AN EMERGENCY.

BE IT RESOLVED by the Council of the City of Sylvania, Lucas County, Ohio, \_\_\_\_\_\_ members elected thereto concurring:

<u>SECTION 1.</u> That is hereby determined to be necessary to continue to improve the streets in the City of Sylvania, Ohio, by lighting the same pursuant to a contract therefore which this City now has with the Toledo Edison Company and necessary to provide funds in 2023 for such street lighting.

SECTION 2. That for the tax year 2023 the basis for determining and allocating annual assessments on lots and lands in said City for street lighting in the City of Sylvania, Ohio, shall be as follows, which basis is hereby determined to be according to the benefits which may result from the improvements to the several parcels and lots of land in said City:

- E. Each taxable parcel, outside of the Whiteway Business District, having no building or buildings thereon, served by lamps on poles with either overhead or underground circuits, shall be assessed a front footage charge of 16¢ for each benefitted front foot of the parcel;
- O. Each taxable parcel, outside of the Whiteway Business District, having a building or buildings thereon, served by lamps on poles with overhead circuits, shall be assessed a front footage charge of 50¢ for each benefitted front foot of the parcel;
- U. Each taxable parcel, outside of the Whiteway Business District, having a building or buildings thereon, served by lamps on poles with underground circuits, shall be assessed a front footage charge of 88¢ for each benefitted front foot of the parcel;
- W. Each taxable parcel, within the Whiteway Business District, fronting on Main Street, Maplewood Avenue, or Monroe Street, being served by lamps on poles with either overhead or underground circuits, shall be assessed at a rate of \$1.13 per front foot of the parcel;

SECTION 3. That the contract with the Toledo Edison company and the costs to this City required thereby, now on file with the Finance Department, are hereby deemed to be the plans and specifications and estimate of cost required to be on file with the Finance Department before the passage of the Resolution of necessity.

SECTION 4. That the Finance Department has prepared and filed in the Office of Finance a list of the estimated special assessments for the cost and expense of street lighting in the City of Sylvania, which list shows the amounts of the estimated assessment against each taxable parcel in the City of Sylvania, pursuant to Section 2 of this Resolution, and the amount of such assessments in the aggregate, and this Council finds and determines that such estimated assessments are in proportion to the special benefit derived by each property against which such assessments are to be levied and are not in excess of any statutory limitation.

SECTION 5. That, pursuant to Ohio Revised Code Section 727.14, the Finance Department is hereby directed to give notice of the passage of this Resolution by publication of such notice once a week for two (2) consecutive weeks, and as to an owner of any lot or parcel of land the assessment upon which is estimated to exceed Two Hundred Fifty Dollars (\$250.00), the Finance Department is hereby directed to serve such notice in the same manner as service of summons in civil cases, or by certified mail addressed to such owner at his last known address or to the address to which tax bills are sent, or by a combination of the foregoing methods. Objections to estimated assessments must be filed, in writing, with the Finance Department, within two (2) weeks after completion of the notice hereby required. An owner who fails to file an objection shall be deemed to have waived any objection. Any and all properly filed objections to estimated assessments shall be considered by Council at its first regular meeting held more than two (2) weeks after the completion of the notice hereby required and the estimated assessments so objected to shall, at such meeting, be adjusted by Council by motion or other action, reflected in the journal of the minutes of Council. Council, after adjusting such estimated assessments or after the time for filing objections without any properly filed objections having been timely filed, may, by Ordinance, levy such estimated assessments and adjusted estimated assessments, as the case may be. No notice shall be required other than as herein required.

SECTION 6. That the Finance Department is hereby directed to give notice to the Auditor of Lucas County, Ohio, on the levying of such assessments and to do so within twenty (20) days after the levying of same and prior to October 1, 2023.

<u>SECTION 7.</u> That the method, manner and procedure for providing street lighting by contract with the Toledo Edison Company is hereby approved and this Council hereby determines the method, manner and procedure for levying assessments for such street lighting to be as set forth in this Resolution.

SECTION 8. That this Resolution shall be published by posting a copy thereof in a conspicuous place in the Sylvania Municipal Building for a period of not less than fifteen (15) days as provided in ARTICLE III, Section 12.0 of the Charter of said City.

SECTION 9. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 10. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the reason that proceedings for assessing the cost of the improvement referred to herein are required without delay in order to timely place said assessment upon the tax duplicate for the year. Provided this Resolution receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force thirty (30) days after it is approved by the Mayor or as otherwise provided by the Charter.






