Dear Mr. Mayor and Council Members:

At the October 16, 2023 meeting City Council authorized the Service Department to request Letters of Interest (LOI's) from consultants to provide engineering services for the design of a modern roundabout at the intersection of Erie Street and Monroe Street. Construction is scheduled for 2027.

During the solicitation we received LOI's from two (2) engineering consultants. The Service Department reviewed, scored, and ranked the LOI's and selected Tetra Tech as the most highly qualified consultant for this project. Subsequently, the Service Department entered into scope of services and fee negotiations with Tetra Tech.

We have completed those negotiations and Tetra Tech has prepared a proposal in the amount of \$474,500 to complete the requested scope of services. Their scope of services include survey, preparation of construction plans and right-of-way plans, geotechnical engineering, public involvement coordination, and landscape architecture and roundabout aesthetics. The Service Department will return to City Council to request additional proposal approvals for right-of-way acquisition services once the right-of-way needs on the project are defined.

This is a Local Public Agency (LPA) project with the Ohio Department of Transportation (ODOT). As such the Service Department has coordinated the scope of services and fee proposal with ODOT District 2 and both entities are ready to move forward and commence engineering design. This is an appropriated item in the 2024 budget, fund 401-7610-53613. We would recommend approval of the proposal in the amount of \$474,500 with Tetra Tech. Please call with any questions.

ORDINANCE NO. 6-2024

ACCEPTING THE PROPOSAL OF TETRA TECH TO PROVIDE PROFESSIONAL ENGINEERING SERVICES FOR ERIE STREET & MONROE STREET ROUNDABOUT AND RESURFACING PROJECT; APPROPRIATING FUNDS THEREFORE IN THE AMOUNT OF \$474,500; AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance No. 3-2019, passed January 7, 2019, accepted the proposal of Tetra Tech to conduct a traffic study at the intersection of Erie Street and Monroe Street and appropriated funds in the amount of \$18,500 for the study; and,

WHEREAS, the purpose of the study was to review intersection deficiencies and evaluate alternatives to improve traffic flow and safety and based on the study, Tetra Tech recommended that a roundabout be constructed at the Monroe Street and Erie Street intersection; and,

WHEREAS, Ordinance No. 13-2020, passed March 2, 2020, accepted the proposal of Tetra Tech to conduct a gap study supplement for the traffic study at the intersection of Erie Street and Monroe Street to include the intersection of Monroe Street and Olde Post Road at a cost of \$7,000; and,

WHEREAS, Resolution No. 8-2021, passed June 21, 2021, authorized the Mayor and Director of Finance to apply for Surface Transportation Block Grant ("STBG") funding for said project in the amount of \$2,861,950 towards the total estimated cost of the project of \$4,028,132; and,

WHEREAS, at the October 16, 2023 meeting of Sylvania City Council, the

Administration was authorized to solicit Letters of Interest from consultants to provide
engineering services for the design of a modern roundabout at the intersection of Erie Street and
Monroe Street; and,

WHEREAS, the Director of Public Service, by report dated February 5, 2024, received Letters of Interest from two (2) engineering consultants and selected Tetra Tech as the most

highly qualified consultant for this project; and,

WHEREAS, the engineering services proposed include survey, preparation of construction plans and right-of-way plans, geotechnical engineering, public involvement coordination, landscape architecture and roundabout aesthetics; and,

WHEREAS, the Director of Public Service, by report dated February 5, 2024, has recommended that the proposal of Tetra Tech in the amount of \$474,500 for the professional engineering services relative to the Erie Street & Monroe Street Roundabout and Resurfacing Project be accepted and approved.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, _____ members elected thereto concurring:

- SECTION 1. That the proposal of Tetra Tech in the amount of Four Hundred Seventy-Four Thousand Five Hundred Dollars (\$474,500.00) for providing professional engineering services for the Erie Street & Monroe Street Roundabout and Resurfacing Project, is hereby approved and accepted.
- SECTION 2. That the Director of Public Service shall promptly give notice to said engineers to proceed under the proposal hereby approved and accepted.
- SECTION 3. That to provide funds for said engineering services hereby authorized, there is hereby appropriated from the **CAPITAL IMPROVEMENT FUND** from funds therein not heretofore appropriated to **Account No. 401-7610-53613 Erie Street Roundabout and Resurfacing**, the amount of Four Hundred Seventy-Four Thousand Five Hundred Dollars (\$474,500.00).
- SECTION 4. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- SECTION 5. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City.

Our team includes DGL Consulting Engineers for surveying, R/W planning and traffic control plans; CT Consultants for geotechnical services; TRC for environmental services; EDGE for landscape architecture design, NE Roundabouts for roundabout peer reviews, and West Erie Realty for R/W acquisition. West Erie will be submitting a proposal directly to the City for R/W acquisition services, later in the design process, when the final R/W needs are determined.

WHEREAS, Ordinance No. 90-2023, passed November 6, 2023, accepted the proposal of Klumm Bros. Landscaping, LLC to abate the nuisance at 5647 Dellbrook Drive at a cost of \$10,500; and,

WHEREAS, Section 1329.07 of the Sylvania Codified Ordinances allows the cost of the abatement to be levied as a special assessment against the property by Council, and certified to the Lucas County Auditor and collected as other assessments are collected by the City; and,

WHEREAS, the total cost of the abatement is \$11,025, which includes the cost of the demolition permit, and the costs of the sanitary and water service termination permits.

be placed on the tax duplicate and collected as other taxes are collected.



The City of Sylvania is interested in becoming a Certified Autism Center. This legislation begins the process for the City of Sylvania.

We need to show that 80% of our employees who deal with the public face to face will go through specific training that will ensure that they have the knowledge and skills to better understand and are then able to communicate with autistic individuals.

The training will cover an overview of Autism, basic safety, sensory impacts, accessibility needs, communication and caregiver perspective.

All of our police officers will need to be certified and other employees, or a total of at least 65 staff members. The certification will last for two years.

The IBCCES (International Board of Credentialing and Continuing Education Standards) handles the certification process.

The Sylvania Fire Department will also be going through this certification, but will be handled administratively by the Township.


Who is your training and certification organization, IBCCES?

The International Board of Credentialing and Continuing Education Standards (IBCCES) was established in 2001 to meet the training and credentialing needs of professionals who work with individuals with autism and cognitive disorders. IBCCES provides these programs in more than 87 countries to healthcare, education, hospitality, corporate, and public safety professionals to help ensure better experiences and outcomes for autistic and neurodivergent individuals.





WHAT ARE THE IBCCES CERTIFICATION REQUIREMENTS?



FREQUENTLY ASKED QUESTIONS

What is a Certified Autism Center?

The Certified Autism Center™ credential requires IBCCES training and certification of at least 80% of public-facing staff in autism and sensory differences. The goal is to better prepare and equip staff to provide service and experiences to all, including autistic and sensory-sensitive individuals. The process may also include an onsite review, as well as other support and guidance. The certification must be renewed every 2 years with updated training provided for staff at each certified organization.



Who is IBCCES?

IBCCES is an independent credentialing organization that was founded in 2001 with the goal of providing specialized training and certification to professionals working with autistic individuals and individuals with other cognitive differences. IBCCES is a leader in the training and certification for cognitive disorders, including autism and other neurodivergencies. We work in more than 85 countries across the globe.

- We work with an advisory board of clinical specialists and subject matter experts, as well as autistic and neurodivergent self-advocates. This advisory board provides guidance and participates in creating the training content for our certifications which is evidence-based and promotes best practices from experts in multiple disciplines.
- IBCCES does not believe there is a "one size fits all" approach and thus brings together expertise and learnings from
 multiple disciplines such as psychology, neurology, special education, and more, along with the lived experience and
 viewpoints of neurodivergent individuals themselves.

What does it mean when an individual has been trained as part of the CAC process?

IBCCES offers industry and position-specific training, as well as individual professional credentials. Depending on an individual's position within an organization, their training may have focused on guest service in a recreational space and building empathy and understanding of what neurodivergent visitors may need, or it may have been more extensive (up to 14 credit hours) and include specific techniques and strategies for professionals working within educational or healthcare environments, or specific to scenarios law enforcement or first responders may encounter.

- The credentials and training are meant to supplement or build upon existing departmental and organizational
 regulations and rules, particularly in a safety or healthcare setting where professional protocols for individual health
 and safety are already in existence.
- All staff that complete training through IBCCES complete a competency exam specific to their training program to ensure comprehension.

What are staff at CACs being trained to do?

The training and certification provided by IBCCES are specific to industry and position.

 Staff are trained to better understand what autism is (and isn't), how to empathize and understand how autistic and sensory sensitive individuals experience the world, communicate more effectively, and be aware of common sensitivities.

Why become a CAC?

The purpose of the training and certification programs offered by IBCCES are to ultimately improve the experience and outcomes for autistic individuals and those with other related disorders.

- The focus is on building understanding and empathy, as well as improving processes and options for individuals with these needs, and ensuring staff have appropriate tools and strategies when engaging with a neurodiverse population.
- With one out of six people having a sensory disorder or sensitivity, one out of 36 children in the US are diagnosed
 with autism, and millions of children and adults that are on the autism spectrum but not included in those formal
 diagnosis rates, the need has never been greater.

AUTHORIZING THE MAYOR AND DIRECTOR OF FINANCE TO ENTER INTO AN AGREEMENT ON BEHALF OF THE CITY OF SYLVANIA BETWEEN THE CITY OF SYLVANIA AND THE BOARD OF LUCAS COUNTY COMMISSIONERS FOR THE SUBURBAN COURT SERVICES PROGRAM; AGREEING TO PARTICIPATE IN FUNDING A PORTION OF THE LOCAL SHARE FOR SUBURBAN COURTS' SERVICES; APPROPRIATING \$25,000 THEREFORE; AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance No. 169-97 approved the application by the Suburban Court Services to the Victims of Crime Assistance (hereinafter "VOCA") grant and authorized the City of Sylvania to share one-third of the 25% match required by the grant; and,

WHEREAS, said Ordinance authorized the expenditure of up to \$12,622.00 for Sylvania's local share of this grant; and,

WHEREAS, Ordinance No. 56-99, passed May 17, 1999, approved the Suburban Court Services grant application for federal funds under the Victims of Crime Act ("VOCA") through the office of the Ohio Attorney General's Office and agreed to participate in funding a portion of the local share up to \$15,056.34 for Sylvania's share of this grant; and,

WHEREAS, by Ordinance No. 17-2001, passed February 20, 2001, the City of Sylvania agreed to participate in a portion of the local share funding of Suburban Court Services which portion of funding increased to \$36,568.14 for the year 2001 due to the expiration of funding through the Byrne Memorial Grant and also included a three percent per year increase over the duration of the Agreement through September 30, 2003; and,

WHEREAS, by Ordinance No. 25-2004, passed March 15, 2004, the City of Sylvania agreed to participate in a portion of the local share funding of Suburban Court Services from October 1, 2003 through September 30, 2004 in the amount of \$38,795.14; and,

WHEREAS, by Ordinance No. 94-2004, passed November 15, 2004, the City of Sylvania

agreed to participate in a portion of the local share funding of Suburban Court Services from October 1, 2004 through September 30, 2005 in the amount of \$38,795.14; and,

WHEREAS, by Ordinance No. 97-2006, passed October 2, 2006, the City of Sylvania agreed to participate in a portion of the local share funding of Suburban Court Services from October 1, 2006 through September 30, 2007 in the amount of \$9,635.00, which price decrease was a result of the City now providing office space and supplies; and,

WHEREAS, since 2008, the City of Sylvania has participated in a portion of the local share funding of Suburban Court Services in the amount of \$25,000; and,

WHEREAS, the City of Sylvania has received a request for funding Suburban Court Services in the amount of \$25,000.00 for October 1, 2023 through September 30, 2024.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, _____ members elected thereto concurring:

SECTION 1. That City of Sylvania hereby agrees to participate in funding a portion of the local share in an amount of not to exceed Twenty-Five Thousand Dollars (\$25,000.00) for the year October 1, 2023 – September 30, 2024.

SECTION 2. That the Mayor and Director of Finance be, and they hereby are, authorized to evidence such approval and agreement by signing such documents as may be necessary and the Clerk of this Council is hereby authorized and directed to certify a copy of this Ordinance and provide such certified copy to Judge Bonfiglio.

SECTION 3. That to provide funds for said services hereby authorized, there is hereby appropriated from the GENERAL FUND from funds therein not heretofore appropriated to Account

No. 110-7740-51295 - LCCPC Board Services the total sum of Twenty-Five Thousand Dollars (\$25,000.00).

SECTION 4. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this

Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City.

SECTION 6. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that funding for Suburban Court Services should be provided for immediately. Provided this Ordinance receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force thirty (30) days after it is approved by the Mayor or as otherwise provided by the Charter.

AGREEMENT BETWEEN THE CITY OF SYLVANIA AND THE BOARD OF LUCAS COUNTY COMMISSIONERS FOR THE SUBURBAN COURT SERVICES PROGRAM

This agreement executed this ____ day of January, 2024 by and between the City of Sylvania, Ohio and the Board of Lucas County Commissioners (Lucas County), political subdivisions of the State of Ohio.

WHEREAS, since 1997 the parties have participated in the Suburban Court Services Program which provides victim advocacy services to victims and witnesses of misdemeanor crimes in the participating courts; and,

WHEREAS, all parties desire to continue the Suburban Court Services Program;

NOW, THEREFORE, the parties to this contract agree to the following terms and conditions:

- 1. The Board of Lucas County Commissioners shall administer the program through the Lucas County Prosecutor's Office.
- 2. Subject to the provisions of paragraph 5, the term of the Suburban Court Services Program shall be from October 1, 2023 through September 30, 2024, coinciding with the funding from the Victims of Crime Act.
- 3. The City of Sylvania shall pay the Board of Lucas County Commissioners the sum of \$25,000 to be used as matching dollars for the VOCA grant and for the use of the services of the program during the contract period.
- 4. The matching dollars needed are to coincide with a federal funding period which is October 1, 2023 through September 30, 2024.
- 5. Lucas County may cancel or modify this agreement, without prior notification, if there is a termination or change in the amount of funding from the Victims of Crime Act. Lucas County may cancel the agreement, after having given the other parties 60 days written notice. A municipality may terminate its participation in this agreement, after having given the other parties 60 days written notice.

The bidding documents for the above referenced projects are complete.

The scope of work includes milling and resurfacing McCord Road from Sylvania Avenue to Brint Road including new pavement markings.

The estimated construction cost is \$706,874 of which \$159,047 is being funded by an Ohio Public Works Commission (OPWC) grant and \$500,000 is being funded by a Surface Transportation Block Grant (STBG) through the Ohio Department of Transportation. The anticipated local share is \$47,827.

This is a programmed capital improvement expense for 2024 utilizing fund account 401-7610-53614. The Service Department will advertise for bids beginning on February 26, 2024 with an opening scheduled for March 18, 2024. Construction is scheduled to occur anytime June 1 thru August 15 to best align with the McCord Junior High summer break.
