Angola/Frankfort-Silica-Summit-Maplewood-Erie Resurfacing

Dear Mr. Mayor and Council Members:

On February 20, 2024 City Council authorized the Service Department to enter into a joint-cooperation agreement with the Lucas County Engineer for the administration of Ohio Public Works Commission (OPWC) loan/grant funds for the Angola Road, Frankfort Road, McCord Road, Silica Drive, Summit Street, Maplewood Avenue, and Erie Street Resurfacing Project (Ord. 18-2024). The City scope of work would resurface Silica Drive from 1,200 feet north of Convent Boulevard to Tenmile Creek, Summit Street, Maplewood Avenue between Main Street and Summit Street and Erie Street between Main Street and Summit Street. Construction is scheduled for 2025.

As a part of the joint cooperation agreement, each entity would be responsible for conducting the engineering and construction plan preparation work for their respective portions of the project. The City requested an engineering proposal from Feller Finch Associates, Inc. from Maumee, Ohio. Feller Finch provided the same engineering services for the City on the last joint-cooperation agreement project with Lucas County on the Brint Road Resurfacing Project, completed in 2023.

Feller Finch's proposal to provide topographic field survey and engineering on all four (4) roadways was in the amount of \$21,400. We would recommend approval of Feller Finch and Associates, Inc. proposal in the amount of \$21,400. These funds were included in the 2024 budget and were programmed using account 401-7610-53503. #### **ORDINANCE NO. 29-2024**

ACCEPTING THE PROPOSAL OF FELLER FINCH & ASSOCIATES, INC. TO PROVIDE PROFESSIONAL ENGINEERING SERVICES FOR THE ANGOLA, FRANKFORT, McCORD, SILICA AND SUMMIT RESURFACING PROJECT; APPROPRIATING FUNDS THEREFORE IN THE AMOUNT OF \$21,400; AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance No. 18-2024, passed February 20, 2024, authorized the Mayor and Director of Finance to enter into a Joint Cooperation Agreement on behalf of the City of Sylvania with the Board of Lucas County Commissioners relative to the Angola, Frankfort, McCord, Silica and Summit Resurfacing Project and appropriated \$395,944 for the City's portion of said project; and,

WHEREAS, the terms of the Agreement requires each entity to conduct engineering and construction plan preparation work for their respective portions of the project; and,

WHEREAS, the Director of Public Service, by report dated March 4, 2024, has received a proposal from Feller Finch to provide engineering and surveying services and to prepare the necessary construction plans for the proposed resurfacing improvements; and,

WHEREAS, the Director of Public Service, by report dated March 4, 2024, has recommended that the proposal in the amount of \$21,400 for the professional engineering and construction plan services relative to the Angola, Frankfort, McCord, Silica and Summit Resurfacing Project be accepted.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, \_\_\_\_\_ members elected thereto concurring:

SECTION 1. That the proposal of Feller Finch in the amount of Twenty-One Thousand Four Hundred Dollars (\$21,400.00) for providing professional engineering services, including the preparation of necessary construction plans for the Angola, Frankfort, McCord, Silica and Summit Resurfacing Project, is hereby approved and accepted.

<u>SECTION 2.</u> That the Director of Public Service shall promptly give notice to said engineers to proceed under the proposal hereby approved and accepted.

<u>SECTION 3.</u> That to provide funds for said engineering services hereby authorized, there is hereby appropriated from the **CAPITAL IMPROVEMENT FUND** from funds therein not heretofore appropriated to **Account No. 401-7610-53503 – Street Improvements** the

amount of Twenty-One Thousand Four Hundred Dollars (\$21,400.00).

SECTION 4. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City.

SECTION 6. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that the City should provide for the engineering services for the Angola, Frankfort, McCord, Silica and Summit Resurfacing Project at the earliest possible time. Provided this Ordinance receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force thirty (30) days after it is approved by the Mayor or as otherwise provided by the Charter.

You will be expected to provide us with any information regarding additional requirements, including any special or extraordinary considerations for the project or special services needed. Our services will consist of the following:

- Prepare plans for the milling and resurfacing of the roads.
- Specifications for spot full depth repairs where needed.
- Necessary adjustments to manholes, valves, and roadway monuments.
- Upgrade deficient curb ramps.
- The plans will include the following:
  - o Title sheet
  - General notes
  - Typical sections
  - General summary
  - o Plan sheets
- Provide field survey as needed to prepare the plans. Existing plan records will be utilized where possible.
- Submittal of drawings and preliminary cost estimate to the City at the 50% level for review.
- Submittal of drawings and finalized cost estimate at the 100% level. Final submittal shall include:

  - Cost estimate

Our fees for the services described above will be time and expense, not to exceed \$21,400.00. The project is anticipated to include the following man hours: 30 survey hours, 125 engineer hours and 45 technician hours.

Additional or non-customary services and resident services during construction will be charged based on our current hourly rates. We will invoice you monthly for our services and reimbursable expenses.

The above financial arrangements are on the basis of prompt payment of our invoices and continuous progress of the Project through construction. Invoices that remain unpaid for more than thirty (30) days after the invoice date will be charged a service/finance charge of 1-1/2% per month. **We reserve the**

The construction plans for the proposed traffic signal installation at Harroun Road and Ravine Drive with a newly relocated Flower Hospital driveway (PID 116375) has advanced through Stage 3 plan development. The final right-of-way plans for the lone parcel on the east side of Harroun Road are completed and the City was authorized to begin the right-of-way acquisition for this parcel on October 27, 2023.

In order to accommodate the roadway improvements, the Service Department needs to acquire a temporary construction easement from Crestview of Ohio, Inc., an Ohio corporation, now known as ProMedica Continuing Care Services Corporation (Ownership 001 in the Right-of-Way Plan on file with the Service Department). The temporary construction easement take of 1.858 acres is along the east side of Harroun Road across from Ravine Drive. The temporary construction easement allows the City the right to enter and complete the necessary scope of work beyond the right-of-way over a 12-month period and includes the construction of Flower Hospital's new main entrance driveway including grading and drainage work.

The City has reached an agreement with the owner in consideration of \$101,215.00. WHEREAS, Crestview of Ohio, Inc., n/k/a ProMedica Continuing Care Services Corporation is entitled to receive payment of just compensation representing the fair market value of the temporary easement after an appraisal of those rights and they have executed and delivered a grant of temporary easement to this City for which they will be paid the sum of One Hundred One Thousand Two Hundred Fifteen Dollars (\$101,215.00), a copy of which grant of temporary easement is attached hereto as "Exhibit A"; and,

WHEREAS, said grant of temporary easement is presented to this Council for acceptance and for appropriation of funds and authorization of payment thereof to the Grantor.

(herein, the "Owner") this plan letter attachment ("Plan Letter Attachment") and a print of the right of way plan sheets applicable to the Easement Property (defined below) and associated construction plan sheets, if applicable (Plan Sheets Dated 8/11/23 and identified as "Compliance R/W Submittal 10/26/2023" prepared by DGL Consulting Engineers, covered by "Right Of Way Legend Sheet LUC -TR-77-0.54" and consisting of seven (7) total pages inclusive of the said Legend Sheet, referred to here as the "Plan Drawings"). Parcel 001-T is defined as a Temporary Construction Easement to be acquired in the name of and for the use by the City of Sylvania, Ohio. This identifier is used to designate an area of temporary usage, where permanent Right of Way is not required. For this acquisition, the temporary easement is needed to provide room for grading and completion of the improvements described in this Plan Letter Attachment.

We subsequently prepared the attached agreement to assist the homeowner in removing the emitter and removing the hazardous street conditions.

The attached agreement is a 5-year agreement with the homeowner whereby the payments will be added to the homeowner's monthly utility bill until paid in full. Should payments not be made, the City will file a lien on the property until the costs have been paid in full. We recommend approval of this agreement.

AGREEMENT WITH THE OWNERS OF A SINGLE-FAMILY RESIDENCE LOCATED ON A LOT OR PARCEL OF REAL ESTATE TO BE CONNECTED TO THE CITY OF SYLVANIA STORM SEWER SYSTEM FOR THE INSTALLMENT PAYMENT OF STORM SEWER TAP FEES, CONNECTION FEES, AND THE COST OF THE STORM SEWER SERVICE LINE INSTALLED BY THE CITY OF SYLVANIA.

WHEREAS, the undersigned represents that it is the owner in fee simple of the real estate described on "Exhibit A" attached hereto and made a part hereof or the undersigned collectively represent that they own said real estate in fee simple and include all those having any dower rights therein, in which case all references herein to the undersigned shall be construed to refer to all of those comprising the undersigned whether singular, plural, male, female or neuter; and,

WHEREAS, the undersigned propose to connect a main building consisting of a single-family residence(residence) located on said real estate to a City of Sylvania(City) storm sewer located in the street on which said real estate fronts; and,

WHEREAS, said real estate lies inside of the CITY; and,

WHEREAS, Sylvania Municipal Code 929.26 establishes that 'Stormwater and all other unpolluted drainage shall be discharged to such sewers as are specifically designated as storm drain or to a natural outlet approved by the Director and other regulatory agencies."; and,

WHEREAS, the existing storm water discharge is not in compliance with Sylvania Municipal Code 929.26; and,

WHEREAS, the undersigned desires to connect said real estate so that the residence thereon will be served by a storm sewer connecting to the storm sewer facilities constructed by the City; and,

WHEREAS, the City, on the request of the undersigned, has indicated its willingness to cooperate with the undersigned by permitting, on conditions hereinafter set forth, the residence located on a lot or parcel consisting of said real estate, to be connected to the storm sewer installed in the street on which said real estate fronts; and,

WHEREAS, the undersigned understands that such cooperation by the City is conditional upon said City being satisfactorily assured of the payment to it, with respect to storm sewers and said real estate, of such connection fees established for said storm sewer system as may now or hereafter be applicable to said real estate by the Codified Ordinances and/or rules of said City and this Agreement.

NOW, THEREFORE, in consideration of said City permitting said real estate and the main building lawfully constructed thereon consisting of a single-family residence, to be connected to said City's storm sewer system, the undersigned, for itself, its successors and assigns, or themselves, their heirs and assigns, hereby agree(s) as follows:

- 1. With respect to said real estate, to pay to the City of Sylvania, Ohio, a connection fee with respect to such single family residence thereon, pursuant to Section 929 of the Codified Ordinances of the City of Sylvania, Ohio, and the applicable cost of connection established for said real estate totaling \$4,050.00 plus interest at the rate of 1.85% per annum in equal monthly installments of \$70.72 over a five-year period computed and payable on the monthly utility bill of said real estate and the first installment payment is due in April, 2024. The last installment payment to be due in March, 2029 barring early payment by the owner of said real estate.
  - 2. At such time as said real estate, if any part thereof, is no longer owned by the

undersigned or any one of them, the entire unpaid balance of the connection fee plus interest theron as aforesaid shall be paid to the City. This document, as of the date of execution and recording in the office of the Recorder of Lucas County, Ohio, shall constitute a lien against said real estate in favor of the City of Sylvania, Ohio, for the full amount of the connection fee plus interest. The City of Sylvania is hereby granted the right and authority to foreclose such lien as any other liens upon real estate are or may be foreclosed and to recover in such foreclosure action the unpaid amount of such lien including interest and the amount of all expenses in connection with the lien and foreclosure including, but not limited to, lien recording fees, title expense, attorney fees and court costs.

- That the City of Sylvania is hereby granted the right and authority to impose upon each lot of which said real estate is comprised, a lien or liens, from time to time, for any and all storm sewer services charges, authorized by the Codified Ordinances of the City of Sylvania, Ohio, including, but not limited to be levied and assessed upon each lot, parcel of land, building or premises having any sewer connection with the storm sewer system of the City, which charges have been billed by said city and have remained unpaid for a period of more than twenty (20) days after the billing date, including any penalty thereon, and is hereby granted the right and authority to foreclose such lien or liens from time to time, as any other liens upon real estate are or may be foreclosed and to recover in such foreclosure action the amount of such lien or liens including any penalty on such charges and the amount of all expenses in connection with the lien and foreclosure including, but not limited to, lien recording fees, title expense, attorney fees and court costs and also interest on all of the same at Eight per cent (8%) per annum from the date of recording of such lien or liens as to the amount stated in the certificate of lien hereinafter mentioned and from the date such expense is incurred as to such expense. Any such lien may be perfected in favor of the City of Sylvania, Ohio, and shall be considered so perfected for all purposed by said City causing through its Director of Public Service, a Certificate of Lien, in the form hereinafter set forth: (1) to be completed with the information indicated in such form as sufficient to identify the premises having received such storm sewer services, to establish the period such services were received, to establish the dollar amount of such services billed and unpaid for more than twenty (20) days including any penalty and to identify the Directors of Public Service and Law of said City; (b) to be executed with such formality as will entitle said Certificate to be accepted for recording by the Recorder for Lucas County Ohio; and, (c) after being so completed and executed, to be recorded in the Office of the Recorder of Lucas County Ohio, which form is included in this agreement.
- 4. That any and all storm sewers installed in said real estate in public streets, roads or easements, or in such areas that become public streets, roads, or easements, and which connect to or discharge into said City's storm sewer system, shall become the property of said City, which may operate and maintain such sewers.
- 5. That all portions of the Codified Ordinances of the City of Sylvania, Ohio, 1979, as amended, and of the Rules of the City of Sylvania, Ohio, in any way pertaining to storm sewers, as such Codified Ordinances and Rules now exist and as they or any of them may be made to exist in the future, are hereby expressly made applicable to all storm sewers installed in said real estate and applicable to the respective owner or owners of said real estate.
- 6. That as to a lot, subdivision or premises of said real estate for which or with respect to which a building permit or a storm sewer tap permit has been issued by any public authority or as to any lot, subdivision or premises of said real estate which is or becomes connected to said City's storm sewer system or a storm sewer discharging thereto, the City of Sylvania shall be deemed conclusively and for all purposes, to have fully performed all portions of this Agreement to be performed by it as consideration therefore.
- 7. If any part, clause, provision or condition of this Agreement is held to be void, invalid, or inoperative, such voidness, invalidity or inoperativeness shall not affect any other cause, provision or condition hereof; but the remainder of this Agreement shall be effective as though such clause, provision or condition has not been contained herein.
- 8. This Agreement shall bind the heirs, successors and assigns of the undersigned, shall bind said real estate and run with the land, and shall unsure to the benefit of the City of Sylvania, Ohio, its successors and assigns.

PLUMMER POOL IMPROVEMENTS

Dear Mr. Mayor and Council Members:

The City has been working with the Sylvania Area Joint Recreation District(SAJRD) in a joint agency project to improve Burnham Park and Plummer Pool. SAJRD was the lead agency for the Burnham Park portion of the project and the City served in a support and construction capacity.

The next phase of the project which includes improvements to Plummer Pool is ready to move forward. These improvements include the replacement of the pool filtration and pumping systems, bath house improvements including a new community room within the existing structure, concession improvements, and modifications to the restrooms to make them ADA accessible.

The total cost of the Plummer Pool improvements is estimated to be \$544,368. A breakdown per the attached agreement is as follows:

State Capital Grant(55%)	\$300,000
City of Sylvania((27%)	\$149,634
SAJRD(18%)	\$ 94,734
TOTAL	\$544,368

It is SAJRD's intent to complete the Filtration Room Improvements prior to the summer operating season. The remainder of the project will be completed in either late 2024 or early 2025. The Service Department will be back before Council for approval of the remainder of the project once a schedule is better determined. ### **ORDINANCE NO. 34-2024**

AUTHORIZING THE MAYOR AND DIRECTOR OF FINANCE TO ENTER INTO A JOINT COOPERATION AGREEMENT ON BEHALF OF THIS CITY OF SYLVANIA WITH THE SYLVANIA AREA JOINT RECREATION DISTRICT ("SAJRD") RELATIVE TO THE PLUMMER POOL IMPROVEMENT PROJECT; AND DECLARING AN EMERGENCY.

WHEREAS, the City and the Sylvania Area Joint Recreation District ("SAJRD") have been collaborating to improve Burnham Park and Plummer Pool; and,

WHEREAS, the improvements to Burnham Park have been completed and the Plummer Pool Improvement Project is ready to begin; and,

WHEREAS, the Plummer Pool Improvements include the replacement of the pool filtration and pumping systems, bath house improvements, including a new community room within the existing structure, concession improvements and modifications to the restrooms to make them ADA accessible; and,

WHEREAS, the Director of Public Service, by report dated March 4, 2024, has recommended approval of the Joint Cooperation Agreement for the Plummer Pool Improvements, estimated to cost \$544,368, with the City's portion of the improvements estimated to be \$149,634.

### JOINT COOPERATION AGREEMENT

### **FOR**

### PLUMMER POOL IMPROVEMENTS

This Agreement by and between the City of Sylvania, Ohio, hereinafter referred to as the CITY, and the Board of Sylvania Area Joint Recreation District, hereinafter referred to as SAJRD.

### WITNESSETH

WHEREAS, the CITY and SAJRD both have a vested interest in the leisure activities available to Sylvania citizens and have cooperated in past operations at Plummer Pool, and

WHEREAS, the CITY and SAJRD entered into a lease agreement for the operation and maintenance of Plummer Pool on June 20, 2022 via Ordinance 58-2022, and

WHEREAS, the CITY and SAJRD desire to improve the pool filtration system and bath house facilities at Plummer Pool, hereinafter referred to as the PROJECT, and

WHEREAS, the CITY and SAJRD agree the construction of said PROJECT would be beneficial to the citizens of the CITY and users of SAJRD facilities, and

WHEREAS, through a joint effort by the CITY and SAJRD, the CITY has obtained Ohio Community Recreation/Conservation Project Pass-Through Grants, hereinafter referred to as GRANT, for the PROJECT, and

WHEREAS, the CITY and SAJRD desire to conclude an agreement which will accomplish the construction of said PROJECT,

NOW, THEREFORE, the CITY and SAJRD do hereby agree as follows:

1. The **CITY** will act as the lead agency for the detailed construction plans, specifications and design phase of the **PROJECT**.

- 2. The **CITY** will administer the **GRANT** for the **PROJECT**.
- 3. The **CITY** will advertise for bids and administer the construction contracts for the **PROJECT** with **SAJRD** assistance.
- 4. The CITY will be listed as project manager on the GRANT Funding agreements. The CITY will process payments to the contractor(s) and process the GRANT disbursement requests.
- 5. The total cost of the **PROJECT** is estimated to be \$544,965 as shown on page 4 of this agreement. The **GRANT** will be in the amount of \$300,000. The **CITY** shall be responsible for \$149,634 of the **PROJECT**. **SAJRD** shall be responsible for \$94,734 of the **PROJECT**. Page 4 of this agreement itemizes the responsibilities of each party for various portions of the **PROJECT**. Any modifications due to actual construction costs shall adjust each party's share proportionally.

The CITY will invoice SAJRD for its local share after the construction contract is completed.

6. It is the intent of this Agreement that the CITY and SAJRD shall each properly and expeditiously discharge any requirements that may devolve upon them from time to time during the period this Agreement will be in force.

- 1. City is the owner of a shredder with an approximate value of \$50,000.
- 2. Contractor has agreed to accept the shredder equipment in exchange for payment of one year of green yard waste and compost services.
- 3. The Agreement shall be under the same terms and conditions as the original Agreement, however, the payment schedule shall be modified as follows:

May, 2024 – May, 2025: No Payment Due in Exchange for the Shredder Equipment

June, 2025 – September 30, 2026: \$52,020 annually, payable in equal quarterly Installments.

- 4. In the event Sylvania Compost & Recycling, LLC ceases operation prior to May, 2025, the cost of the shredder shall be prorated and Sylvania Compost & Recycling shall remit the balance due to the City of Sylvania within thirty (30) days of ceasing operation. For example, if Sylvania Compost & Recycling ceases operation in December, 2024, the total amount due to the City for the cost of the shredder shall be \$21,250 (\$4,250/month x 5 months = \$21,250).
- 5. Except as amended herein, all terms, covenants and conditions of the Agreement are now and shall continue to be and remain in full force and effect.

The Police Division is requesting authorization to purchase a new vehicle to be placed in road patrol portion of their fleet.

The new vehicle is a 2025 Ford Explorer that would be purchased from Baumann Ford Oregon in compliance with the Ohio State Cooperative Purchasing Program for the purchase price of \$46,595.94. The vehicle will be used by the road patrol as a stealth type vehicle. ### **ORDINANCE NO. 38-2024**

APPROVING THE BANNER APPLICATION OF LOURDES UNIVERSITY; AUTHORIZING THE ZONING ADMINISTRATOR TO INDICATE SUCH APPROVAL ON BEHALF OF THE CITY OF SYLVANIA; AND DECLARING AN EMERGENCY.

WHEREAS, Resolution No. 19-2000, passed June 5, 2000, granted permission to install banners in the public right-of-way on the Toledo Edison poles located on Monroe Street by Wendy's across to the area in front of Country Squire Plaza (near the intersection of Corey Road and Monroe Street); and,

WHEREAS, Resolution No. 19-2000 provided that the applications were to be reviewed on an application-by-application basis and set forth the criterion on which the applications were to be considered; and,

WHEREAS, Ordinance No. 20-2018, passed May 21, 2018, amended Part Eleven – Planning and Zoning Code of the Codified Ordinances of Sylvania, 1979, as amended, by amending Section 1166.07 – Standards for Permitted Signs to permit banners to be installed in the downtown; and,

WHEREAS, Lourdes University has submitted a request to hang a banner within said public right-of-way to promote the Lourdes University 2024 Spring Commencement on May 4, 2024; and,

WHEREAS, the banner will hang from April 21, 2024 – May 15, 2024 and will comply with all of the terms and conditions set forth in Resolution No. 19-2000 and Ordinance No. 20-2018.

NOW, THEREFORE BE IT ORDINANCE by the Council of the City of Sylvania, Lucas County, Ohio, \_\_\_\_\_ members elected thereto concurring:

SECTION 1. That the application of Lourdes University to hang a banner on across the

downtown block of Main Street between Maplewood Avenue and Monroe Street is found to comply with Section 1166.07(h)(2)(A)(1) and is hereby approved.

- SECTION 2. That the Zoning Administrator is authorized to sign said permit granting permission to proceed under the application hereby approved.
- SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- SECTION 4. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City.
- SECTION 5. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that permission should be granted immediately to provide for the installation of the banner. Provided this Ordinance receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force thirty (30) days after it is approved by the Mayor or as otherwise provided by the Charter.
