We received five (5) bids on March 18, 2024 for the above referenced project. The lowest bid was submitted by Bowers Asphalt and Paving, Inc. of Walbridge, Ohio. Their bid of \$188,823.10 is approximately 27.1% under the Engineer's Estimate of \$258,915.

Bowers Asphalt has performed several resurfacing projects in the City including Arbor Way (2014), Brookhill Court (2019), Centennial Crossings Plat Four (2019) & Five (2020), Veteran's Memorial Field Woodrow Child Care Center paving for SAJRD (2021), and Tantallon Plat I & II Resurfacing (2023).

Therefore, it is our recommendation that the contract be awarded to Bowers Asphalt and Paving, Inc. of Walbridge, Ohio in the amount of \$188,823.10.

Dear Mr. Mayor and Council Members:

The Service Department requested City Council authorization to advertise for bids on the LUC-CR 73-5.43 (PID 118134) project at the February 5, 2024 meeting. This is the ODOT Local-Let resurfacing project on McCord Road between Sylvania Avenue and Brint Road. The City received four (4) bids on March 18, 2024.

The published engineer's estimate was \$709,815. The apparent low bidder was Henry W. Bergman, Inc. from Genoa, Ohio with a bid of \$685,765.00 (3.4% under estimate). The 2<sup>nd</sup> lowest bid received was from Gerken Paving, Inc. with a bid of \$686,103.25 (3.3% under estimate).

Henry W. Bergman has successfully completed the post-bid documentation review with ODOT and their bid meets with their requirements. Henry W. Bergman is an ODOT pre-qualified contractor with previous asphalt pavement resurfacing experience on ODOT Local-Let projects. The last asphalt resurfacing project Henry W. Bergman performed for the City was on the north/south section of Silica Drive north of Convent Boulevard in 2019.

This project was anticipated as part of our 2024 Capital Improvement plan and will be paid via account 401-7610-53614. Therefore, it is our recommendation that the contract be awarded to Henry W. Bergman, Inc. in the amount of \$685,765.00.

Waterline improvements to Balfour Road are ongoing with over 75% of the waterline installed to date. The Service Department is requesting a project change order for several new work items that are required as a part of the construction project.

Below is a summary of the items included in this change order request:

- CO#1 The contractor has discovered four (4) unrecorded sewer connections in conflict with waterline trench footprint. A new pay item with a unit cost of \$664.84/each was established to reconnect each connection encountered thus far and for any other connections found as waterline construction continues (\$2,659.36).
- CO#2 Removal of the large 56" Cottonwood Tree near the waterline trench at 5682 Balfour (\$6,825.00).
- CO#3 Removal and replacement of deteriorated storm sewer piping and catch basins at the intersection of Balfour Road and (Old) Alexis Road as a lump sum item (\$12,179.83).

As a result, a total change order in the amount of \$21,664.19 is necessary to increase the contract amount from \$761,024.40 to \$782,688.59. Please call if you have any questions.

1. Why is the work necessary?

The contractor and Service Department agree that a 56" Cottonwood Tree located outside of the existing right-of-way at 5682 Balfour Road needs to be removed due to pending root damages that will occur as a result of waterline trenching operations. The Service Department will obtain a Work Agreement from the property owner to have the tree removed.

The plans contain an existing pay item for Item 201 – Tree Removed, 48", which according to the ODOT Construction and Materials Specifications should include trees 36" thru 60" in diameter.

Dear Mr. Mayor and Council Members:

The Service Department has had recent success in utilizing Federal Surface Transportation Block Grant (STBG) funds to help reconstruct sections of Main Street. In 2018, STBG funds were used to reconstruct Main Street between Monroe Street and Tenmile Creek. In 2024, STBG funds will be used to reconstruct the next section of Main Street between Tenmile Creek to just south of Ravine Drive. These Federal grants were used to leverage additional state resources from the Ohio Public Works Commission (OPWC) to further reduce the burden to our local capital improvement program.

The Toledo Metropolitan Area Council of Governments (TMACOG) has advised its membership that the next solicitation for STBG projects to program the 2027 thru 2029 pipeline in the Transportation Improvement Program (TIP) will begin in May with applications due in July. As a result, the Service Department would like to begin the planning efforts to reconstruct the next section of Main Street between just south of Ravine Drive to just south of Convent Boulevard.

The Service Department has requested a proposal from Tetra Tech to provide a construction cost estimate within these limits. The scope of work also includes preparing a conceptual exhibit that would include a single lane roundabout at the intersection of Main Street and Convent Boulevard to replace the existing traffic signal. The cost estimate and exhibit will be used in the STBG grant application later this year.

The Tetra Tech proposal is in the amount of \$4,000 to complete these services with funding to be provided from account 222-7610-51250. As a result, we would recommend approval of the Tetra Tech proposal in the amount of \$4,000. Please call with any questions.

Re: Ten Mile Creek / Ottawa River Maintenance Petition #1053

Dear Mr. Mayor and City Council Members,

As you may be aware the Lucas County Engineers Office has requested that the Joint Board of Lucas and Fulton County Commissioners approve placing Ten Mile Creek and Ottawa River under a ditch maintenance petition. This petition will assess all properties within the watershed areas of the two waterways to provide funds to better maintain the ditch/river for improved flow during storm events.

Properties in the City that are part of this watershed area will be included in the above assessment. A large majority of the City is within this watershed. The City will also be assessed for our portion of hard surface right-of-way, or in other words, our streets. The Lucas County Engineer has informed us that the assessments to be collected from all properties within the City is estimated at \$160,000. The total assessments to be collected from the entire watershed area is estimated to be \$2.55 million.

The City has two options regarding the implementation of the assessments:

- 1. The City can choose to pay the assessments for all of the properties in the City. If this option is chosen we would recommend utilizing our Storm and Ditch Maintenance fee, adjusting that fee as Council may desire.
- 2. The City can simply allow the county assessments to be billed to our residents on their tax bill. The Engineers office has indicated an assessment of approximately \$7 for the average household.

If Option 1 is selected by the City, the costs associated with our existing maintenance activities can be monitored and invoiced to the Joint Board of County Commissioners as reimbursable expenses that fall within the maintenance activity of the petition. City staff already performs much maintenance of the ditches and tributaries within the City. The Sewer department staff maintains these ditches with activities such as stream bank stabilization, removing log jams and debris, and responding to random requests throughout the year. The reimbursable maintenance costs would include city personnel cost, equipment cost, subcontractor cost, etc. that pertain to Ten Mile Creek, Ottawa River, and any of their tributaries.

To date we haven't tracked our activity to the detail that will be needed, but, it is conservatively estimated that our total cost of maintenance is approximately \$100,000. This would leave the City with a balance of \$60,000 that will not be recouped. These costs could then be recovered via the City's Storm and Ditch

Maintenance Fee. If Option 1 is chosen, our residents would see just one Storm & Ditch Maintenance Fee on their tax invoices.

If Option 2 is selected, the City will not have the ability to recoup our maintenance costs. The City would then have a different decision to make. Either a) continue to perform our maintenance activities without reimbursement or b) cease our maintenance operations and rely on the Lucas County Engineers office to perform such functions. If Option 2 is chosen, our residents would see a Storm & Ditch Maintenance Fee from the City and a Ditch Maintenance Fee from the County on their tax invoices.

The City is required to notify the County Commissioners of our decision 30 days prior to notices being sent to affected properties for the final public hearing. This is anticipated to take place in July of 2024. This would require our decision to be made by the end of May in order to provide sufficient notice. The attached Ordinance will be required to be passed if Option 1 is chosen. No action is needed if Option 2 is preferred.

# **ORDINANCE NO. 57-2024**

DECLARING THE INTENT OF THE CITY OF SYLVANIA TO ASSUME AND PAY ASSESSMENTS FOR THE TEN MILE CREEK/OTTAWA RIVER DITCH PETITION #1053; AUTHORIZING THE MAYOR AND DIRECTOR OF FINANCE TO NOTIFY THE JOINT BOARD OF FULTON AND LUCAS COUNTY COMMISSIONERS OF SUCH INTENT; AND DECLARING AN EMERGENCY.

WHEREAS, a petition for assessments for improvements to the Ten Mile Creek/Ottawa River Ditch Petition has been submitted to the Joint Board of County Fulton and Lucas County Commissioners; and,

WHEREAS, if enacted, the revenue collected from the assessments will allow for the maintenance of Ten Mile Creek/Ottawa River and its tributaries and will include projects that include log jam removal and other projects necessary to maintain the waterway, promote stabilization, reduce sedimentation, and improve water quality; and,

WHEREAS, Ohio Revised Code Section 6131.23(D) permits a municipality to assume the assessments on behalf of its residents and permits the municipality to pay the assessments through the performance of projects on the petitioned ditches, through other municipal funds authorized for the purposes of the assessments, or by assessing all or a portion of the assessments to property owners; and,

WHEREAS, it is the intent of the City of Sylvania to pay the assessments from funds collected through the Storm and Ditch Maintenance Fee for properties within the City of Sylvania.

NOW, THEREFORE BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, \_\_\_\_\_ members elected thereto concurring:

SECTION 1. That it is the intent of the City of Sylvania to assume and pay the annual ditch assessments for parcels within the City of Sylvania for the Ten Mile Creek/Ottawa River Ditch Petition #1053.

SECTION 2. That the Mayor and Director of Finance are authorized to notify the Joint Board of Fulton and Lucas County Commissioners of the intent to assume and pay the annual ditch assessments for the Ten Mile Creek/Ottawa River Ditch Petition #1053.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Provided this Ordinance receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force thirty (30) days after it is approved by the Mayor or as otherwise provided by the Charter.

Dear Mr. Mayor and Council Members:

As you are aware, the City recently sold the vacant property at the northwest corner of the Harroun Road and Holland-Sylvania Road intersection (4827 Holland-Sylvania Road). The vacant property consists of four (4) parcels identified as Lucas County Tax District Parcel numbers 82-00008, 82-00009, 82-00010, and 82-00011.

The Service Department is planning an intersection improvement project in 2028 to convert this intersection from a traffic signal to a modern roundabout. This improvement project would coincide with an already funded Congestion Mitigation and Air Quality (CMAQ) roundabout project in 2028 at the intersection of Brint Road and Harroun Road (LUC-Brint-Harroun Roundabout, PID 120824).

The Service Department would like to formally dedicate the necessary right-of-way that would be needed on this property for the roundabout project. The new owner is agreeable to this dedication. The conceptual roundabout footprint calls for a new road to be added to the west side of the intersection. This road would be publicly dedicated with a standard sixty (60) foot right-of-way, provide driveway access to the adjoining properties, and help with Holland-Sylvania Road access management.

The Service Department received a proposal from DGL Consulting Engineers, LLC in the amount of \$10,285 to provide professional surveying services with the goal of preparing a right-of-way dedication plat for formal recording with the Lucas County Recorder's Office. The dedication plat process would follow Ohio Revised Code Chapter 711 and Sylvania Municipal Code Chapter 1177. Funding for these services would be from account 222-7610-51250. As a result, we would recommend approval of the DGL proposal in the amount of \$10,285. Please call with any questions.

AUTHORIZING THE MAYOR AND DIRECTOR OF FINANCE TO ENTER INTO A CUSTOMER SUPPLY AGREEMENT WITH ARCHER ENERGY FOR THE PROVISION OF NATURAL GAS TO RESIDENTIAL AND SMALL COMMERCIAL CUSTOMERS WITHIN THE CITY OF SYLVANIA BEGINNING IN OCTOBER, 2024; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Sylvania is approved by the Public Utilities Commission of Ohio ("PUCO") as an opt-out government aggregator for natural gas and is a member of the Northwest Ohio Aggregation Coalition ("NOAC"); and,

WHEREAS, since 2003, NOAC has saved residents and small business customers in the aggregation over \$20,000,000 on their natural gas bills versus the Columbia tariff price; and,

WHEREAS, Ordinance No. 33-2022, passed by Sylvania City Council on March 7, 2022, authorized the Mayor and Director of Finance to enter into a Customer Supply Agreement with Constellation to act as the City's Natural Gas Aggregation supplier for a twenty-four month period beginning in June, 2022 and ending in May, 2024; and,

WHEREAS, in anticipation of the expiration of our current Agreement with Constellation, NOAC's consultant, Palmer Energy, recently issued a request for proposals and received two responses from one supplier, however, neither of those original offers resulted in an estimated savings over the Columbia Gas pricing for the NOAC customers; and,

WHEREAS, after the communities' meeting with Palmer Energy to review the proposals, Palmer Energy received a proposal from Archer Energy for a 20-month period that will result in savings for NOAC customers; and,

WHEREAS, Archer Energy's offer results in an estimated savings of \$8 per year per participant through March, 2025, however, the Columbia Gas adder changes each April so savings beyond March, 2025 are unknown; and,

WHEREAS, Palmer Energy recommends accepting the Archer Energy offer as it is estimated to result in the best savings for the residential and small commercial consumers in the City of Sylvania.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, \_\_\_\_\_ members elected thereto concurring:

SECTION 1. That the Mayor and the Director of Finance be, and they hereby are, authorized to enter into a Customer Supply Agreement with Constellation to supply natural gas to City of Sylvania consumers enrolled in its opt-out aggregation program for a period of 20 months beginning with the October, 2024 and ending with the May 2026 billing periods.

SECTION 2. Any such contract with Archer Energy shall be in a form which is acceptable and approved by the Director of Law.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 4. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City.

SECTION 5. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that the Agreement for said natural gas services should be approved immediately so that City residents continue to receive the best possible natural gas pricing.
