### **ORDINANCE NO. 138-2025**

ACCEPTING FOR ANNEXATION TO THE CITY OF SYLVANIA, OHIO, THE TERRITORY DESCRIBED IN ANNEXATION PETITION NUMBER 2025-2 FOR WHICH LESLIE B. BRINNING IS THE AGENT, AND AS HEREINAFTER DESCRIBED; PROVIDING FOR THE INTERIM ZONING OF SAID TERRITORY; AND DECLARING AN EMERGENCY.

BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, \_\_\_\_\_\_ members elected thereto concurring:

<u>SECTION 1.</u> That the petition for annexation of the territory described as follows:

The north two hundred (200) feet of the west one-half (1/2) of the north thirty (30) acres of the south fifty (50) acres of the west one-half (1/2) of the southwest quarter (1/4) of Section number two (2), Town nine (9) south, Range six (6) east, in Sylvania Township, Lucas County, Ohio, excepting therefrom the North One Hundred (100) feet of the West Four Hundred Thirty-Five and ninety-eight hundredths (435.98) feet thereof and subject to legal highways.

having been filed with the Board of County Commissioners of Lucas County, Ohio, on July 1, 2025, presented to said Board of County Commissioners at a regular session thereof held on July 15, 2025, and acted upon favorably by said Board of County Commissioners on September 16, 2025 by passing a resolution to approve Annexation Petition 2025-2 together with the accompanying map of the territory and a certified transcript of the proceedings of said Board of County Commissioners, deposited with the Clerk of Council of the City of Sylvania, Ohio, by said Board of County Commissioners on the 16<sup>th</sup> day of October, 2025, be, and the same is hereby accepted.

SECTION 2. That the Council of the City of Sylvania, Ohio, hereby finds and determines that the property is currently zoned "Low Residential District" and, therefore, comparable zoning should be established for all of the hereinabove described territory, that is, R-1.

SECTION 3. That the Clerk of Council be, and she is hereby, authorized and directed to make three (3) copies of this Ordinance to each of which shall be attached a copy of the map accompanying the petition for annexation, a copy of the transcript of the proceedings of the Board of County Commissioners relating thereto and a certificate as to the corrections thereof. The Clerk of Council shall then forthwith deliver one (1) copy to the County Auditor, one (1) copy to the County Recorder, and one (1) copy to the Secretary of State and shall file Notice of this annexation with the Board of Elections within thirty (30) days after it becomes effective, and the Clerk shall do all other things required by law.

SECTION 4. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City.

SECTION 6. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that provision for the acceptance of said annexation and establishment of interim zoning thereof should be made promptly so as to promptly establish the jurisdiction having authority over future developments of said real estate and therefore this Ordinance should be effective forthwith. Provided this Ordinance receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force thirty (30) days after it is approved by the Mayor or as otherwise provided by the Charter.

The project contractor, Helms and Sons, will be returning in the spring to perform any final restoration and seeding activities before project close out.

With a majority of work items completed Helms and Sons has requested a project change order for several scope of work items that changed during construction. The full list of changes is enclosed, but below is a brief summary:

- Item 0014 Less pavement undercut was required than estimated (-\$13,000.00).
- Item 0015 Less granular backfill for undercut areas was required than estimated (-\$26,000.00).
- Item 0155 A construction field office was not needed (-\$7,000.00).
- Item 8000/8001 Water quality structure and conduit omitted from the plans (\$21,076.23).
- Item 8002 Additional electrical work under the Hospital Loop Road (\$19,175.00).

### MEMORANDUM OF UNDERSTANDING

It is declared to be in the public interest that TMACOG and City of Sylvania cooperate to undertake education of regional water quality. Per federal requirements set by US EPA and administered by Ohio EPA, the National Pollution Discharge Elimination System (NPDES) stormwater permit requires that regulated Municipal Separate Storm Sewer Systems (MS4) comply with Minimum Control Measures, including Public Education.

### WITNESSETH:

WHEREAS, TMACOG, an association of local governments, was organized on May 31, 1968, was established under Chapter 167 of the Ohio Revised Code and the Michigan Public Act No. 7 (Ex. Sess); and

WHEREAS, TMACOG staff provides capable and knowledgeable expert water quality and stormwater planning for the region; and

WHEREAS, TMACOG's Stormwater Coalition (SWC) was formed to provide a forum for local governments to address drainage, erosion, stormwater pollution, and stormwater management regulations on a cooperative, watershed basis; and

WHEREAS, City of Sylvania is a member unit in good standing of TMACOG; and

WHEREAS, City of Sylvania is a member unit in good standing of TMACOG's SWC; and

WHEREAS, City of Sylvania must comply with the NPDES stormwater permit requirements that regulate MS4; and

WHEREAS, Public Education is a Minimum Control Measure within said permit; and

WHEREAS, SWC members approved moving forward with a mass media campaign to assist with complying with the requirements of the Public Education Minimum Control Measure; and

WHEREAS, the mass media campaign will require TMACOG to enter into a contract with a selected media provider to perform scope of services (Exhibit A); and

WHEREAS, participating SWC members will provide financial support for the mass media campaign.

NOW, THEREFORE, in consideration of the above, we do hereby agree as follows:

### **SECTION 1: TMACOG Provides Service**

That it is in the public interest that TMACOG provide the services necessary to accomplish the goals of the mass media campaign; and

### SECTION 2: TMACOG Agrees to Employ Necessary Staff

That TMACOG is committed and shall employ such professionals and supporting staff, as shall be deemed necessary to perform the functions of the process and conduct the activities of the agency; and

SECTION 3: TMACOG Prepares and Maintains Lake Erie Starts Here Northwest Ohio Campaign Contract

That TMACOG acting for itself and as agent for the units of local government participating in the 2026 Lake Erie Starts Here Northwest Ohio Campaign, will engage with a selected media provider, negotiate and execute a contract for scope of services approved by SWC for calendar year 2026 (Exhibit A); and

### **SECTION 4: Periodic Reports**

That TMACOG shall periodically report to the units of local government participating in the campaign, the status of the mass media campaign; and

### SECTION 5: Responsibility of Unit of Local Government

That the unit of general purpose local government entering into this MOU agrees to cooperate and participate in the process as listed above including being a dues paying member of TMACOG as well as be current on Stormwater Coalition assessment payment; and

### **SECTION 6: Contribution of Funds**

TMACOG will invoice all participating units of government for their respective cost of the program. In the case that TMACOG does not collect the fully quoted cost of the contract, the cost per unit government may be readjusted.

City of Sylvania commits to pay \$871.81 towards the 2026 Lake Erie Starts Here Northwest Ohio Campaign. This payment will be assessed separately from TMACOG membership dues and SWC assessment (Exhibit B); and

SECTION 7: Any notice, statement or demand required, permitted or desired to be given under this MOU shall be in writing and shall be effective upon receipt, if given (a) in person or by courier or by courier service, (b) by telex, facsimile, email or other wire transmission, (c) in person or United States mail, return receipt requested, postage prepaid, or (d) by nationally recognized overnight delivery service, addressed as follows:

### SECTION 8: Miscellaneous

This MOU shall be binding upon and inure to the benefit of the parties and their respective successors and permitted assigns and intended third-party beneficiary.

- No change, modification or amendment or waiver of any obligation of this MOU will be enforceable unless set forth in writing and signed by both parties;
- If any provision of this MOU shall be held invalid, illegal or unenforceable, the validity, legality or enforceability of the other provisions hereof shall not be affected thereby;
- This MOU sets forth the entire MOU and understanding of the parties with respect to the matters set forth herein and supersedes any and all prior agreements, arrangements and understandings among the parties;
- This MOU may be executed in one or more original, facsimile or electronic counterparts, each of which shall be deemed the original, but all which together shall constitute one and the same instrument;
- This MOU shall be construed according to its fair meaning as if prepared by all parties;
- This MOU shall be governed, defined, construed and enforced in accordance with
  the internal laws of the state of Ohio and shall be deemed to have been entered
  into in the state of Ohio the jurisdiction and venue for any action between the
  parties regarding this MOU shall be in federal or state courts located in Toledo,

Dear Mr. Mayor and Council Members:

Ohio Excavating & Sewer Contractors Corp. has completed the storm sewer replacement work on the Fricker's Restaurant property, located at 6339 Monroe Street. As a reminder approximately 66 feet of 24" storm sewer and one catch basin with a City utility easement was replaced by open cut method.

Now that all work items have been completed, the Service Department is requesting a project change order to adjust the final contract price. This change order added parking lot asphalt trench replacement to the contractor's scope of work that was originally going to be performed by the City's Streets Department. However, due to the time of the year the work was performed our Streets Department was fully immersed in leaf collection operations and had completed all asphalt pavement repair work for their construction season.

The subcontracted work was performed by Bowers Asphalt Paving, Inc. at a cost of \$4,000.00 and Ohio Excavating is permitted a subcontractor markup of 5% yielding a total additional cost of \$4,200.00.

As a result, a final project change order in the amount of \$4,200.00 is necessary to increase the contract amount from \$42,900.00 to \$47,100.00. With this increase the total construction cost was approximately 9.8% over the original contract amount.

We recommend approval of Change Order No. 1 (Final) in the amount of \$4,200.00 with Ohio Excavating & Sewer Contractors Corp. Please call with any questions

Dear Mr. Mayor and Council Members:

In February 2025 the Parks & Forestry Department was involved in an Ohio Public Employment Risk Reduction Program inspection/investigation with the Ohio Bureau of Workers' Compensation (OBWC) related to our powered forklift operations. The Parks & Forestry forklift is used to remove holiday decorations and banners in our downtown area along with several other tasks within the Department.

This review noted the man-basket attachment did not have written manufacturer approval for use which could affect the safe operation of the forklift and place our employees at risk of falling, tipping, or crushing hazards. OBWC advised the City that we should decommission the man-basket without this written approval, which the Department did after months of failed communication attempts.

OBWC encouraged the City to review their Safety Intervention Grant program which allows employers to purchase equipment to significantly reduce or eliminate injuries associated with a particular task or operation. The Department has proposed the purchase of an articulating aerial boom lift (NiftyLift SP34) using this program in the amount of \$55,850 from Aerial Titans from Archbold, Ohio. The grant program would cover \$40,000 of the equipment cost with the remaining \$15,850 to be funded from the account 401-7310-53405.

We request the authorization to apply for the OBWC Safety Intervention Grant funding in the amount of \$40,000, and if successful, the authorization to purchase the referenced equipment from Aerial Titans in the amount of \$55,850. Please call with any questions.

### **ORDINANCE NO. 144-2025**

WHEREAS, Ohio Revised Code Section 5705.41(D)(1) further provides that in such circumstances when no certificate is furnished as required and the expenditure is for \$3,000 or more, the City's Council, may authorize the drawing of a warrant in payment of amounts due upon such contract or order upon certification by the Finance Director that there was at the time of the execution of such certificate a sufficient sum appropriated for the purpose of such contract in the treasury or in the process of collection to the credit of an appropriate fund free from any previous encumbrances; and,

WHEREAS, such certificate of the Finance Director is known as a "Then and Now Certificate" meaning that the funds were available when the contract was made and when the amount due under the contract was/is paid; and,

WHEREAS, the City is issuing Then and Now Certificates in connection with payments due and owing as shown on the "Exhibit A" attached; and,

WHEREAS, City Council deems it to be in the best interest of the health, safety, and

welfare of the City to approve the execution by the Finance Director of Then and Now Certificates and to authorize and ratify the payment of amounts due under the contracts or orders, requiring the expenditure of \$3,000 or more.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, members elected thereto concurring: SECTION 1.
