Centennial Crossings Plat Five

Dear Mr. Mayor and Council Members:

The construction plans and specifications prepared by the developer of Centennial Crossings Plat Five are complete and ready for construction. This plat calls for the installation of 18 lots and will extend Willow Circle to a cul-de-sac. This is the final plat in the Centennial Crossings Planned Development. The construction and administration of Plats One through Four were administered by the Lucas County Engineer's Office and Sylvania Township prior to this area being annexed.

The Service Department solicited a proposal from the Maakil Group out of Perrysburg, Ohio to provide the necessary construction engineering, testing, and inspection services on the project. The Maakil Group specializes in construction management services and will provide an inspector for the length of the project.

The Maakil Group submitted a proposal in the amount of \$24,075 to complete the scope of services. All costs associated with this work will be reimbursed to the City by the developer.

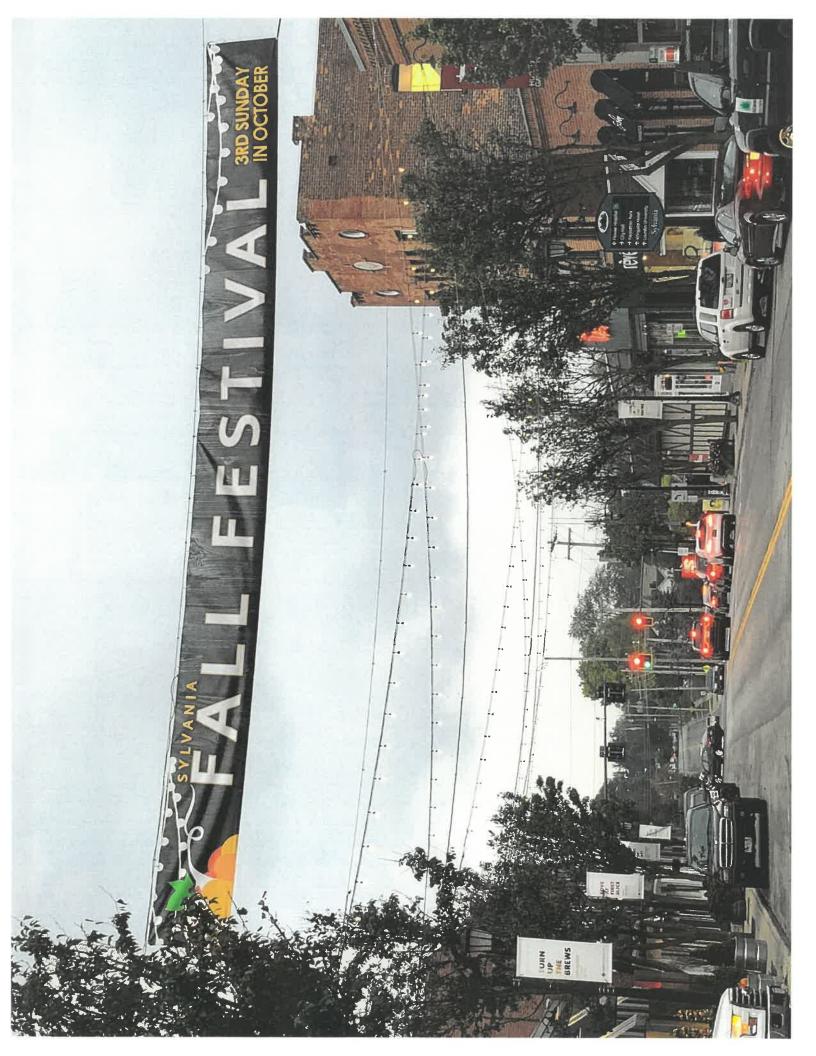

WHEREAS, Resolution No. 19-2000 provided that the applications were to be reviewed on an application-by-application basis and set forth the criterion on which the applications were to be considered; and,

WHEREAS, Ordinance No. 20-2018, passed May 21, 2018, amended Part Eleven – Planning and Zoning Code of the Codified Ordinances of Sylvania, 1979, as amended, by amending Section 1166.07 – Standards for Permitted Signs to permit banners to be installed in the downtown; and,

ORDINANCE NO. __78__ - 2019

AUTHORIZING THE MAYOR AND DIRECTOR OF FINANCE TO ENTER INTO AN ECONOMIC DEVELOPMENT GRANT AGREEMENT WITH VENTURE VISIONARY PARTNERS; AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance No. 54-95, passed May 15, 1995, adopted a Job Creation and Retention Program and adopted guidelines for administering the program; and,

WHEREAS, Ordinance No. 60-2013, passed August 19, 2013, revised the Job Creation and Retention Program guidelines; and,

WHEREAS, the Economic Development/Administrative Services Coordinator of this City negotiated with Craig Findley, Chief Executive Officer of Venture Visionary Partners and, after outlining to him the economic development proposal which would be available to Venture Visionary Partners ("VVP"), made a grant proposal to VVP, subject to the approval of the Mayor and the Sylvania City Council; and,

WHEREAS, VVP is a new company locating in the First Federal Building at 5520 Monroe St., Suite B in the City of Sylvania and the decision to locate to the City was based, in part, on receiving an economic development grant; and,

WHEREAS, the Mayor and Economic Development Director have recommended that the grant agreement between this City and VVP be formalized using the economic development letter grant agreement attached hereto as "Exhibit A."

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, _____ members elected thereto concurring:

DEPARTMENT OF LAW – DIRECTOR, DIVISION OF PROSECUTION; CONSULTANT EXPENSE REIMBURSEMENT.

The Department of Law shall have a Division of Prosecution comprised of two fulltime chief prosecutors, one Secretary II and one Secretary who will be employed on a part-time basis, who shall serve under the direction of the Prosecutors. The prosecutors in the Division of Prosecution shall be responsible for the prosecution of all City of Sylvania and State cases in Sylvania Municipal Court and the cases of all municipalities with whom the City of Sylvania has contracted to provide prosecutorial services in addition to other duties as assigned by the Director of Law, subject to the oversight of the Director of Law. The prosecutors shall be attorneys at law duly admitted to practice law in the State of Ohio. The prosecutors shall be appointed by the Mayor, subject to confirmation by a majority of the members of Council. The Director of Law may appoint, on a case by case basis, such Special Prosecutors as may be necessary when the prosecutors have a potential conflict of interest or there exists other legal grounds why the prosecutors should not prosecute a particular case. The Prosecutors shall be compensated in accordance with the provision made for them in the Position and Compensation Plan and/or in accordance with the compensation provided for them in an ordinance of Council and/or a separate agreement authorized by an ordinance of the Council. The Prosecutors shall submit reports to the Director of Law at such frequency, in such detail and covering such matters as the Director shall require.
