This project consists of milling and resurfacing the top 2" of asphalt in the Brookfield Estates Subdivision. The roadways scheduled to be resurfaced are Brookfield Lane, Fairmeadow Drive, Glenhill Drive, and Westcroft Drive. In addition, curb ramp improvements meeting current ADA standards will be implemented at deficient locations.

The estimated cost of the project is \$293,584 with construction scheduled this year.

We received four (4) bids on April 1, 2020 for the above referenced project.

The lowest bid was submitted by Overhead Roofing and Sheet Metal, Inc. of Toledo, Ohio. Their bid of \$98,192 was approximately 19.5% under the Engineer's Estimate of \$122,000.

Overhead Roofing has not performed work for the City on past projects, but several references were checked during the bid review process. All references checked yielded a positive response.

As a result, it is our recommendation that the contract be awarded to Overhead Roofing and Sheet Metal, Inc. of Toledo, Ohio in the amount of \$98,192.

ACCEPTING THE BID OF OVERHEAD ROOFING AND SHEET METAL, INC. AND AWARDING THE CONTRACT FOR THE ADMINISTRATION BUILDING AND SYLVANIA MUNICIPAL COURT ROOF REPLACEMENT PROJECT TO SAME; AUTHORIZING THE EXPENDITURE FOR THE IMPROVEMENTS IN THE AMOUNT OF \$98,192; APPROPRIATING FUNDS THEREFORE; AND DECLARING AN EMERGENCY.

WHEREAS, plans for the Administration Building and Sylvania Municipal Court Roof Replacement Project have been completed and are now on file with the Clerk of this Council; and,

WHEREAS, the Clerk of Council was authorized to advertise for bids at the March 2, 2020 Council meeting and thereafter the Clerk advertised for bids, and the bids were opened on April 1, 2020, and thereafter, the Director of Public Service, by report dated April 6, 2020, stated that the total engineer's estimate for the Administration Building and Sylvania Municipal Court Roof Replacement Project was \$122,000 and the following bids were received:

WHEREAS, the four (4) bids offered by the above bidders meet all of the City's specifications and the Director of Public Service, by report dated April 6, 2020, has recommended acceptance of the lowest and best bid of Overhead Roofing and Sheet Metal, Inc. and that the contract for the Administration Building and Sylvania Municipal Court Roof Replacement Project be awarded to same.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sylvania, Lucas County, Ohio, _____ members elected thereto concurring:

- SECTION 1. That the bid of Overhead Roofing and Sheet Metal, Inc., Toledo, Ohio for said Administration Building and Sylvania Municipal Court Roof Replacement Project, in the amount of Ninety-Eight Thousand One Hundred Ninety-Two Dollars (\$98,192.00), is hereby determined to be the lowest and best bid received and the same is hereby accepted.
- SECTION 2. That the Mayor and Director of Finance be, and hereby are, authorized and directed to execute a contract with the bidder named in Section 1 above for the furnishing of such labor and materials in accordance with said bid.
- SECTION 3. That to provide funds for said improvements hereby authorized, there is hereby appropriated from the **CAPITAL IMPROVEMENT FUND** from funds therein not heretofore appropriated to **Account No. 401-7750-53203**, **Building Improvements**, the total sum of Ninety-Eight Thousand One Hundred Ninety-Two Dollars (\$98,192.00).
- SECTION 4. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
- SECTION 5. That the Clerk of Council is hereby directed to post a copy of this Ordinance in the Office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12, of the Charter of this City.
- SECTION 6. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that the bid of Overhead Roofing and Sheet Metal, Inc. should be accepted immediately so as to provide for the commencement of the Administration Building and Sylvania Municipal Court Roof Replacement Project at the earliest possible time. Re: ODOT-LUC-475/23-9.54-9.63 Noisewall (PID 103647)

Dear Mr. Mayor and Council Members:

The Ohio Department of Transportation (ODOT) plans to move forward with installing Type II noisewalls along I-475 and US-23. The construction plans are nearly complete and ready for bidding.

Type II noisewalls are scheduled to be installed along I-475 from the systems interchange with US-23 to the railroad overpass near Holland-Sylvania Road. The entire stretch of US-23 between I-475 and the Michigan state line will receive noisewalls as well.

Because a portion of the project is within the City municipal limits ODOT requires legislation that provides consent for the work, even though all of the proposed work lies with their Limited Access right-of-way. A copy of the legislation is enclosed for your reference.

ODOT anticipates selling and awarding a contract for the first phase of the noisewalls in September 2020. The first phase of construction would consist of all walls south of Monroe Street on US-23 and all of I-475 and would occur October 2020 through April 2021. ODOT will sell and award the second phase of noisewalls in 2021. The second phase of construction would complete all work north of Monroe Street to the state line.

This project is 100% funded by ODOT with no local financial contribution requirement. We would recommend approval of the consent legislation for this project.

The following is an <u>ordinance</u> enacted by the <u>City</u> of <u>Sylvania</u>, <u>Lucas</u> County, Ohio, hereinafter referred to as the Local Public Agency (LPA), in the matter of the stated described project.

SECTION I - Project Description

WHEREAS, the LPA/STATE has identified the need for the described project:

Construct type II noise barriers on a stretch of I-475 and US-23 in Lucas County

NOW THEREFORE, be it ordained by the City of Sylvania, Ohio

SECTION II - Consent Statement

Being in the public interest, the LPA gives consent to the Director of Transportation to complete the above described project.

SECTION III - Cooperation Statement

The LPA shall cooperate with the Director of Transportation in the above described project as follows:

- 1) The LPA will assume and bear one hundred percent (100%) of the total cost of any features requested by the LPA which are not necessary for the project as determined by the State and/or the Federal Highway Administration.
- 2) The LPA consents to having the State acquire all necessary rights of way for the subject project in the name of the LPA.
- 3) The LPA agrees, upon completion of the project, to own and maintain all those portions of the project under its jurisdiction.
- 4) The State agrees to be the lead agency and to administer all phases of the project.

SECTION IV - Utilities and Right-of-Way Statement

The LPA agrees that all existing street and public way right-of-way within the jurisdiction of the LPA which is necessary for the described project shall be made available therefor. The LPA further agrees that any right-of-way acquired by said LPA on behalf of the described project shall be acquired and/or made available in accordance with current State and Federal regulations.

The LPA agrees that all utility accommodation, relocation and reimbursement will comply with the current provisions of 23 CFR 645 and the ODOT Utilities Manual.

SECTION V - Maintenance

CECTION THE ADDRESS OF ALL CO.

Upon completion of the Project, and unless otherwise agreed, the LPA shall: 1) provide adequate maintenance for those portions of the Project under the jurisdiction of the LPA in accordance with all applicable state and federal law, including, but not limited to, Title 23, U.S.C., Section 116; 2) provide ample financial provisions, as necessary, for the maintenance of those portions of the Project under its jurisdiction; 3) maintain the right-of-way, keeping it free of obstructions; and 4) hold said right-of-way inviolate for public highway purposes.

RESOLUTION NO. <u>12</u> -2020

A RESOLUTION OF THE COUNCIL OF THE CITY OF SYLVANIA CONSENTING TO THE OHIO DEPARTMENT OF TRANSPORTATION'S CONSTRUCTION OF TYPE II NOISE BARRIERS ON A STRETCH OF I-475 AND US-23; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Sylvania and State of Ohio have identified the need for the construction of Type II noise barriers on a stretch of I-475 and US-23; and,

WHEREAS, because a portion of the project is within the City municipal limits, the Ohio Department of Transportation requires legislation consenting to the work; and,

WHEREAS, the Director of Public Service, by report dated April 6, 2020, has recommended that the City consent to the construction of the Type II noise barriers on a stretch of I-475 and US-23.

NOW, THEREFORE BE IT RESOLVED by the Council of the City of Sylvania, Lucas County, Ohio, members elected thereto concurring:

SECTION 1. Being in the public interest, the City of Sylvania gives consent to the Director of Transportation to complete the construction of Type II noise barriers on a stretch of I-475 and US-23.

<u>SECTION 2.</u> The City of Sylvania shall cooperate with the Director of Transportation in the above-described project as follows:

A. The State shall assume and bear 100% of all of the cost of any features requested by the City which are not necessary for the project as determined by the state/or the Federal Highway Administration.

B. The City of Sylvania consents to having the State acquire all necessary rights of

way for the subject project in the name of the City of Sylvania.

C. The City of Sylvania agrees, upon completion of the project, to own and maintain all those portions of the project under its jurisdiction.

D. The State agrees to be the lead agency and to administer all phases of the project.

SECTION 3. The City of Sylvania agrees that all existing street and public right-of-way within the jurisdiction of the City of Sylvania which is necessary for the described project shall be made available therefore. The City of Sylvania further agrees that any right-of-way acquired by said City of Sylvania on behalf of the described project shall be acquired and/or made available in accordance with current State and Federal regulations.

The City of Sylvania agrees that all utility accommodation, relocation and reimbursement will comply with the current provisions of 23 CFR 645 and the ODOT Utilities Manual.

SECTION 4. Upon completion of the Project, and unless otherwise agreed, the City of

Sylvania shall:

- A. Provide adequate maintenance for those portions of the Project under the jurisdiction of the City of Sylvania in accordance with all applicable state and federal law, including, but not limited to, Title 23, U.S.C. Section 116.

 B. Provide ample financial provisions, as necessary, for the maintenance of those
- portions of the Project under its jurisdiction.
- C. Maintain the right-of-way, keeping it free of obstructions.
- D. Hold said right-of-way inviolate for public highway purposes.
- SECTION 5. It is hereby found and determined that for all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- SECTION 6. That the Clerk of Council is hereby directed to post a copy of this Resolution in the office of the Clerk of Council in the Municipal Building pursuant to ARTICLE III, Section 12 of the Charter of this City.
- SECTION 7. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that the City should consent to the construction of the noise barriers at the earliest possible time so that the project can proceed without delay and therefore this Resolution should be made effective immediately. Provided this Resolution receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force thirty (30) days after it is approved by the Mayor or as otherwise provided by the Charter.
